Five-Point Road Map of the State Administration Council

1. The Union Election Commission will be reconstituted and its mandated tasks, including the scrutiny of voter lists, shall be implemented in accordance with the law.
2. Effective measures will be taken with added momentum to prevent and manage the COVID-19 pandemic.
3. Actions will be taken to ensure the speedy recovery of businesses from the impact of COVID-19.
4. Emphasis will be placed on achieving enduring peace for the entire nation in line with the agreements set out in the Nationwide Ceasefire Agreement.
5. Upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held in line with the 2008 Constitution, and further work will be undertaken to hand over State duties to the winning party in accordance with democratic standards.

and foreign travellers may take relaxation and exploration on Satan Island, Nyaung Oo Phee Island, Macleod Island, Nga Khin Nyo Gye Island, Kyun Phi Lar Island, 115 Island, Bo Cho Island, Cock Comb Island, Lampi Island or Kyun Tan Shey and Wa Ale Island.

diving, snorkelling and adventure types for paying visits to those islands in Kawthoung District so as to enjoy the beautiful nature of coral reefs, sea fans, sea snakes, sea eels, fishes, hogs, jaws, lobsters, herbal plants, rare underwater animals, evergreen forests and other natural resources. — GNLM

Interim order given to one special civil appeal case; judgements passed on 9 special civil appeals; 5 special civil appeals heard

THE special appeal court comprising Chief Justice of the Union U Htun Htun Oo and Judges U Kyi Thein, U Khin Maung Gyi, U Tin Hone and U Thein

Ko Ko passed an interim order on one special civil appeal case and also passed judgements on nine special civil appeal cases yesterday.

Moreover, they heard five special civil appeal cases in line with COVID-19 health rules. — MNA

3 new cases of COVID-19 reported on 9 May, total figure rises to 613,056

MYANMAR'S COVID-19 positive cases rose to **613,056** after **3** new cases were reported on 9 May 2022 according to the Ministry of Health. Among these confirmed cases, **591,981** have been discharged from hospitals. Death toll stands at **19,434** without casualties. —MNA

Public Notice

- Since it is important to get the full revenue from exports, the main source of foreign exchange into the country, Section 38-b of the Foreign Exchange Management Law and Paragraph 35 of the Foreign Exchange Management Rules stipulate that the exporter is required to have foreign currency into his/her bank account within six months from the date of shipment (within three months from 10-11-2021).
- Therefore, in order to ensure that export earnings of the exporters who exported during 2016, 2017 and 2018, are credited back to their bank accounts in foreign currency within six months from the date of shipping, the Central Committee on Ensuring the Smooth Flow Trade and Goods, the Ministry of Investment and Foreign Economic Relations, the Ministry of Legal Affairs, the Ministry of Commerce, the Central Bank of Myanmar; the Republic of the Union of Myanmar Federation of Chambers of Commerce and Industry (UMFCCI), and the Foreign Exchange authorized dealer (AD) licenced banks, have already done the following:
 - Clarification by AD Banks (within three years)
 - Clarification by the UMFCCI (60 days)
 - Announcing to clarify in the newspapers and the website of the Central Bank of Myanmar (60 days)
 - The Ministry of Commerce closes the registration certificate of importers and exporters (Pa-Tha-Ka) for those who do not clarify (30 days)
- Exporters are required to comply with Section 38-b of the Foreign Exchange Management Law, which states, "No one shall fail to deposit all export earnings into their bank account in the country in foreign currency within the stipulated period," and "Violation of this prohibition is punishable by imprisonment for a term not exceeding one year or a fine or both punishments must be imposed under Section 42-a of the law."
- The 158 companies (attached list) are being prosecuted under Section 42-a of the Foreign Exchange Management Law, and the boards of directors of the companies and the listed companies have been blacklisted, and the remaining companies are still under investigation for additional export earnings.

UNION Minister for Information U Maung Maung Ohn met the Myanmar Press Council and National Literary Award and Sarpay Beikman Manuscript Award Selection Committees' members yesterday.

During the meeting with the Myanmar Press Council, the Union minister said those who do not want peace and stability in the country are conducting various activities at present, especially, since the civilian people are accused of being informers and killed them without any reason. Due to the untrue incitements of some people, the youths who are not familiar with democracy at all are heading the wrong way and that affects their future.

The ministry also adopts proper media related measures to ensure the knowledge and thoughts of the people in their daily life. But unscrupulous persons are obstructing

Efforts should be made in various ways to spread true information and fight false news among the people, says MoI Union Minister

UNION Minister for Information Maung Maung Ohn said it was very upset to see the hate speech and writings that provoke

the conflict on social media. No matter how much the Ministry of Information's media activities are obstructed, he would make

every effort to ensure that the public receives accurate information and to fight false information, he said.

He remarked during the meeting with publishers at the Department of Printing and Publishing in Botahtaung Township, Yangon, on 8 May.

He also urged them to work together to do the right thing for the future of the country and the future of Myanmar society. He also added the prosecution of the publishers of the pornographic book under the law, saying that such a lawsuit is not a violation of the right to freedom of expression, but a legal action due to the violation of the provisions of the Printing and Publishing Law. He said, "I would like to say that

such action is systematic censorship of unethical writings that are unacceptable in our Myanmar society." The Union minister added that today, the media activities aimed at disseminating accurate news and combatting false information in the country are being obstructed by unscrupulous persons in various ways.

He also stressed the need to take the writings seriously as today's publications will remain as records in the future, calling on the printing/publishing business to act as per the relevant rules, regulations, and code of conduct. — Htun Htun/GNLM

Myanmar to participate in "World's Best Tourism Village Programme-2022"

MYANMAR will try to apply for the Best Tourism Village Programme as per the terms and conditions.

Union Minister for Hotels and Tourism Dr Htay Aung made the remarks yesterday afternoon at the Briefing Session of the Best Tourism Villages by UNWTO Online Meeting related to the application of the second time Best Tourism Village Programme-2022 under the leadership of the World Tourism Organizations.

anmar's tourism industry, and asked to continue to provide technical assistance as needed.

Severe Cyclonic Storm "Asani"

ACCORDING to the observations at (17:30)hrs MST 9 May, the Severe Cyclonic Storm "Asani" over West Central Bay and adjoining

South Bay of Bangal has moved Northwestwards and now lies over West Central Bay of Bengal. It is centered at about (475)

Nautical miles West-Northwest of Port Blair; (215) Nautical miles South-Southeast of Vishakhapatnam, (315) Nautical miles South of Puri (India), (475) Nautical miles West of Coco-Island and (540) Nautical miles West-Southwest of Hainggyigyun (Myanmar).

It is not moving towards Myanmar coasts, the present stage of the Severe Cyclonic Storm "Asani" is coded yellow stage.

Position of Severe Cyclonic Storm "Asani", centre pressure and wind

The Severe Cyclonic Storm "Asani" is located at Latitude (14.5) degree North and Longitude (85.4) degree East, centre pressure of Severe Cyclonic Storm "Asani" is (988) hPa and maximum wind speed near the centre is (65-70) miles per hour

at (17:30)hrs MST 9 May.

During next (72) hrs forecast

The Severe Cyclonic Storm "Asani" is forecast continuous to move Northwestwards and reach to West Central Bay and adjoining Northwest Bay of Bengal (off north Andhra Pradesh-Odisha coasts, India) around (10-5-2022) and recurve to North-Northeastwards and reach to Northwest Bay of Bengal (off Odisha coast, India). It is likely to weaken gradually into a Cyclonic Storm "Asani" during next (24) hrs and into a Deep Depression around (11-5-2022).


General caution

Due to the Severe Cyclonic Storm "Asani", rain or thundershowers will be fairly widespread to widespread in Nay Pyi Taw, Sagaing, Mandalay, Magway,

Bago, Yangon, Ayeyawady and Taninthayi Regions and Kachin, Shan, Chin, Rakhine, Kayah, Kayin and Mon States with likelihood of regionally and isolated heavy-falls in some Regions and States from tonight to (13.5.2022). Occasional squalls with rough seas will be experienced off and along Myanmar Coasts. Surface wind speed in squalls may reach (40) mph Wave height will be about (8-12) feet off and along Myanmar Coasts.

Domestic tourism back in operation almost as usual

AMID the COVID-19 control activities, domestic travel services are back in operation almost as usual in Myanmar, particularly during the Thingyan holidays in April. It is learnt that the num-

ber of tourists who are travelling with their own itinerary is increasing.

“At present, there are only office staff who have to travel for work,” said Ma Ni Ni Maw,

a ticket seller of a Yangon-Mandalay express. She added that returnees before the Thingyan period and pilgrims are more likely to travel on their own as a group than by a group service

vehicle. Due to fewer travellers before the Thingyan period, passenger buses had to rely on goods every day.

Due to COVID-19 preventive measures, only about 12 passengers are allowed in a Yangon-Mandalay VIP bus, which cannot even cover the fuel expense, Ko Win Tun, a Yangon-Mandalay passenger bus driver, told GNLM.

As passenger buses have to rely on the goods, it costs a lot to freight forwarders, according to an online clothes seller, Ko Arkar Oo. He also added that a mini-

mum of K3,000 need to be paid for the shipping fees, depending on the weight of the goods, there are various prices.

During the Thingyan period, ticket fees were about K35,000, and they reduced to K25,000 after the period. In April, Rakhine State, Chaungtha Beach, Ngapali Beach, Bagan, Taunggyi, and Inlay were the most crowded areas, with 16,000 local/international tourists in Rakhine State and 15,000 tourists per day in Bagan, according to the Ministry of Hotels and Tourism. — TWA/GNLM

Youths keen on going overseas for work

MOST young people want to go overseas for work as the jobs available in the country decline.

The youths are interested in labour exports under MoU to the neighbouring countries. On the other hand, they are waiting for the time to work in Japan and Korea.

When the government offices are reopened with COVID-19 rules, the rates of application for passports become high. The officials conduct an online booking

system for passport application processes to prevent the disease infection rate now.

“We are waiting for the chance to work in Thailand via road under the plan of the Ministry of Labour. They will send 200 workers tomorrow for the first time. I am not included in that group this time,” Ko Kaung Myat Win from Hline Township told The Global New Light of Myanmar.

The Mae Sot based media

expressed that the Thai government provides vehicles to welcome the Myanmar migrant workers under the MoU system.

“Now, I am studying the Japanese language and waiting for the time that Japan will call workers officially,” said Ko Ko Soe Lwin from Mayangon Township.

As the COVID-19 infection rate was high, most of the job opportunities and businesses were suspended starting last July, and now almost all the businesses resume their operations.

The youths join computer and mobile phone repair services, language, cooking and hospitality training.

“I paid the fees for the hotel cooking class since September 2020. The class was not open for various reasons. I did not lose my training fee but it wasted the time and occurred delays in teaching,” the Global New Light of Myanmar quoted Ko Khin Maung Lin from Myingyan Township as saying. —TWA/GNLM

Green gram, pigeon pea prices drop within one week

IN the local bean market, the prices of beans including the green gram and pigeon pea drop within one week, according to data from the Bayintnaung Wholesale Market on 9 May.

On 6 May, it was K47,140 per basket of green gram and K44,212 per basket of pigeon pea, while the price of green gram was K46,785 per basket and the pigeon pea K44,130 per basket on 9 May.

“The price of green gram dropped to K355 per basket, while the pigeon pea by K82 per basket during one week. The price of chickpeas is high. The bean season is over. They were left only in the hand of merchants. The bean prices will keep declining,” said Ko Oo, a bean merchant.

The bean prices have fallen since the exchange

rate was fixed at K1,850 per dollar.

According to the Bayintnaung Wholesale Centre, the price of mung bean was between K2,080 and K2,670 per viss, between K3,215 and K4,250 per viss of lablab bean and between K1,750 and K1,870 per viss of black-eyed peas.

The beans are mostly grown in Ayeyawady, Bago, Magway and Mandalay regions. More than 142,000 tonnes of pulses were exported in April amounting to \$830.625 million from 1 October 2021 to 31 March 2022, according to the ministry. — TWA/GNLM

Illegal timbers and unregistered vehicles seized

SUPERVISED by the Anti-Illegal Trade Steering Committee, action is being taken under the law against illegal trades across the country.

An inspection team led by Traffic Police Force under the Ayeyawady Region Anti-Illegal Trade Task Force conducted

the inspections at the Koezu Checkpoint in Patheingyi Township. A Toyota Ractis vehicle estimated at K2,500,000 without a vehicle registration certificate was seized on 6 May. Police opened a file on this case under the Export/Import Law.

Similarly, a combined in-

spection team led by the Region Forest Department under the supervision of the Bago Region Anti-Illegal Trade Task Force

seized K102,300 worth of 0.6820 tonne of illegal teak in the Saiya reserved forest in Yedashe Township of Toungoo District

and charged them under the Forest Law.

In addition, Police Force seized two unregistered Dump trucks estimated at K8,000,000 and action was taken under the Export/Import Law.

The Forest Department inspection team confiscated K10,861,850 worth of 12.3904 tonnes of illegal timbers and action was taken under the Forest Law.

Therefore, on 6 and 9 May, six arrests were made (an estimated value of K21,464,150), according to the Anti-Illegal Trade Steering Committee. — MNA

Traffickers sentenced to jail for human trafficking

YANGON'S South District Court sentenced a man to six years imprisonment with labour for his role in trafficking a man to a fishing bamboo raft (Kyaphaung) work site on 5 May.

The victim U..., aged 30, from Dala Township of Yangon Region, was sent to a fishing bamboo raft work site by Balaji (aka) Aung Bala from Pyapon Township of Ayeyawady Region. Balaji exploited the salary of the victim-K600,000 that he told the victim to earn K80,000 a month.

The trafficker was prosecuted at Dala Myoma police station under Section 25 of the Anti-Trafficking in Persons Law.

Similarly, Yangon's North

District Court sentenced two traffickers to 10 years imprisonment with labour under Sections 24/32 of the Anti-Trafficking in Persons Law on 6 May.

The victim Ma ..., aged 18, from Hlinethaya Township of Yangon Region was sold to a Chinese man by Ma Paing Paing Soe (aka) Ma Soe Soe and Taw Thargyi (aka) Tin Ko Oo from Shwepyitha Township of Yangon Region. The two traffickers exploited K6,000,000 that they told the victim to earn K1,500,000 a month.

The two traffickers were prosecuted at Shwepyithar police station under Sections 24/32 of the Anti-Trafficking in Persons Law. — MNA

Ketamine worth over K500 million seized in Kunhing Township

OVER K500 million worth of ketamine were seized in Kunhing Township, according to the Myanmar Police Force.

A combined team consisting of members of the Anti-Drug Police Force conducted

an inspection in Kunhing Township at 9 pm on 7 May. A search of the Mitsubishi Colt vehicle driven by Sai Naw Shen from Kali to Mongpyin at the Takaw Joint Inspection Station turned up 61 kilogrammes of ketamine

worth over K500 million.

According to the investigation, the ketamine was transported from Kali to Mongpyin, so he was prosecuted and the perpetrators are still under investigation. — MNA

Sugar mills in Katha District produce over 63,000 tonnes of sugar

PRODUCTION of sugar mills in Katha District, Sagaing Region is estimated at over 63,000 tonnes, according to a statement released by Sagaing Region Consumer Affairs Department.

The close season of sugarcane is at the end of May 2022. Over 580,000 tonnes of sugarcane by Great Wall Wilmar Co., Ltd, 25,000 tonnes by Mya Taungtha mill, and 30,000 tonnes by UTP sugar mill were processed, totalling over 630,000 tonnes of sugarcane.

One tonne of sugar is produced if ten tonnes of sugarcane are milled. Therefore, a total of over 63,000 tonnes of sugar were produced by those three mills.

There were over 120,000 acres of sugarcane in 2021 in Katha District, with the yield rate estimated at 2.4 million tonnes of

sugarcane.

Three mills in Katha and Htigyaing townships crushed over 600,000 tonnes of sugarcane. The remaining was delivered to the mills in Mandalay Region and the syrup manufacturing plants.

The milling period for that sugarcane produced in the 2021 season is from January to May 2022.

The millers faced banking restrictions to pay the growers. Nevertheless, they reached an agreement with the growers to practice a barter trade system. The refined sugar is given in return for sugarcane price and worker wages. The sugar is conveyed to the Mandalay depot. The sugar fetches K1,950 per viss (a viss equals 1.6 kilogrammes).

Minbu market sees onion bustling trade



The retail prices stand at K700-800 per viss at present and the wholesale price is at K500-600 per viss.

THE prices of onions are slightly rising and the Minbu market sees brisk sales, onion brokers said.

“Onion growers earlier struggled to survive with the collapse of the onion market, with the prices of K150-200 per viss (a viss equals 1.6 kilogrammes). The retail prices stand at K700-800 per viss at

present and the wholesale price is at K500-600 per viss,” said U Tun, an onion buyer.

The stocks have declined in the market. When onions were priced around K1,700-1,800 per viss in the previous year, the demand significantly dropped, traders said.

The prices regain in April and May. The onions are highly

demanded at K500-600 per viss, U Thar Paw, an onion trader.

The inflows of onions are seen regularly in Minbu depot, with an estimated volume of 60,000 visses per day, a depot owner Daw Lei Lei said.

The onion growers, as well as traders, experienced market fallouts during the COVID-19 pandemic since the foreign demand dried up.

Next, Bangladesh’s demand for Myanmar’s onions coupled with high demand in the local market hiked up prices, soaring up to K4,000 per viss on 15 November 2019, according to the Mandalay commodity depot.

The prices of domestic onions exceeded K3,000 per viss in 2015, 2018, and 2019.

The onions are primarily grown in Mandalay, Magway and Yangon regions, Nay Pyi Taw and Shan State. — Zeyar Htet, KK/GNLM

4 enterprises pump \$5.99 mln of FDI into manufacturing sector in April

ONLY the manufacturing sector attracted foreign direct investment in April 2022 of the 2022-2023 financial year, as per the statistics released by the Directorate of Investment and Company Administration (DICA).

Four enterprises from China and Hong Kong SAR put an estimated capital of US\$5.99 million into the manufacturing sector last month.

Manufacturing enterprises and businesses that need a large labour force are prioritized to create job opportunities for the local community, according to the Myanmar Investment Commission.

Although some labour-intensive enterprises faced financial hardship amid the COVID-19 negative impacts and the political changes, the industry is now returning to normal after the COVID-19 vaccination programme for workers, as per the HIS Markit’s September report.

Myanmar’s manufacturing

sector is largely concentrated in garments and textiles produced on the Cutting, Making, and Packing basis, and it contributes to the country’s GDP to a certain extent.

Myanmar has drawn foreign direct investment of more than \$647.127 million from 49 enterprises during the October-March period. Of them, 40 foreign enterprises put investments in the manufacturing sector, pumping the estimated capital of \$202.667 million in the past mini-budget period (October 2021-March 2022). Additionally, the agriculture sector drew one project worth of \$5 million. The livestock and fishery sector attracted two enterprises with investments of more than \$19 million. Power, construction and hotels and tourism sectors have one new project each in the past mini-budget period and three other enterprises invested in other service sectors. — KK/GNLM

Jordan's tourism witnesses signs of recovery

JORDAN'S pandemic-hit tourism industry has shown signs of recovery for the first quarter of 2022 and the Eid al-Fitr holiday, following massive campaigns to promote the kingdom's tourism profile and the eased COVID-19 restrictions.

"All figures indicate that the tourism sector is undergoing a recovery ... The holiday season during Eid al-Fitr saw a large increase of visitors to various sites across the country, while occupancy rates in hotels of Aqaba and the Dead Sea area exceeded 90 per cent," Abeer Nauman, economic news editor at the Jordan Press Foundation, told Xinhua.

Archaeological and tourist sites in Jordan have received about 190,000 visitors home and abroad for the four-day Eid holiday that marks the end of the fasting month of Ramadan, state-run Petra news agency reported.

Jordan's tourism revenues rose by 251 per cent during the first quarter of 2022, reaching 893 million US dollars, the Tourism Ministry's spokesman Ahmad Rifai told Xinhua.

Meanwhile, some 780,000 people visited the kingdom in the first quarter, up by

298 per cent year-on-year, the state-owned Al-Mamlaka TV reported, citing Tourism Minister Nayef Fayez.

"We are on the right track toward the recovery of tourism, and we have exceeded our targets for the first quarter already," the minister was quoted as saying.

According to Rifai, the ministry's massive promotional campaigns and the adjustment of pandemic-related restrictions in the kingdom have contributed to the recovery.

Noting tourism's 14-per-cent contribution to Jordan's GDP, Nauman called for more promotional efforts to revitalize tourism and stimulate hotels, restaurants, and transport consumptions.

According to figures by the Economic and Social Council of Jordan, the number of workers in the tourism industry in 2020 reached 21,000, of whom 73 per cent were Jordanians. Abdel Hakim Al-Hindi, head of Jordan Hotel Association, said the hotel occupancy may continue to increase in the near future, because of eased coronavirus restrictions and mild climate of the kingdom.

COP15 talks open facing 'emergency' over Earth's degraded land

NINE African heads of states attended Monday's opening session of the UN's COP15 talks to fight desertification and land degradation that have devastated large

swathes of the continent amid climate change.

The United Nations Convention to Combat Desertification (UNCCD), 196 countries plus the

European Union — is meeting for the first time in three years, in Abidjan.

Decades of unsustainable agriculture have depleted soils

worldwide and accelerated both global warming and species loss, the UNCCD says, with an estimated 40 per cent of land degraded globally.

"Our summit is taking place in the context of the climate emergency which harshly impacts our land management policies and exacerbates drought," Ivory Coast President Alassane Ouattara announced. "Our people put great hope in us. We don't have the right to disappoint them.

"Let us act swiftly, let us act together to give new life to our lands," he urged.

Nigeria's Muhammadu Buhari, Niger's Mohamed Bazoum and DR Congo's Felix Tshisekedi were among the continent's leaders listening to the Ivorian host.

French President Emmanuel Macron was to address the gathering by videoconference later in the day. Ouattara presented the Abidjan Initiative to raise \$1.5 billion over five years to restore Ivory Coast's "degraded forest

eco-systems" and promote sustainable soil management.

Ivory Coast is among numerous African nations badly affected by desertification. Forest cover has fallen by 80 per cent since 1900 — from 16 million hectares to just 2.9 million last year.

"At the current rate, our forest could totally disappear by 2050," Ouattara warned.

COP15 runs until 20 May and is due to hear new proposals to try to halt the spread of desertification and deteriorating land quality. The conference will pay particular attention to the restoration of one billion hectares of degraded land by 2030, future-proofing land use and drought resilience, the UNCCD said.

Debate is expected to include the question of the "Great Green Wall" scheme to restore 100 million hectares of arid land from Senegal in the west of Africa to Djibouti in the east by 2030. —AFP

Southern Mongolian province to plant 70 mln trees by 2030 to combat desertification

THE southern Mongolian province of Umnugovi aims to plant at least 70 million trees by 2030 to combat desertification.

"Our province is planning to plant at least 70 million trees by 2030 within the framework of the 'Billion Trees' national tree-planting campaign initiated by Mongolian President Ukhnaa Khurelsukh," said Nasanbuyan

Enkhbat, deputy governor of the province, on Monday.

The provincial governor's office is urging every household to plant at least nine trees and every organization at least 90.

Last year, Mongolia launched a nationwide tree-planting campaign as President Khurelsukh told the United Nations General Assembly that the campaign

could combat climate change and desertification. Almost 77 per cent of Mongolian territory has been struck by desertification, according to the country's Ministry of Environment and Tourism.

Umnugovi, located in the Gobi Desert region of southern Mongolia, is one of the provinces most affected by desertification. — Xinhua

Aussie conservation group hires drones to monitor species

A team of conservationists from Australian conservation group, the Australian Wildlife Conservancy (AWC), have begun using remote control drones to track populations of native Australian wildlife.

Details of the new wildlife monitoring programme, revealed to the public on Monday, showed how drones could add a new dimension to the way conservationists monitor endangered species in Australia.

Mahalia Booth-Remmers, AWC field ecologist, told Xinhua on Monday that their tests give proof of concept to a process that could be used for conservation across Australia.

"Using a thermal drone, you've got more likelihood of actually detecting the animal and getting a more accurate population estimate," said Booth-Remmers.

"Coming up with new and innovative ways of actually surveying for our wildlife, I think is really critical."

The team's initial test saw a human-operated drone fitted with a thermal camera fly over

a 480-hectare breeding area in Molly Cliffs National Park in southwest New South Wales (NSW) five separate times.

The footage was sent back to researchers who were able to determine the population of bilbies, a native Australian marsupial, with similar accuracy to traditional population monitoring methods like live-trapping which for the same area took a team of researchers five nights out in the field.

Booth-Remmers said at this stage the largest limiting factor on drone capabilities was their battery life.

"At the moment, it's limited by the battery life, which is only 20 minutes. So, you can only cover a small area, that 480 hectares was a good size, any bigger than that... and it became really difficult."

Booth-Remmers said going forward the team would be looking to scale up operations and use the method on different species. Most recently the team took their fleet of drones to Scotia, a larger reserve in NSW's north. — Xinhua

Chinese mainland registers tallest tree in Tibet

CHINESE researchers have found a 76.8-metre tree in Medog County in southwest China's Tibet Autonomous Region, the tallest ever registered in the Chinese mainland, local authorities said Monday.

The tree, belonging to *Pinus bhutanica*, or Bhutan white pine, was measured by a research team led by Peking University in April. The final measurement beats the previous height record of 72 metres.

The team used laser radar, which can obtain a 3D point cloud model of the tree directly, rapidly and accurately, said Guo Qinghua, a professor at Peking University, adding that it is the most advanced method for measuring the height of trees.

The research team has found a total of eight trees measuring over 70 metres tall in the survey in Gelin Village in Medog. The height ranges from 70.2 metres to 76.8 metres.

Gesang Bachug, head of the forestry and grassland administration in Medog, said it is hoped that the collected data and analysis by researchers will shed light on the conditions and mechanisms of the tall trees' growth to offer a scientific basis for local conservation efforts. — Xinhua

Downtown Beijing goes quiet as zero-Covid policy smothers capital

MILLIONS of people in Beijing stayed home on Monday as China's capital tries to fend off a Covid-19 outbreak with creeping restrictions on movement. Beijing residents fear they may soon find themselves in the grip of the same draconian measures that have trapped most of Shanghai's 25 million people at home for several weeks.

Officials there have said the eastern powerhouse city is winning its battle against China's worst outbreak since the pandemic began.

Yet the Shanghai lockdown has intensified, causing outrage and rare protest in the last major

economy still glued to a zero-Covid policy. In Beijing, subway stations and offices were empty during rush hour Monday morning across Chaoyang — the city's most populous district — after officials stepped up a work-from-home order on Sunday over rising Covid cases.

Non-essential businesses in the district, home to 3.5 million people, were shuttered, with even the Apple store in the popular Sanlitun shopping area ordered to close after opening briefly in the morning. "I feel very uncomfortable seeing so few people around," Wang, a middle-aged cleaner waiting outside a restaur-

has ordered multi-day curfews for residents of multiple neighbourhoods, according to notices seen by AFP, even as daily case numbers have dwindled into the low thousands. — AFP

India reports 3,207 new COVID-19 cases

INDIA'S COVID-19 tally rose to 43,105,401 on Monday with 3,207 new cases registered during the past 24 hours across the country, showed the federal health ministry's latest data.

Of the new cases, 1,422 were reported from Delhi. Presently there are 5,939 active cases in the national capital, and the positivity rate stands at 4.98 per cent.

Besides, as many as 29 deaths were reported across the country due to the pandemic since Sunday morning, taking the total death toll to 524,093.

There are still 20,403 active COVID-19 cases in the country, a rise of 232 during the past 24 hours.

So far 42,560,905 people have been successfully cured and discharged from hospitals, out of which 3,410 were discharged during the past 24 hours. — Xinhua

New Zealand reports 6,407 new community cases of COVID-19

NEW Zealand recorded 6,407 new community cases of COVID-19, the ministry of health said on Monday.

Among the new community infections, 2,066 were reported in the largest city Auckland, the ministry said in a statement.

A further two people who have travelled from overseas to New Zealand have been confirmed as having the BA.5 variant of Omicron, it said.

Both people travelled to New Zealand and subsequently returned positive RAT and PCR results. Whole-genome sequencing subsequently confirmed the BA.5 variant. Following the first BA.5 case reported on Sunday, there are now three people who are confirmed to have the variant, all of whom travelled from South Africa, the statement said.

Both BA.4 and BA.5 have been reported in Southern Africa and Europe, and both variants have been detected in Australia. The arrival of the BA.5 sub-variant in New Zealand is not unexpected, it said. — Xinhua

Australia in midst of COVID-19 reinfection wave: expert

A leading expert has warned of a COVID-19 reinfection surge across Australia in the lead-up to winter.

Adrian Esterman, an infectious diseases expert from the University of South Australia, on Monday said reinfections were on the rise as natural immunity from the peak of Australia's Omicron wave in December and January begins to wane.

Governments across Australia do not have systems in place to track reinfection rates, which Esterman said has left ex-

perts relying on data from overseas. "We can't say hand over heart the same thing's happening here, but there's no reason why we wouldn't be seeing a reasonably large number of reinfections in Australia as well," he told The Canberra Times. According to the Canberra Times, the subvariants have proved adept at avoiding immunity from vaccination or prior infection, and Australians are increasingly testing positive to COVID-19 for the second time.

Australia's rate of COVID-19 infection has remained stable at

approximately 40,000 new cases per day since mid-April. In the Australian Capital Territory, the number of cases being treated in hospitals hit an all-time high of 76 on Sunday.

However, Esterman said the expected winter spike in cases would not have the same impact on the hospital system as previous waves. The federal, state and territory governments have urged all Australians to receive their influenza vaccinations to avoid the risk of a double blow to the health system. — Xinhua

Strict pandemic control in Shanghai buys time for full vaccination coverage: study

CHINESE epidemiologists said in a peer-reviewed medical journal that the strict, comprehensive pandemic control strategies in Shanghai will buy time for full vaccination coverage.

Without strict public health measures, the number of severe to critical cases and the resulting death toll could be high among unvaccinated older people, according to a study published recently in *Lancet*. Those measures include large-scale viral nucleic acid and antigen screening, quarantine of infected cases and close contacts in shelter hospitals and hotels, respectively, and lockdown of districts with severe outbreaks, according to the study.

The researchers from the National Research Centre for Translational Medicine and Fudan University compared the fatality rate in Hong Kong during its recent wave of the COVID-19 pandemic and that in New Zealand. In Hong Kong, the crude case fatality rate among those older than 60 years was 2.7 per cent, and 19.3 per cent of this age group has not been vaccinated. Comparatively, only 2 per cent of New Zealand's population older than 60 years has not been vaccinated, and they reported a low COVID-19 crude case fatality rate of 0.07 per cent. — Xinhua

China's April exports slump to lowest in two years as virus bites

CHINA'S export growth slumped in April to its lowest level in almost two years, customs data showed Monday, as a Covid resurgence shuttered factories, sparked transport curbs and caused congestion at key ports.

The data shows the extent of growing damage to the world's second-largest economy as millions are confined to their homes — particularly in key business hub Shanghai — to stamp out its worst Covid resurgence since the early days of the pandemic.

Beijing has persisted with a strict zero-Covid policy involving lockdowns and mass testing, but the economic costs are mounting as manufacturing hubs and supply chains atrophy under gruelling restrictions.

Export growth plunged to 3.9 per cent on-year last month, the Customs Administration said Monday.

While this was above analysts' expectations of 2.7 per cent growth according to a Bloomberg poll, it marked the lowest

rate since June 2020.

Import growth was flat in April, an improvement from a 0.1 per cent contraction in March, as Chinese consumers remain hesitant under a welter of restrictions across the country.

Customs spokesman Li Kuiwen tried to strike an upbeat note on Monday saying the economy still has room to make a turnaround and that its "positive fundamentals" remain unchanged.

But analysts are less optimistic.

"Export growth could get worse in the next couple of months due to the pandemic and China's stringent Covid containment measures, falling external

demand, and loss of orders to other regions," Nomura chief China economist Ting Lu told AFP.

Export growth was among the key economic drivers of the last several quarters but could turn into a "drag" on the economy, he warned.

Last month, China's trade surplus came in at \$51.1 billion, according to official data.

A dilemma

In April, China's biggest city Shanghai was almost entirely sealed off as it became the epicentre of the country's worst coronavirus surge, with many factories halting production and trucker shortage causing goods to pile up at its port.

Restrictions also appear to be looming in other cities, including the capital Beijing.

"Lockdowns in large cities like Shanghai and rising input costs are major reasons" behind the underwhelming trade figures, analyst Zhaopeng Xing of ANZ Research said.— AFP

Vietnam's cloth import up 10.3 pct in first 4 months

VIETNAM spent over 4.8 billion US dollars on cloth imports in the first four months of this year, posting a rise of 10.3 per cent year on year, according to the General Statistics Office on Monday.

Between January and April, Vietnam imported some 469,000 tonnes of cotton worth more than 1.2 billion dollars, down 18.6 per cent in volume and up 23.4 per cent in value year on year.

Over the period, the country also spent 928 million dollars importing 370,000 tonnes of yarn, up 6.1 per cent and down 9 per cent respectively year on year. Last year, Vietnam spent nearly 14.4 billion dollars importing cloth and earned more than 32.7 billion dollars from exporting garments and textiles, according to the office.— Xinhua

ECB should raise rates as soon as July: Finland bank chief

FINLAND'S central bank chief Olli Rehn said Monday the ECB would have to raise its key interest rate as soon as July, as the bloc battles soaring inflation spurred by Russia's invasion of Ukraine.

The ECB has kept interest rates at rock bottom over the last years to prop up a weak European economy.

But with consumer prices bounding up dramatically, calls have grown for the ECB to end its stimulus and follow other central banks in raising its key rates.

Unlike in the US where wages have risen by six per cent for the year, in Europe, the increases have been limited to between 1.5 and 2.5 per cent, Rehn noted in an interview with Welt daily.

However, he said there were already signs of such second-round effects of inflation.— AFP

Indonesia maintains steady growth in first quarter thanks to exports

INDONESIA'S economy maintained steady growth in the first quarter of 2022 despite global tensions, official data showed on Monday, as the nation reaped the benefits of soaring commodities prices and an easing of Covid restrictions.

Indonesia was badly affected by the coronavirus pandemic, with its exports and tourism-reliant economy taking a massive hit in 2020 as GDP shrunk by 2.07 per cent — its first recession since the 1997 Asian financial crisis.

But Southeast Asia's largest economy has picked up in recent months, and the Central Statistics Agency (BPS) on Monday reported an on-year expansion of 5.01 per cent in January-March.

"The high economic growth for the first quarter of 2022 is caused by the recovery of public activities," head of the bureau Margo Yuwono said during a press conference.

"Public mobility in the first quarter of 2022 has been really good."

Exports showed an especial-

ly impressive growth of 16.22 per cent in the first quarter of 2022 as prices for Indonesia's palm oil, nickel and tin soared on the global market.

Moody's Analytics said Indonesia's first-quarter showing exceeded their forecast.

"The result indicates that Southeast Asia's largest economy is on track to achieve the government's full-year growth

target of 4.5 per cent to 5.3 per cent," it said in a note released Monday.

Indonesia in March had dropped quarantine requirements for all travellers with a negative PCR test.

It has also seen a tripling of foreign tourist arrivals between January to March this year, compared to the same period in 2021.— AFP

“Doctor Strange in the Multiverse of Madness” tops North American box office on debut weekend

DISNEY'S presentation of Marvel's superhero film “Doctor Strange in the Multiverse of Madness” took the top spot at the North American box office on its debut weekend with a three-day estimate of 185 million US dollars, according to studio figures released by measurement firm Comscore on Sunday.

It's the biggest opening weekend of any film released in North America so far this year and the second best of the COVID-19 pandemic era, only after another superhero film “Spider-Man: No Way Home,” which opened with a massive 260 million dollars at the end of last year.

Based on Marvel Comics featuring the character Doctor Strange, the blockbuster is the sequel to 2016's “Doctor Strange.” Directed by Sam Raimi, the film stars Benedict Cumberbatch as the title role, along with Elizabeth Olsen, Benedict Wong, Rachel McAdams, Chiwetel Ejiofor, Xochitl Gomez. Hollywood and US news outlets applauded the film's successful debut.

The film “showcases the global demand for big-screen events, premium formats, and shared experiences in a movie theater,” Shawn Robbins, chief analyst at the Boxoffice website, was quoted as saying by CNBC.—Xinhua

Asian stocks tumble on global anxieties over inflation and China lockdowns

ASIAN stocks fell on Monday as investors remained anxious over inflation and the ongoing impact of China's Covid lockdown policies, despite an initial Wall Street bounce thanks to a solid US jobs report.

Global markets have taken a beating over a series of crises including surging inflation, rising interest rates, China's economic slowdown and the war in Ukraine.

Investors were given more bad news on Monday as China's April exports slumped to their lowest level in almost two years, due to Beijing's strict zero-Covid policy which has pushed millions under lockdowns and halted manufacturing hubs. Ex-

ports plunged to 3.9 per cent on-year, while imports were stagnant for April.

Chinese customs spokesman Li Kuiwen tried to strike an upbeat note by saying the economy still had room to make a turnaround but experts were less optimistic.

“Asian equities are down heavily in the red today as regional markets react to tightening Covid-19 restrictions in China and fears of a prolonged slowdown in the world's second-largest economy,” Jeffrey Halley, a senior market analyst at OANDA Asia Pacific, said.

Lockdowns across dozens of Chinese cities—from the manufacturing hubs of Shenzhen and

Shanghai to the breadbasket of Jilin—have wreaked havoc on supply chains over recent months, crushing small businesses and trapping consumers at home. The jitters reverberated across Asian equities Monday, tanking

in Australia, Singapore and Seoul. Tokyo's Nikkei index closed down more than 2.5 per cent, while China's two mainland indices — Shanghai and Shenzhen—saw a slight bump throughout the day. — AFP

Nagasaki mayor to attend 1st UN nuclear ban meeting in June

NAGASAKI Mayor Tomihisa Taue will attend the first meeting of parties to a UN treaty banning nuclear weapons in Vienna next month to rally the global community against the use of such armaments, the city government said Monday.

"We need to raise international public opinion on halting the use of nuclear weapons," amid drastic changes to the security situation following Russia's invasion of Ukraine, Taue said during a meeting with city assembly members.

His remarks came ahead of his participation in the three-day meeting of the signatory states to the Treaty on the Prohibition of Nuclear Weapons from 21 June.

He will be joined by Hiroshima Mayor Kazumi Matsui, who has expressed his intent to take part.

Nagasaki and Hiroshima were the two Japanese cities attacked separately by US atomic bombs in August 1945 in the final stages of World War II. Their mayors have been actively campaigning for a nuclear-free world.

Taue has been calling on the Japanese government to sign and ratify the treaty and participate in the meeting as an observer.

The Japan Confederation of A- and H-Bomb Sufferers Organizations has also said it will send some A-bomb survivors, known in the country as hibakusha, to the June meeting.

The treaty is the first international pact outlawing the development, testing, possession and use of nuclear weapons. It came into effect in January last year with the support of many non-nuclear states.

But nuclear-weapon states, such as the United States, are not part of it, while Japan has not signed the pact due to its security alliance with the United States, which offers the shelter of its nuclear umbrella.

Concerns linger over Russia possibly using nuclear weapons during its war in Ukraine, which began in late February, although the United States has said it does not see an increased risk of Moscow doing so. — Kyodo

6.3-magnitude quake strikes off Taiwan's coast

A 6.3-magnitude earthquake struck off the coast of Taiwan on Monday afternoon, the US Geological Survey said, with buildings in capital Taipei sent swaying. Local television news said the shake was felt across the island, though there were no immediate reports of damage.

According to USGS, the offshore quake hit at a depth of 27 kilometres (17 miles), about 70 kilometres southwest of Yonakuni, a Japanese island just off Taiwan. Taiwan and the surrounding area are regularly hit by earthquakes as they sit near the junction of two tectonic plates.

In March, a 6.7-magnitude earthquake that struck off Taiwan's eastern coast rattled buildings and roused people from their sleep, leaving one injured and causing a half-constructed bridge in the island's east to collapse. — AFP

Jetliner aborts landing in Mexico to avoid another plane

A jetliner attempting to land in Mexico City aborted its approach at the last second to avoid hitting a plane taxiing on the runway, an airline official said Sunday. Video circulating on social media showed the near-miss involving two Airbus jets belonging to low-cost Mexican carrier Volaris Saturday night at Benito Juarez Airport, the busiest in Latin America.

The airline did not disclose the flight numbers, exact model of aircraft or how many passengers were aboard.

"Thanks to the training of our pilots ... no passenger or crew member was at risk during the incident reported the night of 7 May," Volaris CEO Enrique Beltranea wrote on Twitter. Mexican news organizations said Victor Hernandez Sandoval, a senior communications ministry official who redesigned air traffic patterns over the sprawling city so it could operate two airports, had tendered his resignation. The video shows one plane about to land when it suddenly pulls up to avoid hitting the jetliner taxiing on the ground.

Because of saturation at the current facility, the previous government began construction of a second airport in Texcoco, a suburb of the city. — AFP

Iran says EU nuclear coordinator to visit this week

THE European Union's coordinator for talks between Iran and world powers over restoring a 2015 nuclear deal will visit Tehran this week, Iran's foreign ministry said Monday.

"The agenda for talks (with Enrique Mora) in Tehran is nearly finalised," foreign ministry spokesman Saeed Khatibzadeh said at a weekly press briefing.

"He will meet with Ali Bagheri, the Islamic Republic of Iran's chief nuclear negotiator."

The date of Mora's arrival in Iran's capital has not been

confirmed, but local press reported he is expected on Tuesday.

The 2015 deal gave Iran sanctions relief in exchange for curbs on its nuclear programme to guarantee that it could not develop a nuclear weapon, something Tehran has always denied wanting to do.

It was agreed between Iran and the five permanent United Nations Security Council members China, Russia, the United States, United Kingdom and France, alongside Germany.

But the US unilateral-

ly withdrew in 2018 under then-president Donald Trump and reimposed biting economic sanctions, prompting Iran to begin rolling back its own commitments.

Talks in Vienna have over the last year focused on bringing the US back into the deal and lifting its sanctions, while ensuring Tehran's full adherence to its own commitments.

Adversaries for decades, Iran and the US have been engaged in negotiations only indirectly, even while Tehran has negotiated directly with the remaining parties to the

Marcos Jr leads in Philippine presidential election as votes counted

FORMER senator Ferdinand Marcos Jr, the son and namesake of the late Philippine dictator, was in the lead Monday evening as votes were being tallied in the Philippines' presidential election.

The elections to pick the country's new leaders, including the vice president, were held amid hopes they will guide South-east Asia's third-largest economy as it navigates a recovery from the coronavirus pandemic.

Marcos Jr was ahead of opposition candidate and Vice-President Leni Robredo by 10.5 million votes, with 61 per cent of the votes counted, according to local television station GMA.

Polling stations closed at 7 pm, but those already in line were

allowed to vote past the deadline.

Marcos Jr has vowed to carry on President Rodrigo Duterte's policies, including his anti-drug campaign that has seen thousands of innocent people reportedly killed. In contrast, as a human rights lawyer, Robredo has criticized the so-called war on drugs. Recent pre-election surveys had shown Marcos Jr holding a wide lead over Robredo.

Popularly known as Bongbong, Marcos Jr, 64, is running with Sara Duterte-Carpio, the daughter of Duterte, as his vice-presidential running mate. Sara Duterte-Carpio, 43, is considered a shoo-in as vice-president. While the Marcos-Duterte alliance has plenty of support,

some victims of the atrocities committed while Marcos senior was in power have expressed concerns. The dictator's 21-year-long administration was marked by rampant human rights abuses, torture, killings and embezzlement until he was overthrown by the 1986 pro-democracy "people power" revolution. During the election campaign, Marcos Jr said he will focus on promoting small and medium-sized businesses and agriculture as well as accelerating industrialization, as his father's government had worked on the areas in the 1970s. Although the Philippines faces its deepest economic downturn since the 1980s and a record high debt of 12.68 trillion pesos (\$242

billion), Marcos Jr has said the Philippines is in a "relatively good position" in terms of the ratio between debt and gross domestic product. Meanwhile, Robredo, who is also an economist, pledged to work for more efficient tax collection and provide a three-month subsidy as well as vocational training for the unemployed. She

has gained endorsement from a number of economists for her "solid" career in economics and the law.

Other presidential candidates include retired boxing star Sen. Manny Pacquiao, Manila Mayor Francisco Domagoso and Sen. Panfilo Lacson, a former national police chief. — Kyodo

Mexican President presses for end to US sanctions on Cuba

MEXICO'S President Andres Manuel Lopez Obrador called Sunday for an end to US sanctions against Cuba as he concluded a migration-themed tour of Central America and the Caribbean.

During the trip, which has also taken him to Guatemala, Honduras, El Salvador and Belize, Lopez Obrador urged the United States — where many migrants are headed — to help solve underlying economic problems fuelling the wave.

Cuba has seen its own exodus accelerate, with more than 78,000 of its nationals arriving in the US via Mexico from October 2021 to March this year, according to US customs data.

The wave has been fuelled by the communist nation's worst economic crisis in nearly three decades, which it blames in large part on six decades of US sanctions that were tightened under Donald Trump.

On Sunday, Lopez Obrador said he would continue to insist that the United States lift what he called a blockade against the island nation.

Many thousands of US-bound undocumented mi-

grants, most of them Central Americans, cross Mexico's southern frontier with Guatemala each year fleeing poverty and violence.

In 2021 alone, Mexican authorities detected more than 300,000 irregular migrants.

US Customs and Border Protection officials have registered 7,800 undocumented migrants a day along the border with Mexico in recent weeks — almost five times the average in 2014-2019. Lopez Obrador argued on his trip that migration from Latin America was "the result of the difficult conditions in our countries, from the Rio Grande to the south."

"The will of Latin Americans is not enough; we also need the United States to become clearly involved in solving a problem that also affects it and to contribute to financing job creation projects," he said in Honduras.

And in El Salvador, Lopez Obrador argued that "the United States, a protagonist of the migration phenomenon, must, therefore, be jointly responsible for solving it, modifying its migration policy." — AFP

RUSSIA-UKRAINE CONFLICT

Putin calls Russia's military operation in Ukraine "right decision"

RUSSIAN President Vladimir Putin on Monday stressed the "special military operation" in Ukraine was the "only right decision" for his country during a speech at an annual event to mark the 77th anniversary of the Soviet Union's victory over Nazi Germany in World War II.

In a public address during Victory Day celebrations at Red Square in central Moscow, Putin justified sending troops into Ukraine as a "pre-emptive rebuff to aggression" from member countries of the North Atlantic Treaty Organization, saying the security bloc had created

an "absolutely unacceptable threat".

Again labelling the Russian invasion a "special military operation," he did not use the highly symbolic anniversary to formally declare war on Ukraine as some had expected.

More than two months after invading Ukraine, Putin instead blamed the West for not responding to Russia's calls for "honest dialogue", and criticized the provision of weaponry and other military equipment to Ukraine.

His speech was followed by a military parade featuring

around 11,000 troops and around 130 military vehicles, including new tanks and intercontinental ballistic missile launchers. — Kyodo

West continues to ramp up sanctions on Russia, increase strain on global economy

THE United States and its Western allies on Sunday announced new sanctions against Russia over the Ukraine crisis, a move that aims to further cripple Moscow's economy but poses severe challenges for global economic recovery from the COVID-19 pandemic.

The Group of Seven (G7) said Sunday that the bloc will phase

out or ban the import of Russian oil following a video conference.

According to its statement, the group will carry out the oil ban over a period of time in order to find alternative supplies. It will also take further actions against Russian banks, and continue sanctions against additional individuals.

Ukrainian President Volod-

myr Zelensky attended the G7 meeting, during which he asked the Western countries to provide more weapons and financial support for Ukraine. Zelensky said Ukraine is interested in getting the M142 high mobility artillery rocket system and M270 multiple launch rocket system from the G7 countries, the presidential press service reported. — Xinhua



Milan close in on title glory after Tonali double sinks Verona

SANDRO Tonali fired AC Milan closer to the Serie A title with a brace in Sunday's 3-1 win at Verona which maintained their two-point lead over Inter Milan at the top of the league.

Italy midfielder Tonali struck with almost identical goals created by Rafael Leao either side of half-time before Alessandro Florenzi completed the scoring near the end to leave Milan needing four points from their final two games to claim a first Scudetto since 2011.

Their superior record in this season's Milan derbies gives the seven-time European champions an advantage which would keep them ahead of champions Inter should the two local rivals end the season level on points.

"I'm in love with my play-

ers," said coach Stefano Pioli to DAZN. "I see the effort they put in every day and I know the journey we've been on... we've got to keep this concentration, determination and belief in the final two games."

Milan overcame the toughest test of their run-in against ninth-placed Verona and now host Europe-chasing Atalanta next weekend before travelling to Sassuolo on the closing weekend of what has been an enthralling campaign.

Inter meanwhile are in Sardinia on Sunday against a Cagliari team fighting for its Serie A life, with their final opponents Sampdoria and the small matter of the Italian Cup final against Juventus on Wednesday further complicating matters. — AFP
