## Five-Point Road Map of the State Administration Council

1. The Union Election Commission will be reconstituted and its mandated tasks, including the scrutiny of voter lists, shall be implemented in accordance with the law.
2. Effective measures will be taken with added momentum to prevent and manage the COVID-19 pandemic.
3. Actions will be taken to ensure the speedy recovery of businesses from the impact of COVID-19.
4. Emphasis will be placed on achieving enduring peace for the entire nation in line with the agreements set out in the Nationwide Ceasefire Agreement.
5. Upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held in line with the 2008 Constitution, and further work will be undertaken to hand over State duties to the winning party in accordance with democratic standards.

**IT** is necessary to honour the efforts and sports spirit as well as victories of Myanmar athletes who deservedly secured a national level position in the SEA Games, said Chairman of the State Administration Council Prime Minister Senior General Min Aung Hlaing at the ceremony to honour victorious athletes for winning medals in the XXXI SEA Games at the Wunna Theikdi Sports Complex (B) in Nay Pyi Taw yesterday morning.

In his address, the Senior General said it can be seen that athletes compete in the local sports contests, and regional and international sports competitions by showing their excellent skills in order to upgrade the health and fitness of the people and sports standards of the country.

In the XXXI SEA Games, 293 athletes from Myanmar in addition to 97 coaches and administrative officials competed in 20 sports events with their earnest efforts and bagged nine gold, 18 silver and 35 bronze medals, totalling 62, securing the seventh position among 11 contending countries.

# IP system of Myanmar must conform to the international standards and comply with the political, economic and educational conditions of the country: Vice-Senior General

MYANMAR needs to prepare to join the IP international agreements similar to other ASEAN member countries in accord with the procedures of the ASEAN Economic Community, said Chairman of the Central Committee on Rights of Intellectual Property Vice-Chairman of the State Administration Council Deputy Prime Minister Vice-Senior General Soe Win at the meeting 1/2022 of the Central Committee on Rights of Intellectual Property in Nay Pyi Taw yesterday afternoon.

Speaking at the meeting, the Vice-Senior General said that the government of the Republic of the Union of Myanmar has enacted the Trademark Copyright Law, the Industrial Design Copyright Law, the Invention Copyright Law and the Literary and Artistic Copyright Law on 30 January 2019. The Department of Intellectual Property will mainly take responsibility for the implementation of the laws while the Customs Department, Ministry of Planning and Finance and the Supreme Court of the Union will take action against the violations of the intellectual property.

The Constitution (2008) grants the citizens to enjoy the rights of intellectual property, rights of innovation and trademarks without violation of its provisions.

In implementing the State

economic policies, exercising the rights of intellectual property can contribute much to the development of businesses based on innovation and the emergence of the private sector capable of creation, innovation and competitiveness involved in the Myanmar sustainable development plan (2018-2030) while supporting the economic development of the State.

The work procedure of the Myanmar Economic Recovery Plan-MERP was mentioned to implement the intellectual property laws as a work procedure in the law, bylaw, rules and regulations and procedure reform sector. Hence, all need to accept

that establishment of the intellectual property system is a good aid for the development of the State economy.

Being a member of the World Trade Organization and the World Intellectual Property Organization, Myanmar needs to comply with the trade treaty related to intellectual property and join the cooperation in IP among Southeast Asian countries.

As the IP project is being implemented in the ASEAN region, all regional countries are implementing the IP system contributing to the development of investment and trade flow as well as economic booming. Hence, Myanmar needs to

prepare to join the international IP conventions similar to other ASEAN member countries in accord with the procedures of the ASEAN Economic Community.

The IP system of Myanmar must conform to the international standards and comply with the current political, economic and educational conditions of the country. Hence, it is necessary to implement the laws one after another to systematically affect four IP laws.

The agency for the intellectual property must be set up as quickly as possible for declaring necessary notifications, orders and directives to implement the duties and functions adopted by

the central committee.

Exercising the IP laws will contribute to the development of the State economy, strengthening the system of protecting the IP system for businesspersons, increasing the foreign investment and human resources, creating new job opportunities, taking over the modern techniques and raising the production.

The Vice-Senior General urged the people to join hands with the government in soonest implementing an IP system for the improvement of economic, social, scientific and cultural, innovation and the creation of the State.

Vice-Chairman of the Central Committee Union Minister for Commerce Dr Pwint San reported on measures for the emergence of the IP system. Secretary Deputy Minister U Nyunt Aung presented accomplishments in the minutes of the central committee in the first meeting with a video on the efforts of the IP Department.

Joint-Secretary Director-General Dr Moe Moe Thwe presented reports to the meeting 1/2022. The Vice-Senior General discussed each report. Then, the central committee members participated in the discussions and approved the draft decisions of the meeting. Later, the Vice-Senior General attended to the needs. — MNA

## MoH Union Minister receives Global Fund's officials

UNION Minister for Health Dr Thet Khaing Win received the delegation led by Mrs Izaskun Gavira, the Global Fund's Senior Fund Portfolio Manager in Nay Pyi Taw on Thursday.

During the meeting, they discussed treatment for HIV/AIDS, MDR – TB (Multidrug-Resistant), and malaria arrangements of ministry to ensure medicines, medical and lab equipment, and assistance to conduct training courses for disease control and further cooperation work between Global Fund and the ministry.

Then, Deputy Minister for Health Prof

Dr Aye Tun presided over a meeting on HIV/AIDS project, TB project, Malaria project, the Global Fund and its associate organizations following COVID-19 health rules.

During the event, they focused on the effective use of further assistance from the Global Fund in Myanmar in 2022, proper treatment for diseases, capacity-building training to accelerate disease prevention measures in regions/states and support from the Global Fund in the coming year.

The two-day meeting was held on 2 and 3 June in Nay Pyi Taw.—MNA



## Sugar price hit record-high of K2,200 per viss

THE price of sugar spiked to a record high of K2,200 per viss (a viss equals 1.6 kilogrammes) in the domestic market, said Ko Ta Yoke from the Bayintnaung Sugar Commodity Centre.

The domestic sugar mills start to run at the end of the year. Therefore, it takes a long time for the new sugar season. Moreover, the global sugar export slump is another contributing factor to the price rise. The price is unlikely to fall, domestic sugar producers said.

“The wholesale price of sugar touched a high of K1,750 per viss in late 2010. On 31 May 2022, the price reached a fresh peak of K2,200,” said Ko Ta Yoke.

The local sugar brands sell the sugar at the wholesale price of K2,140-2,200 per viss in Yangon. The sugar market collapsed in the past years owing to the COVID-19 impacts, resulting in a decrease in sugarcane sowing acres. This year, more sugarcane acres are added. The sugarcane processing started in mid-December and the season has not ended yet. Approximately 440,000 tonnes of sugar are expected to flow into the market, market

observers guessed.

According to the price data released daily by Mandalay Sugar and Sugarcane Products Enterprises Association, the sugar prices moved in the range of K1,700 and K2,100 on 28 May, while the syrup price was from K600 to K1,520.

The dealers are not commercially doing well when they sell the sugar produced by the

Mandalay region as transport to Yangon city is added, said Ko Kyi Lwin, a seller from Nyaungbinlay market.

The sugar market tends to be slow-moving in the monsoon season every year. However, the Kyat depreciation against the US dollar drove the price up. The prices this year are on the rise compared to that of the previous years, traders stated.

Shopping centres in Yangon offer K800 for a 400-gramme sugar bag and K3,200 per viss (1,660 gramme).

This year, the sugarcane price rallied to K660,000 per tonne on average.

Myanmar was allowed to import the sugar from foreign markets and re-export them to neighbouring countries via cross-border trade. At that time,

the wholesale price stood at only K1,600 per viss. When the re-export was banned, the wholesale price was only K900 per viss between mid-2018 and early 2021.

Starting from mid-January 2021, Kyat weakening against the US dollar raised the price up to above K1,000 per viss. The strong demand in late September 2021 hiked up the price to K1,800 per viss. The price is gradually increasing with K2,050 in January-end and K2,150 in April-end. The price remained in an upward trend and hit K2,200 in May-end 2022.

The surge in sugar prices increases the interest of the sugarcane growers.

The local sugar processing plants are mostly located in Bago, Sagaing and Mandalay regions. The mills are also found in Shan, Rakhine and Kachin states.

The global sugar price stands at US\$0.19-0.20 per pound (a viss equals 3.6 pounds).

At present, Myanmar's syrup is exported to China through border trade. It is also shipped to Viet Nam via sea trade this year. — TWA/GNLM

## Pilot project introduced for disability classification, registration in 4 townships

THE pilot project for disability classification and registration will be implemented in four townships including Yangon Region, according to the Department of Rehabilitation under the Ministry of Social Welfare, Relief and Resettlement.

The pilot projects will be in Pobbathiri Township of Nay Pyi Taw Council, Hline-thaya Township of Yangon Region, Nyaunglebin Township of Bago Region and Hpa-an Township of Kayin State.

The 61<sup>st</sup> United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) adopted its optional protocol for disabilities on 13 December 2006. Myanmar ratified the UNCRPD on 7 December 2011.

According to the 2019 inter census survey, the rate of disability is 6.3 per cent in seeing, 2.4 per cent in hearing, 5.4 per cent in walking/climbing steps, 4.4 per cent in remembering and concentrating, 1.9 per cent in self-care and 1.6 per cent in communication.

Being a country of the Asia-Pacific Region and an ASEAN member, Myanmar cooperates with UN agencies, partner associations and organizations of persons with disabilities to implement Incheon Strategy to Ensure the Rights of Persons with Disabilities in Asia and the Pacific (2013-2022) and ASEAN Enabling Master Plan (2025). — TWA/GNLM

## Action to be taken against petrol stations that sell overpriced fuel

THE Petroleum Import, Storage and Distribution Oversight Committee are publishing daily reference retail prices of oil in Yangon, Mandalay, Nay Pyi Taw, and regions/states, as well as it is also overseeing to ensure that the fuel will not run out and the price is stabilized, according to the statements of the committee.

Myanmar can produce and supply only 10 per cent of the domestic fuel demand within the country, and as the rest 90 per cent is imported, the fuel price in the country is changing depending on the global fuel price.

If the fuel prices on 31 May 2022 are calculated at an exchange rate of K1,850 per one US dollar, one litre of petrol was K2,240 (US\$1.21) and one litre of diesel K2,450 (US\$1.324), while in Singapore, one litre of petrol was US\$2.260 and one litre of diesel was US\$2.107, which is 76 per cent and 57 per cent higher than the prices in Myanmar. Fuel

required in Myanmar is mainly imported from Singapore.

Myanmar is collecting fewer tax rate on the import of fuel and is setting policies to ensure that the people can purchase at a reasonable price. In some countries, fuel prices are high due to the import tax, and, in Malaysia, the price is 60 per cent lower than in Myanmar due to the subsidization of the government.

In Myanmar, the Petroleum Import, Storage, and Distribution Oversight Committee were established on 21-4-2022 with 10 members, and the State Administration Council is also setting the exchange rate at K1,850 per US dollar. — TWA/GNLM

## Illegal timbers and vehicles seized

SUPERVISED by the Anti-Illegal Trade Steering Committee, effective action is being taken to prevent illegal trade under the law.

An inspection team led by the Forest Department conducted inspections and captured 0.5194 tonne of illegal teak doors, window doors and parts of teak doors worth K342,804 and a vehicle (approximately K15,000,000), which carried these illegal items in Hmawby Township of Yangon Region on 3 June. The action

was taken under the Forest Law.

Similarly, a team led by the Forest Department under the management of the Sagaing Region Anti-Illegal Trade Task Force confiscated 0.8002 tonne of illegal. In timber parts worth K80,020 in Tamu Township and action was taken under the Export/Import Law.

Thus, two arrests worth approximately K15,422,824 were made on 3 June, according to the Anti-Illegal Trade Steering Committee. — MNA

## Drugs seized in Myitkyina and Mingala Taungnyunt townships

A combined team consisting of members of the Anti-Drug Police Force stopped and searched a motorbike driven by Tu Ja at the 21<sup>st</sup>-mile combined checkpoint near Lwekhau village of Myitkyina Township and seized 0.232 kilogramme of heroin at 2 pm on 2 June.

At 4 pm on the same day, Police Force examined the suspected Htet Myat Aung and Ko Ko Win (aka) Kalarlay on Myanmagon-yay Street in Mingala Taungnyunt Township. They seized 4,000 stimulant tablets.

The suspects are prosecuted under the Narcotic Drugs and Psychotropic Substances Law, the Myanmar Police Force stated. — MNA

## K170 million worth of drugs in Yangon Region, Kayin State

K170 million worth of ecstasy tablets and Ketamine were captured in Yangon Region and Kayin State, according to the Police Force.

A combined inspection team consisting of members of the Anti-Drug Police Force searched a room of a hotel in Bahan Township of Yangon Region, according to information. Police seized Naing Lwin and Hein Thu Soe (a) Shake with 50 ecstasy tablets and 3 grammes of Ketamine on 25 May at 2:30 pm.

According to the examination, at 7:00 pm on the same day, police captured trafficker Htet Aung Wai (aka) Jason with a Chevrolet car, 4,000 ecstasy tablets, 170 grammes of Ketamine and 70 bags – seven grammes each – of mixed Ecstasy powder (Happy Water). According to the investigation, the Anti-Drug Police Force seized a restaurant owner Kaung Sit (aka) Ko Sit with 0.2 gramme of Ketamine, one Ec-

stasy tablet and 15 grammes of mixed Ecstasy powder (Happy Water) in Myawady Township of Kayin State.

According to the examination, they admitted the drugs to be sold to youths who come

to KTV and Entertainment Bar/Club. Police are investigating and the suspects were prosecuted under the Narcotic Drugs and Psychotropic Substances Law, the Myanmar Police Force stated. — MNA

Engineer and staff of the Yankin Township Electricity Manager's Office under the supervision of the Yangon Electric Power Corporation temporarily switched off the power for the public safety while quickly re-installing power lines and replacing the damaged pole.

The power was restored at 7:55 pm. — MNA

## Green gram price surges again

YANGON green gram (RC) prices tough a high at K1,491,000 per tonne, according to the Bayintnaung Wholesale Commodity Exchange Centre yesterday.

The prices of local green gram and pigeon pea depend on the demand and import policy of India. In the 2019-2020FY, the country earned \$1.2 billion from pulses and beans exports (1.6 million tonnes), according to officials. After the monsoon paddy was harvested in the delta region, the people grow summer paddy, chilli, green gram and pigeon pea. The Ayeyawady Region plants green gram and Kayan and Thongwa townships of Yangon Region plant pigeon pea.

The local cultivation rate of green gram is about 300,000 acres and more than 150,000 acres of pigeon pea, according to the data. The green gram with a low local consumption rate is mainly exported to foreign countries. Indians mainly consume the green gram and pigeon pea and they still import the beans. Due to the weather condition in 2015, the green gram demand was high as the production rate declined in India, and they imported large

volumes of green gram.

In September second week of 2015, the price of green gram (RC) was more than K1.4 million per tonne in the Yangon bean market and more than K2.4 million per tonne in October's second week.

The green gram (RC) was priced at about K420,000 per tonne in October 2017 and the price of red pigeon pea dropped to K380,000 per tonne.

In March 2018, the Indian government allowed bean import and the green gram (RC) fetched K800,000 per tonne, said

bean dealer Ko Thet Win.

The green gram (RC) price dropped to K1,192,000 per tonne on 9 February 2022 and it rose to K1,510,000 per tonne on 26 March. In May, the price was between K1,410,000 and K1,468,000. On 2 June, the price of green gram (SQ/RC) was K1,681,000 per tonne while the pigeon pea was priced at K1,370,000 per tonne, the merchants said.

## Foreign exchange reserve amount set for logistic services

THE number of foreign exchange reserves was set for logistic services associations, according to the Foreign Exchange Supervision Committee's meeting (20/2022).

A member company of the Myanmar International Freight Forwarding Services Association (MIFFA) is allowed to keep about US\$300,000 in the foreign exchange account and a quantity more than that must be exchanged for Kyat.

Similarly, a shipping line of the Myanmar Mercantile Marine Development Association is allowed US\$2 million, and more than this amount must be exchanged for Kyat. In addition, international air freight services and ground services for international airlines are allowed to have US\$100,000 in foreign currency accounts and more than this amount must be exchanged for Kyat. — TWA/GNLM

## PPRD steering fuel oil price stability, ensuring oil security

THE Petroleum Products Supervision and Inspection Department is endeavouring to maintain fuel oil price stability and oil security, according to the statement released on 1 June.

As per the statement, 90 per cent of fuel oil in Myanmar is imported, while the remaining 10 per cent is produced locally. The domestic fuel price is highly correlated with international prices. The State is steering the market to mitigate the loss between the importers, sellers and energy consumers. Consequently, the government is trying to distribute the oil at a reasonable price compared to those of regional countries.

On 31 May, the prices of fuel oil calculated on the official US dollar exchange rate at K1,850 stood at K2,240 (US\$1.21) per litre of Octane fuel and K2,450 (\$1.324) per litre of diesel. Meanwhile, oil prices in Singapore were K4,181 (US\$2.26) per litre of Octane fuel and K3,898 (US\$2.107) per litre of Diesel. The prices in Singapore are up by 79 per cent for Octane

fuel and 57 per cent for Diesel.

Additionally, Myanmar primarily imports fuel oil through Singapore. The oil prices were US\$1.506 per litre of Octane and US\$0.927 per litre of Diesel in neighbouring country Thailand, US\$1.654 per litre of Octane and US\$1.329 per litre of Diesel in Laos, US\$1.4 per litre of Octane and US\$1.258 per litre of Diesel in China and US\$1.344 per litre of Octane and \$1.205 per litre of Diesel in India.

Some countries levied higher tax rates and hiked oil prices against that Myanmar. However, Malaysia's oil sector receives government subsidies and the prices are about 60 per cent cheaper than that of Myanmar. Every country lays down different patterns of policy to fix the oil prices. Myanmar also poses only a lower tax rate on fuel oil and strives for energy consumers to buy the oil at a cheaper rate.

To govern the fuel oil storage and distribution sector effectively, and ensure the quality of imported oil and price stability for

energy consumers, a supervisory committee on oil import, storage and distribution of fuel oil was formed on 21 April.

Moreover, the government set the official exchange rate at K1,850 to stabilize the FX market, keep the balance between exports and imports and mitigate foreign currency risk. For the oil sector, the committee is implementing to import the oil promptly depending on the actual requirement in the domestic market.

The committee is also carrying out to generate the revenue for the State, scrutinize import licences, submit a request to purchase foreign currency, monitor the oil storage and distribution activities, control quality and make traceability records for price manipulation, overcharging and identifying the abnormal condition in handling oil to take actions against those unscrupulous traders.

Furthermore, the department, under the guidance of the committee, is issuing the daily reference rate for oil to offer a

reasonable price to energy consumers.

The reference rate in Yangon Region is set on the MOPS' price assessment, shipping cost, premium insurance, tax, other general cost and health profit per cent.

The rates for regions and states other than Yangon are evaluated after adding the transport costs and the reference rates daily covered on the state-run newspapers and are posted on the media and official website and Facebook page of the department on a daily basis starting from 4 May.

Afterwards, the supervisory committee on oil import, storage and distribution of fuel oil is ensuring the oil security at the retail petrol stations and coordinates the requirements in fuel oil import and inventory restocking. The Myanmar Petroleum Trade Association again formed a working committee on small and medium petrol stations and helped the retail petrol stations directly buy the oil from importers. This

move is also to scale down the oil prices.

The supervisory committee on oil import, storage and distribution of fuel oil is following up with the petrol stations in coordination with the related departments to stick to the set reference rates in the regions and states. Those petrol stations which are found to overcharge the price will be warned first. They will face legal actions under the existing laws later if they keep violating the rules. The related departments are closely observing the petrol stations to take action against those businesspersons who are in breach of law.

People can file any complaints about services at petrol stations through contact numbers (067-409881, 067-411129, 09-699611116 and 09-440433533). Upon the complaints, a surprise check, assessment, discussion and taking actions are conducted. The PPRD is also tackling the matters requested by the oil-importing companies, according to the statement. — NN/GNLM

## Accelerate preventive measures of DHF for the children

**AS** DENGUE hemorrhagic fever breaks out across the world, some 390 million patients are suffering from it a year. Of them, the number of DHF patients is larger in Indonesia, Thailand and Myanmar in Southeast Asia.

Based on the statistics in 2021, a total of 5,446 people become victims of DHF, leaving 36 dead. In 2022, the data collected from 1 January to 20 May 2022 showed that a total of 1,516 people suffered from the disease and two of whom were killed. Currently, an outbreak of DHF hits a large number in Yangon and Ayeyawady regions and Mon State.

It is necessary to emphasize the surveillance and prevention of dengue hemorrhagic fever in all areas. Infection with dengue viruses is transmitted through the bite of infective female Aedes spp. Such a mosquito prefers to regenerate in clean water areas. As such, the best performance to take preventive measures against the DHF is to clean the environment.

Sanitation tasks should be carried out to prevent the regeneration of mosquito bearing DHF virus. Moreover, it is necessary to often combat the Aedes mosquito and larvae in the environs, raising the health awareness of DHF among students and the public. Moreover, people need to take care preventing the mosquito-bites while the authorities should set up the Aedes and larvae free schools for the safety of schoolchildren from the dreadful disease.

In this regard, the Ministry of Health, relevant ministries and departments need to participate in the control of dengue hemorrhagic fever in the society with the contributions of the Department of Fire Services, the Myanmar Fire Brigade and the development committees.

In the school opening season, health staff need to share knowledge about DHF with the students. Moreover, health officials should conduct preventive measures against DHF while serving the school-based vaccination and school health activities in the rainy season.

Not only the government hospitals and health centres across the nation but private clinics in the society should take preventive measures of DHF, raise awareness of DHF for the public and collect data and equipment to fight against the DHF in time. Charity organizations operating blood donation and ambulance services should make preparations to be ready to give services to the patients and their families to calm down their frets. Hence, all the people should beware of dengue hemorrhagic fever for the children in monsoon, the DHF-prone season.

## Record 2 mln people in UK have long COVID: survey

*Most people who develop COVID-19 fully recover, but current evidence suggests approximately 10%-20% of people experience a variety of mid- and long-term effects after they recover from their initial illness. These mid- and long-term effects are collectively known as post COVID-19 condition or "long COVID."*

**AN** ESTIMATED 2 million people in the UK, which represents around 3 per cent of the population, have reported experiencing so-called long COVID, official statistics showed Wednesday (1 June).

Around 1.4 million of them said they first had COVID-19, or suspected they had the virus, at least 12 weeks previously, according to the Office for National Statistics (ONS).

It also found 826,000 of them first had coronavirus at least a year earlier, while 376,000 said they first had it at least two years previously.

The ONS figures are based on people's own reports of suffering from long COVID from a representative sample of private households in the four weeks to 1 May.

**Most common symptom**  
Fatigue is the most common

symptom - experienced by 55 per cent of those with self-reported long COVID - followed by shortness of breath (32 per cent), a cough (23 per cent) and muscle ache (23 per cent).

The biggest proportion were people aged 35 to 69, females, those living in more deprived areas and those working in certain professions such as social care, teaching and education or health care, the ONS said.

Those with another activity-limiting health condition or disability were also more prevalent among the long COVID sufferers, it added.

The UK, which was one of the worst-impacted countries by the pandemic, has eased all restrictions this year as cases and hospital admissions have fallen amid relatively high vaccination rates.

The country of around 67 million people has recorded nearly 18.8 million cases, and almost

178,000 deaths from the virus, ago. The ONS assessment found nearly a third of the 2 million people reporting long-lasting symptoms first had COVID, or suspect-

ed they had it, during the Omicron wave which began late last year.

Its numbers follow another UK study published in April showing that only around a quarter of people have completely recovered from COVID a full year after being hospitalized with the disease.

The research, by the National Institute for Health and Care Research involving more than 2,300 people, also found that women were 33 per cent less likely to fully recover than men.

## Notice

1. Since it is important to get the full revenue from exports, the main source of foreign exchange into the country, Section 38-b of the Foreign Exchange Management Law and Paragraph 35 of the Foreign Exchange Management Law stipulate that the exporter is required to have the export earnings in foreign currency into his/her bank account within six months from the date of shipment (within three months from 10-11-2021).
2. Therefore, in order to ensure that export earnings of the exporters who exported between 2016, 2017, and 2018, are credited back to their bank accounts in foreign currency within six months from the date of shipping, the Central Committee for Acceleration of Trade and Goods, the Ministry of Investment and Foreign Economic Relations, the Ministry of Legal Affairs, the Ministry of Commerce, the Central Bank of Myanmar, the Union of Myanmar Federation of Chambers of Commerce and Industry (UMFCCI), and the Foreign Exchange Authorized Dealer (AD) Licenced Banks, have already done the following:
  - (a) Clarification by AD Banks (within 2 years)
  - (b) Clarification by the UMFCCI (60 days)
  - (c) Announcing to clarify in the newspapers and the website of the Central Bank of Myanmar (60 days)
  - (d) The Ministry of Economy and Commerce closes the registration certificate of importers and exporters (PPA) for those who do not clarify (30 days)
  - (e) Five meetings with exporters led by the Central Committee
3. Exporters are required to comply with Article 38 (b) of the Foreign Exchange Management Law, which states, "No one shall fail to deposit all export earnings into his bank account in the country in foreign currency within the stipulated period," and "Violation of this prohibition is punishable by imprisonment for a term not exceeding one year or a fine or both punishments must be imposed under Section 42-a of the law."
4. Sending notification, revocation of the business registration license, and holding meetings were done to discuss several times under paragraph (2) above, but there are 137 companies that still remain to enter the revenue.
5. The remaining 137 companies (list attached) are being prosecuted under Section 42-a of the Foreign Exchange Management Law, and the boards of directors of the attached companies have been blacklisted. Other companies are also being investigated for taking action on remaining export earnings.

# China's logistics sector rebounds in May

CHINA'S logistics sector registered a recovery in May as supportive policies were in place, according to the China Federation of Logistics and Purchasing (CFLP).

The logistics performance index, which tracks business volume, new orders, employment, inventory turnovers and equipment utility rates in the sector, came in at 49.3 per cent last month, up 5.5 percentage points from the previous month.

A reading above 50 per cent indicates expansion

while a reading below 50 reflects contraction.

He Hui, assistant

president of the CFLP, attributed the improved performance to the coun-

try's measures to unclog the logistics and prop up businesses in difficulties, saying that both the supply and demand sides of the sector fared better.

The sub-index for new orders came in at 48.8 per cent, up 4.4 percentage points from a month ago. The sub-index for business expectation rose 1.8 percentage points from the previous month to 53.7 per cent, indicating logistics firms' upbeat outlook on the prospect of the sector, according to the federation.—Xinhua

# Authorities scramble to remedy Australia's growing energy crisis

AS pressure on Australia's energy market from all sides has seen unfathomable spikes in energy and liquefied natural gas (LNG) prices, authorities and retailers have been emptying out their toolbox to find a fix.

According to a note provided to Xinhua on Thursday by Australia's national energy regulator, the Australian Energy Market Operator (AEMO), the spike has triggered an emergency in the Australian state of Victoria.

"AEMO issued a Threat to System Security market notice for 1 June 2022 at 11:13 am (AEST) in Victoria's Declared Wholesale Gas Market (DWGM) as a result of insufficient gas supply to meet forecast demand," said the note.

Ahead of the forecast, the regulator triggered the Gas Supply Guarantee mechanism for the first time since its implementation in 2017. The mechanism is designed to ensure energy producers are able to meet demand.

Despite this, Australia's energy market remains tight. Wholesale natural gas spot prices spiked to a dizzying 800 Australian dollars (about 573 US dollars) per gigajoule in Victoria, 20 times the market cap of 40 Australian dollars.

Calls have been made to Australia's newly appointed Treasurer Jim Chalmers to force exporters to divert LNG to the domestic market, which he has not yet ruled out as a "last resort". —Xinhua

# Ford to invest \$3.7 bn, boosting legacy Midwestern plants

FORD on Thursday announced fresh multi-billion-dollar capital projects in Midwestern factories near its Detroit home, as the auto giant spreads new investments throughout the United States.

The 119-year-old car-

maker plans to spend \$3.7 billion to add manufacturing capacity for a mix of electric vehicles (EVs) and conventional gasoline-powered autos in the states of Michigan, Ohio and Missouri, much of it at existing plants that have been

in the company's portfolio for years. The move follows an announcement last September of an \$11.4-billion push with SK Innovation, a South Korean battery company, to build greenfield car production and battery plants in Tennessee and

Kentucky.

Major car companies are investing billions of dollars in a race to bring EVs to market, develop driver-assistance programs and outfit their products with the latest and greatest digital equipment.—AFP

# UK groups seal merger to create African energy giant

BRITISH energy explorers Tullow Oil and Capricorn on Wednesday agreed a £1.4 billion (£1.6bn) merger to create a leading player in Africa.

The two firms have reached agreement

over a merger that gives Tullow the upper hand with a 53 per cent stake and Capricorn the rest.

The merger deal "represents a unique opportunity to create a leading African energy

company listed in London", the pair said in a statement.

The enlarged group will possess "financial flexibility and human resource capability to access and accelerate near-

term organic growth, add new reserves and resources cost-effectively, generate significant future returns for shareholders, and pursue further consolidation", they noted.—AFP

## Pakistani Taliban declares indefinite ceasefire as peace talks 'progress'

THE Pakistani Taliban on Thursday declared an indefinite ceasefire with Islamabad, saying "substantial progress" had been made in peace talks in the Afghan capital.

Since the Afghan Taliban returned to power last year, Islamabad has increasingly complained of attacks by the Tehreek-e-Taliban Pakistan (TTP), especially along the mountainous border with Afghanistan.

The TTP is a home-grown movement but shares roots with the new rulers in Afghanistan, who Pakistan has claimed lets its fighters stage assaults from

Afghan soil.

In recent weeks peace talks have been brokered by the Afghan Taliban in Kabul, bringing together Islamabad and the TTP, which has battled Pakistani forces for over a decade.

The talks received a boost after a new delegation of tribal elders from Pakistan arrived in Kabul on Tuesday for a fresh round of negotiations with the TTP.

"In the two days of meeting substantial progress has been made and as a result of that the leadership of the TTP has extended the ceasefire until fur-

ther notice," the militant group's spokesman Muhammad Khurasani said in a statement issued in Kabul. A truce previously agreed until 30 May for the Islamic festival of Eid had held until now.

"For taking the negotiations forward further meetings will be held in few days," Khurasani said. A Pakistani government official who did not want to be named told AFP that the talks held in Kabul were moving in a "positive direction". The official discussions may be an indication the Afghan Taliban are trying to smooth over rocky relations with Pakistan.—AFP

### RUSSIA-UKRAINE CONFLICT

## War enters 100<sup>th</sup> day with Russia controlling 'fifth of Ukraine'

UKRAINE marked 100 days since Moscow's invasion on Friday with Russian forces hammering the Donbas in their push to capture the country's east.

The somber milestone came less than 24 hours after Kyiv announced Moscow was now in control of 20 per cent of Ukrainian territory, including Crimea and parts of the Donbas seized in 2014. After being repelled from around the capital, President Vladimir Putin's troops have set their sights on capturing eastern Ukraine, prompting dire warnings the war could drag on.

Following White House talks with US President Joe Biden, NATO chief Jens Stoltenberg warned Thursday that Ukraine's allies needed to brace for a gruelling "war of attrition".

"We just have to be prepared for the long haul," Stoltenberg said, while reiterating that NATO does not want direct confrontation with Russia. While the advance has been much slower than Moscow expected, Russian forces have expanded control

beyond the 43,000 square kilometres (16,600 square miles). "Today, about 20 per cent of our territory is under the control of the occupiers," Ukrainian President Volodymyr Zelensky said in an address to Luxembourg lawmakers.—AFP

### NEWS IN BRIEF

#### African Union head to speak to Putin

THE head of the African Union, Senegalese President Macky Sall, will speak with President Vladimir Putin in the southwestern Russian city of Sochi on Friday, Dakar said.

The visit is aimed at "freeing up stocks of cereals and fertilizers, the blockage of which particularly affects African countries", along with easing the Ukraine conflict, Sall's office said Thursday.

The visit was organized after an invitation by Putin, and Sall will travel with the president of the African Union Commission, his office added.

The AU will also receive a video address from Ukrainian President Volodymyr Zelensky, though no date has been set.—AFP

#### US leaders discuss Russia-Ukraine situation with NATO

US President Joe Biden and Vice-President Kamala Harris met NATO Secretary-General Jens Stoltenberg and discussed the implications of war between Russia and Ukraine for transatlantic security. "The leaders discussed the implications of Russia's war on Ukraine for Transatlantic security and the importance of strengthening NATO's deterrence and defence, in addition to ensuring NATO is properly resourced to address a wide range of challenges, from cyber to climate change," a White House said in a statement on Thursday (local time).—ANI

## Russians edge closer to taking key Ukrainian city

RUSSIAN forces edged closer Thursday to taking a key Ukrainian city after days of intense fighting, tightening their slow squeeze on the eastern Donbas region as Washington warned the war could last months.

The industrial hub of Severodonetsk has become a key target for Moscow, and the local governor said that 80 per cent of the city

was now under Russian control.

"Street fighting continues," said Lugansk regional governor Sergiy Gaiday on Telegram, pledging Ukrainian forces "will fight for Severodonetsk until the end".

Ukraine stopped Russia from seizing Kyiv after its February invasion but the campaign in the east has had a high cost, with

President Volodymyr Zelensky reportedly saying that up to 100 Ukrainian soldiers are dying daily.

"The most difficult situation is in the Lugansk region, where the enemy is trying to displace our units from their positions," said Valeriy Zaluzhnyi, the commander in chief of Ukraine's armed forces, according to a statement from the military.—AFP

## Military parade kicks off queen's historic jubilee celebrations

HUGE crowds converged on central London in bright sunshine on Thursday for the start of four days of public events to mark Queen Elizabeth II's historic Platinum Jubilee, in what could be the last major public event of her long reign.

From early morning, a steady stream of people, many clutching Union flags and picnic baskets, headed to The Mall near Buckingham Palace, where the 96-year-old monarch will make two appearances lat-

er. But as well as seeing the pomp and pageantry of the Trooping the Colour military parade, many sensed the coming end of an era.

Ambulance service worker Gilbert Falconer, 65, travelled from Scotland to witness the event, which is held to mark the queen's official birthday.

"We know it's a special occasion because it might be the last day we'll see Her Majesty in a public event," he told AFP.

"This is very significant," added another spectator Daniel Marmah.

"It's the first time we've had a monarch who's lasted for so many years."

### Appearances

The extent of the queen's involvement in the celebrations for her record-breaking 70 years on the throne has been a source of speculation for months.

She has had to cut back drastically her public appearances since last year because of difficulties standing and walking — and a bout of Covid.

But royal officials confirmed that she would take the salute of mounted troops from the balcony.

The centuries-old ceremony has previously seen the queen take the salute on horseback herself.

Her 73-year-old son and heir Prince Charles will step in this year, supported by his sister Princess Anne, 71, and his eldest son, Prince William, 39.

Joining senior royals watching the display of military precision will be Charles' younger son, Prince Harry, and his wife Meghan, on a rare visit from California, Buckingham Palace confirmed.—AFP

## UN approves Turkey's request to change name to Türkiye

THE United Nations on Wednesday granted Turkey's request to change its name from Turkey to Türkiye, Stéphane Dujarric, spokesman for UN Secretary-General Antonio Guterres, told reporters.

The change came into force immediately at the time when the world body received

a letter from Turkish Foreign Minister Mevlut Cavusoglu to the UN chief with a request to change the country's name, the spokesman said.

Cavusoglu reportedly said that the change in the spelling was adopted as part of the steps aimed at increasing the country's prestige in the international arena. — Xinhua

## Vietnam develops new African swine fever vaccine: official

VIETNAM has developed an African swine fever vaccine for pigs in partnership with the United States, and is aiming to become the first global commercial exporter, an official said.

The virus, harmless to humans, decimated hog populations in Asia after it was detected in Vietnam in 2019, with millions of the animals culled following outbreaks in Mongolia, Cambodia, Hong Kong and mainland China.

Pork prices rose dramatically as a result, devastating global food chains, with Vietnam among the worst hit in Southeast Asia.

"The production and com-

mercial registration of the vaccine is a historic event," deputy minister of agriculture and rural development Phung Duc Tien said Wednesday.

"We are confident to produce pig swine fever vaccine for domestic prevention and will also aim at export," he said.

However, officials did not give a timeframe for the vaccine's rollout or any indication of Vietnam's capacity to produce it at scale.

From 2020, Vietnamese researchers worked with United States scientists on the NAVET-ASFVAC job, Tien said.

He said the Agricultural

Research Institute of the US Department of Agriculture had "sent an official letter to the Department of Animal Health of Vietnam confirming that the NAVET-ASFVAC vaccine is safe and effective".

"The immunity length of the vaccine is six months," Tien said.

Five Vietnamese clinical lab trials "showed 100 per cent of vaccinated pigs were protected against toxicity in the laboratory", he added.

An official circulation licence for Vietnam would be issued Friday at a ceremony launching the job, the Department of Animal Health said.—AFP

#### International police bust 'FluBot' phone scam

POLICE in 11 countries have taken down a mobile phone scam dubbed FluBot that spread around the world via fake text messages, Dutch and EU police said on Wednesday. Dutch cybercops led an operation in May targeting the malware, which infects Android phones using texts which pretend to be from a parcel firm or which say a person has a voicemail waiting.

Hackers would then steal bank details from infected phones, which automatically sent messages to other mobiles

in the user's contact list, passing on the scam like a flu virus. "To date, we have disconnected ten thousand victims from the FluBot network and prevented over 6.5 million spam text messages," Dutch police said in a statement. The EU's police agency Europol said FluBot was among "the fastest-spreading mobile malware to date" and was "able to spread like wildfire due to its ability to access an infected smartphone's contacts."—AFP

Moe Kyaw, Midfielders Hlaing Bo Bo, Yan Naing Oo, Lwin Moe Aung, Htet Phyo Wai, Myat Kaung Khant, Maung Maung Lwin, Suam Lamang, Zaw Win Thein and Aung Naing Win and Strikers Win Naing Tun, Than Paing, and Aung Kaung Marn are participating for the Myanmar squad ahead of the Asian Cup Qualifiers.

## CONCACAF Champions League set for expansion from 2024

ELEVEN more teams will join an expanded CONCACAF Champions League from 2024 under a sweeping revamp of the competition unveiled on Wednesday.

CONCACAF, the governing body for football in North America, Central America and the Caribbean, said in a statement that the club tournament would increase from 16 to 27 teams after the 2023 tournament. Eighteen teams participating in the competition will come from North America, with as many as nine sides from the United States and Canada potentially able to qualify. Under the new format, 22 teams will play in 11 home-and-away first round games, with five other teams automatically advancing to the last 16.

The tournament will proceed as a home-and-away knockout tournament until the final, which will be played as a single game one-off fixture. —AFP

REAL Madrid on Friday demanded an explanation for the way fans were treated at the Champions League final last weekend and said authorities must take responsibility for the ugly scenes in Paris which the club said were “far removed from the values” of the sport.

In the statement published “in defence of supporters”, Ma-

drid asked why the Stade de France was chosen as the venue for the final against Liverpool and asked “who was responsible for leaving the fans helpless and defenceless.” Some Madrid fans have said they were victims of crime after the match on Saturday, with many reporting being assaulted and robbed outside the stadium.—AFP
