## Military columns participate in full-dress rehearsal for 76th Anniversary of Armed Forces Day Parade



Vice-Chairman of the State Administration Council Deputy Commander-in-Chief of Defence Services Vice-Senior General Soe Win is viewing the full-dress rehearsal for the 76th Anniversary of Armed Forces Day Parade, yesterday.

MILITARY columns, which will participate in the parade of the 76<sup>th</sup> Anniversary of Armed Forces Day that falls on 27 March, took part in the full-dress parade at Nay Pyi Taw parade ground yesterday morning.

Anawyahtar, Kyansitthar, Bayintnaung, Aungzayya, Hsinbyushin, Bandoola and Aung San columns led by Parade Commander Maj-Gen Soe Min

Oo marched into the parade ground on the parade agenda by singing marching songs in chorus to the accompaniment of the Tatmadaw military band. Together with Vice-Chairman of the State Administration Council Deputy Commander-in-Chief of Defence Services Commander-in-Chief (Army) Vice-Senior General Soe Win, Council members General Mya Tun Oo, Lt-Gen Soe Htut,

senior military officers including Chairman of the Leading Committee for Observance of the Armed Forces Day Chief of the General Staff (Army, Navy and Air) General Maung Maung Aye, Chairman of the Management Committee for Observance of the Armed Forces Day Commander of Nay Pyi Taw Command Maj-Gen Zaw Myo Tin and officials inspected full-dress rehearsal of

the military columns. After the parade, the Vice-Senior General attended to the needs in coordination with officials.

Officers and other ranks from Tatmadaw (Army, Navy and Air) and Myanmar Police Forces, female members, members of Navy Seals, the female member of special operation task forces, troop of heavy machinery corps from the Tatmadaw (Army and

Navy) and aircraft from the Tatmadaw (Air) participated in the parade rehearsal. Those members wore badges and uniforms used by the Myanmar Tatmadaw in successive eras from the independence struggle to 2020, holding military weapons and today's modern weapons used in successive eras for portraying silver, golden and diamond jubilee eras. — MNA ■

1. Outbreaks of arson fire happened at 18 factories that had registered at Hlinethaya, Shwelinpan industrial zone and Shwepyitha branches of Township Social Security Offices in Yangon Region at 1:30 pm on 14-3-2021, 2:00 pm on 15-3-2021 and 3:00 pm on 19-3-2021, leaving buildings and equipment of factories damaged.
2. A total of 2,229 male workers and 13,428 female workers, totalling 15,657, who insured at the Social Security Board, became jobless after outbreaks of fire as natural disasters. The Social Security Board will spend its fund on providing cash assistance which shall equal 40 per cent from the last premium fees they paid in accord with Section 31 (b) (ii) of the 2012 Social Security Law, and Rules 136 (b) by exercising authority stipulated in Section 100 of the law.
3. In conformity with the provisions of the second paragraph, employers or officials on behalf of the employers from factories and workplaces must apply for taking out the cash assistance of social security for insured workers at the township Social Security Offices from the date when the notification was released.
4. Releases described above come into force from the date when this notification was released.

## Noticeable points in filing complaints to Anti-Corruption Commission

1. Anyone may send information and complaints on matters related to corruption and wealthiness based on corruption to the commission or commission office or work committee, workgroup, preliminary security team or any investigation teams formed in line with this law or relevant governments or government organizations in accord with the prescribed rules.
2. Complaints must be directly sent to the commission but copies.
3. The complaint must comprise the name of the complaint sender, signature, copy of citizenship scrutiny card, full address and telephone number.
4. Important pieces of evidence such as eyewitnesses, documents, photos, audio files and video files can be attached to the complaints.
5. If one intentionally files complaints to cause grievance against or to discredit anyone, it is noticeable that action will be taken against them under Section 59 of the law.

## Yangon circular train resumes operation

MYANMA Railways has stopped operations, including Yangon circular train, for various reasons. Five RBE carriages resumed operation at 8:35 am from Insein railway station yesterday.

That circular train ran to Yangon railway station, Min-

galardon railway station and arrived back at Insein station at 11:50 am.

During this operation, the concrete sleepers, old rail track, stones, logs and barbed wire were found on the railway track between Gyogon and Thamine

Myothit stations, Thamine Myothit and Thamine stations, Kamayut and Hledan stations, and the crossroads of Kamayut and Ywarma Kyaung Lan stations, between Paywat Sake Kone and Okkalapa stations and in the compound of Insein DRC

locomotive station. The security forces, MR officials and local people collectively removed these roadblocks and the train successfully operated for the passengers.

The cases will be opened against the unscrupulous per-

petrators who made destructive elements at respective township police stations to take action under the law.

The MR is also making arrangements to resume the operations of circular trains daily as before.—MNA

## It is necessary to find out possible ways and means to reopen banks

ALTHOUGH not all banks have been reopened yet, instructions have been given to reopen banks by taking necessary security measures. Banks have agreed to operate in accordance with the monetary policies adopted by the State since they were established. In accordance with rules and regulations, action will be taken against banks that cannot reopen. It is necessary to find out possible ways and means to reopen banks. As violations of rules and regulations adopted by the State in dealings with foreign currencies and lending limits were found out in the scrutinization of banking operations, it is necessary for the central bank to take measures for routine banking operations.

## Myanmar Investment Commission (MIC) holds its regular meeting (2/2021)

THE Myanmar Investment Commission was reorganized on 4 March 2021 with nine members in accordance with Notification No. 30/2021 of the State Administration Council.

The Commission held its first meeting (2/2021) yesterday morning at Office No. 18, Of-

fice of the State Administration Council. Chairman of Myanmar Investment Commission Lieutenant-General Moe Myint Tun and members of the Myanmar Investment Commission participated in the meeting.

The meeting approved ten new projects in the communi-

cation service, manufacturing, hotel business, and electricity generation. The approved projects amounted to USD579.019 million, kyats 36.781 billion and 945 job opportunities are expected to be created.

At this meeting, the Region and State Investment Commit-

tees were reorganized in accordance with the Myanmar Investment Law to allow investment projects in the regions and states.

By the end of February 2021, the countries with the largest investment out of 51 countries/regions investing in Myanmar are Singapore, the People's Republic

of China, and Thailand. The electric power sector leads the list of most invested sectors out of 12 business sectors with 26.16% of total investment. This was followed by the Oil and Gas sector, accounting for 25.89% and the Manufacturing sector, accounting for 14.69%.—MNA

## Myanmar rejects and dissociates itself from the draft resolution tabled by the European Union during the 46<sup>th</sup> session of the Human Rights Council

A DISCUSSION on the draft resolution entitled "Situation of Human Rights in Myanmar" tabled by the European Union was held during the 46th session of the Human Rights Council on 24 March 2021 in Geneva. U Kyaw Myo Htut, Deputy Minister for Foreign Affairs of the Republic of the Union of Myanmar, participated in the discussion through a pre-recorded video.

During the submission of the draft resolution, the Deputy Minister underlined the factually and technically flawed facts mentioned in the resolution, the references on the reports which were not supported by credible evidences as well as the elements which could erode the ongoing domestic judicial mechanisms and which could impose

a threat and a direct challenge to the sovereignty of the country.

Furthermore, the Deputy Minister stated that Myanmar is consistently against the country-specific resolution which is politicized and unbalanced on a country. He added that the said

resolution would not contribute to improving rather worsening the situation on the ground, particularly to the developing and least developed countries. Therefore, the EU's draft resolution would not surely contribute to finding solutions to

overcome the challenges faced in Myanmar, but it would rather impose serious impediments on the efforts for bringing peace, stability, national reconciliation and development of the people of Myanmar. Moreover, he underlined that the sovereign right of

a country should not be intruded, rather be respected. In this manner, he stated that Myanmar rejects and dissociates itself from the draft resolution as a whole. China, Venezuela and Russia also dissociated themselves from the resolution. —MNA

## 23 new cases of COVID-19 reported on 24 March, total figure rises to 142,315

MYANMAR'S COVID-19 positive cases rose to **142,315** after **23 new cases** were reported on 24 March 2021 according to the Ministry of Health and Sports. Among these confirmed cases, **3,203 died**, **131,774** have been discharged from hospitals.—MNA

## MoHS discusses resumption of central-level hospital operations in Yangon, Nay Pyi Taw

THE Ministry of Health and Sports held the coordination meeting on resuming hospital operations in central-level hospitals in Yangon and Nay Pyi Taw yesterday morning in Nay Pyi Taw. At the meeting, Union Minister for Health and Sports Dr Thet Khine Win said most people have to rely on public hospitals. Medical superintendents and medical personnel play an essential role in serving people with necessary healthcare services. He said it is needed to maintain the medical professionals' dignity. The first and second wave of COVID-19 has been overcome despite the difficulties.

He added the announcement requesting medical professionals to return to work for the people. He said they could contact the Ministry's call centre, phone number and email address if they have trouble returning to

their work.

He said plans are underway to purchase and install advanced equipment required for treatment and diagnosis in public hospitals during the current financial year, adding that preparations must be

made to ensure that there is no shortage of necessary medicines and no oversupply/overdose of medicines.

The Union Minister called on making continuous efforts to prevent the third wave of COV-

ID-19 by the excellent coverage of COVID-19 vaccination in respective regions and states and said arrangements are being made to get the staff's necessary allowances, including dinner allowance for the night duty staffs in the

public hospitals.

He also urged the subject doctors, including the medical superintendents, to guide their staff in the right direction so that they do not go astray and hold meetings for the resumption of hospital operations and work together in unison public healthcare services.

Afterwards, Director-General U Sein Win of the Union Minister Office discussed matters related to financial and staffing. Acting Director-General of the Department of Medical services discussed hospital management and hospital equipment maintenance to resume the hospital operations.

The meeting was also attended by officials from the Department of Medical Services and Medical Superintendents of the central-level hospitals from Yangon and Nay Pyi Taw. —MNA

# 14 youths going to area of ethnic armed group arrested


ACCORDING to the information sent by a dutiful citizen that some youths who participated in the riotous protests would go to an ethnic armed group to attend the explosion course, security forces take more security measures especially in respective areas.

In so doing, security forces on duty at Zero Milepost in Hlegu Township at about 11 am on 22 March inspected KYN/GG-5378 Probox driven by Hla Win, 32, son of U Khin Nyunt of Taunggyi Village in Taungzun and KYN/GG-4388 driven by Thaug Dan Soe, 47, son of U Kyaw Hlaing from Chaung Pyan Village in Bilin Township, driving from Yangon to Hlegu. Chit San Maung, 24, son of U Than Tun Aung of Phayagone Ward, Thanlyin Township, Nyunt Nyan Paing, 23, son of U Win Nyunt of Dawei Street in Ward 25 of Dagon Myothit (South) Township, Thiha Soe, 21, son of U Soe Myint of Hleseik Village in Dala Township, Shine Myat Aung, 23, son of U Win Naing of No 198, Ward D, Thingangyun Township, Thurein Lin, 24, son of U Yin Tun of Maha Myaing KanU Kyaung Street, Kyaikdaewa Ward, Thanlyin Township, Min Thu, 32, son of U Kyaw Myint, Tarwa-Kanyinbin Village, Thanlyin Township,

Ye Myat Shwe, 29, son of U Shwe Hla, Room-206, Building-3, Maha Bandoola Housing Complex C, Ward 17, Dagon Myothit (South) Township and Kyaw Swar Oo, 31, son of U Aye Thaw of Nweni Street in Ward 54, Dagon Myothit (South) Township were found abroad the cars. As they would go to the area of an ethnic armed group via Bilin Township, security forces on behalf of their families detained those youths not to be victims of politics and armed groups.

Based on further information, Wai Yan Min Oo, 31, son of U Win Cho of U Ponnya Street in Ward 16 of Hlinethaya Township, Kyaw Lin Tun, 47, son of U Kyaw Aye of Thone Hteik, Bogyoke Street, 1/12 Ward, Hlinethaya Township and Zaw Lwin, 44, son of U Thaug Kyi of Mahawthada Street in Ward 1, Hlinethaya Township were also detained together with YG-N/7Q-2854 Creta near the old bus terminal of Htauk Kyant in Mingalardon Township at 12:30 pm on 22 March.

According to the confessions of the youths, they are NLD members. They participated in the protests in Yangon City. Due to the incitement of Thet Paing Shein and Aung Pyae Sone from the group, they agreed to attend

the course of explosion in the area of an ethnic armed group. They were arrested by security forces while gathering at Zero Milepost.

A vehicle wishing to pick them up returned to Bilin. In the searching process, security forces arrested driver Nay Lin Aung, 35, son of U Khin Zaw of Kawkaduk Village in Bilin Township, together with GG-3513 Pro-

box. Nay Lin Aung confessed that he transported those who evaded from Yangon due to various reasons to Myawady by taking transport charges because of connection created by Hla Min, 40, of Laykikkaw Myothit in Myawady Township. According to confessions of detainees, measures are being taken to arrest Hla Min, 40 of

## Handguns and ammunition used in riots confiscated in Bilin, Mon state

ACCORDING to a Myanmar Police Force statement, handguns and ammunition to be used in the riots were confiscated

along with the suspects yesterday morning in Bilin Township, Mon State. Upon the information re-

ceived of Naing Win (a) Kala, 28, son of U Pyi Thein, carrying handguns, the security forces raided the house of 26-year-old Aung Ko Ko Myint, son of U Thein Han, a resident of Thida Auk Street, Kanthayar ward in Bilin Township and one handgun that was 4 feet 5 inches long; a wooden bar about 2 feet 6 inches long; one steel spring, about 3.5 inches long; one piece of plastic pipe used to make an 8-inch pistol were confiscated.

The police forces continued searching the house of Tun Zaw Oo, 28, son of U Tin Oo, on the street and confiscated one handgun and 64 handmade ball ammo.

Naing Win (a) Kala and Tun Zaw Oo, who were armed with handguns, have been arrested and are being investigated for legal action and plans are underway to arrest Aung Ko Ko Myint, who is on the run. — MNA

## Punishments sentenced to detainees involved in riots in Shwepyitha

THE military tribunal under the martial law on 22 March sentenced 20 years' imprisonment with labour each to Min Htet (aka) Lin Htet Paing, son of U Than Tun and Hla Win, son of U Sein Maung, who were arrested in riots in Shwepyitha Township of Yangon Region, under Article 436 of the Penal Code for setting fire to the building of Solamoda garment factory on 16 March and three years' imprisonment with labour each to Aung Tun (aka) Hsa Mi, Aung Thet Paing (aka) Pi Chay and Win Ko Ko under Article 404 of the Penal Code for buying materials from five unknown persons who were believed to steal these materials from Myanmar Hong Pong Mechanical Electrical

Engineering Co Ltd Factory on 14 March and accepting these materials without innocent attitude. Order of martial law was imposed on 14, and 15 March as garment factories and basic education high schools were set on fire in Hlinethaya, Shwepyitha and Dagon Myothit (North, South and Seikkan) townships in Yangon Region and hindrances were committed to firefighting. Twenty-three kinds of crimes to be heard by military tribunals were announced in the townships involved in the imposition of martial law order. Military tribunals will be formed to effectively and rapidly take action against those law-breakers. — MNA

- The Union Election Commission has inspected the withdrawal/receipt/use/remaining of ballot papers used for Pyithu Hluttaw Election of Yedashe, Ottwin and Pyu townships in Bago Region, together with the respective township election sub-commission, head of police force, Immigration and Population and administrator according to the Hluttaw Election Law Section 53.
- According to the ground inspection, a total of 536 polling stations of these three townships took out 571,508 ballots and used 347,347. It left 211,271 ballots instead of 224,161. The difference was 29,622 ballots and it found 16,732 extra ballots. The extra/shortage ballots and illegal extra ballots were found at respective poll stations. The extra ballots were found and so the ballots were illegally printed. The findings in each township are as follows:

# As Covid rages, world risks losing TB gains

IN the year since Covid-19 flipped the world on its head, diagnosis and treatment of another serious lung disease -- tuberculosis -- has plummeted, leaving experts fearful that progress in tackling that pandemic will be lost.

Tuberculosis is treatable and easily diagnosed yet until Covid-19 emerged it was the world's biggest infectious killer, leading to 1.4 million deaths each year and infecting more than 10 million people.

While TB has been with humans for millennia, the progress towards eradicating this preventable disease has been painstaking, with the overwhelming majority of cases occurring in developing nations.

In the run-up to World Tuberculosis Day on Wednesday, the Stop TB Partnership warned that lockdowns and healthcare interventions prompted by Covid-19 had seen a 23-per cent drop in TB treatment and diagnosis.

That essentially sets the world 12 years back in its fight to eradicate the global killer.

"Twelve years of impressive gains in the fight against TB, including in reducing the number of people who are missing from TB care, have been tragically reversed by another virulent res-

piratory infection," said Lucia Ditiu, executive director of the Stop TB Partnership.

"In the process, we put the lives and livelihoods of millions of people in jeopardy."

**Worse than feared**  
At the start of the pandemic, modelling by Johns Hopkins University showed that a three-month lockdown followed by 10 months

of health service disruption would lead to an additional 6.3 million TB cases by 2025.

In the same period, 1.4 million people would die from the disease, the model showed.

Experts now acknowledge the situation is far worse than the one envisaged in the Johns Hopkins' simulation.

Statistics from the nine high-

est incidence countries -- Bangladesh, India, Indonesia, Myanmar, Pakistan, Philippines, South Africa, Tajikistan and Ukraine -- showed TB diagnosis and treatment has already declined by a total of one million people.

And new studies from India and South Africa shows that people suffering with TB are three times more likely to die if infected

with Covid-19.

"The effects of Covid-19 go far beyond the death and disease caused by the virus itself," the World Health Organization's Director-General Tedros Adhanom Ghebreyesus said this week.

"The disruption to essential services for people with TB is just one tragic example of the ways the pandemic is disproportionately affecting some of the world's poorest people, who were already at higher risk for TB."

Jose Luis Castro, president and CEO of global health organization Vital Strategies, told AFP that the impact of Covid-19 on TB would be felt "for a long time to come".

"Covid-19 has demonstrated just how interconnected we all are," he said.

"No one is safe until we are all safe. We can see our fragility and vulnerability to a deadly virus that is very, very easily passed from person to person. That's a new experience for most people."

**'Abysmal funding'**  
According to WHO figures there are currently over 75 candidate Covid-19 vaccines either on the market or in development.

This time last year, there were none.

The Stop TB partnership says

that while there is a newer TB vaccine in the works, at current funding levels it won't come online until 2027 at the earliest.

By that time, millions more will have died.

Castro said that funding towards a new TB vaccine currently stands around \$100 million -- one tenth as much as is given to HIV vaccine research.

"We will never develop a pipeline for effective TB vaccines with the abysmal current level of funding," he said.

Thokozile Phiri Nkhoma, a Stop TB Partnership board member and community representative, drew the comparison between the world's response to two distinct respiratory illnesses.

"After less than a year, a vaccine was developed and is now being deployed to help contain and hopefully end Covid-19," she said.

"But although TB has been around since the time of the pharaohs, the only approved vaccine is 100 years old and doesn't fully work. First-line TB treatment is several decades old and drug resistance is on the rise.

"The millions of people with TB who are not found and treated remain at risk of spreading the disease."

# 1 in 3 Covid survivors suffer long-term health issues: review

AT least one in three patients hospitalized with Covid-19 suffer long-term health issues including multiple organ problems and deteriorated mental health, according to a review of studies looking at the lasting impact of the disease.

Published in the journal Nature Medicine on Monday, the review looked at the frequency of symptoms among Covid "long-haulers", the most common of which include fatigue, shortness of breath, anxiety, depression, and post-traumatic stress disorder.

Authors of the research said the data pointed to an underappreciated health emergency that governments needed to study more closely and find ways to manage.

"Given the millions of people infected by SARS-CoV-2 globally, the long-term cost on physical, cognitive and mental aspects of health still remain to be seen,"

lead author Kartik Sehgal, a medical oncologist at Boston's Dana-Farber Cancer Institute, told AFP

"We may be capturing only the tip of the iceberg."

While severe Covid-19 infects patients' lungs -- leaving many with long term breathing issues -- studies have shown that the virus also attacks other organs, leading to a variety of complications including cardiovascular illness and chronic inflammation.

Sehgal and colleagues reviewed nine long-term studies from Europe, the United States and China and found that several patients reported multiple organ problems months after they were discharged from hospital.

Overall, they found that 30 per cent of patients studied reported at least one symptom, such as fatigue, shortness of breath and psychiatric conditions.

One study in Italy of 143 pa-

tients found that nearly 90 per cent reported lingering symptoms 60 days after they recovered from initial Covid-19 infection.

The most common symptoms were fatigue (53.1 per cent), shortness of breath (43.4 per cent), joint pain (27.3 per cent) and chest pain (21.7 per cent).

In total, more than half of patients experienced multiple symptoms two months after leaving hospital.

Three studies from France, Britain and China showed that between 25-30 per cent of patients reported sleep disturbances weeks after recovering from Covid-19.

And approximately 20 per cent of patients had reported hair loss, according to results from multiple studies.

**'Medical needs don't stop'**  
The results regarding mental health were perhaps equally concerning.

In a cohort of 402 survivors in

Italy one month after they were hospitalised, 56 per cent tested positive for at least one psychiatric condition such as PTSD, depression or anxiety.

The authors said that around 30 percent of patients had developed PTSD after being hospitalized with Covid-19.

"It is important to not forget about the mental health effects of long-Covid-19, while taking care of the physical symptoms, as they can be easily missed," said Sehgal, who is also an instructor at Harvard Medical School.

The researchers called for further investigation into

long-Covid, and the wider establishment of clinics to treat people with lingering, life-altering symptoms.

Sehgal said he hoped the research showed that simply surviving Covid-19 is not necessarily a satisfactory health outcome.

## Cherry ferry boats run as usual for convenience of commuters

YANGON (Pansodan-Dala) ferry boat service is the only transport option for the local people from Southern Yangon—Dala, Twantay, Kawhmu and Kungyangon townships to link with the commercial hub Yangon. The number of passengers has been dropping significantly since the outbreak of COVID-19. Cherry ferry boats are operating as usual for the convenience of the passengers, according to the Inland Water

Transport (IWT) (Delta Division). “Earlier, the Pansodan-Dala ferries were daily packed with over 30,000 commuters. After COVID-19, the declining number of ferry commuters rendered the ferries running less frequently. However, the ferry service has not stopped for the convenience of the passengers. During the Thingyan festival, the ferries will be running daily with a new schedule,” said U Hla Win Naing,

the assistant general manager from IWT Delta Division.

The cherry ferries transported about 5,233 commuters on 19 March, 3,771 commuters on 20 March and 4,025 commuters on 21 March.

Although the number of passengers has declined recently, the ferries provide their transport services with 35 routes on weekdays and 22 routes on weekends for the passengers.

Besides, the Yangon River is yearly covered with fog in March. So, the ferries have to wait until the vision is clear.

Before the pandemic outbreak, the ferry service has been running 46 times a day between 5:30 am and 9:30 pm for over 30,000 commuters approximately. The ferry service is also generating an income of over K3 million daily.

Cherry boats allow the

monks and nuns to ride free of charge. The ferries collect only K 100 per local passenger and K 4,000 per foreigner passenger.

Japan International Cooperation Agency (JICA) donated and handed over the three cherry ferries, passengers’ W/Cs and two jetties in Dala Port on 15 November 2014. It is one of the crowded places in the city. — Naing Lin Kyaw (IPRD)/GNLM

## Security forces seize homemade weapons

THE security forces conducted an investigation to seize the riot equipment and homemade arms. The police arrested Maung Mya, son of U Than Dein, who lives in Aung Thabyay street in No (9) Ward of Lashio in the evening of 23 March together with homemade arms including air guns, gas bottle, catapults and marbles.

Similarly, the security forces seized iron shields, wooden shields, fibre shields and fibre hats from the back alley of Dhamma Seindar street, Ma Hlwa Gone street and Awbar street of Tamway township on the morning of 23 March while other shields and wooden sticks were found in the building of Friday soon donation team located at the corner of Myo Thit 2<sup>nd</sup> street and Kyauk Yay Twin street in the evening.

The security forces also examined a man identified as U Than Zin Win, son of U Win Maung, who lives in South Okkalapa Township, in front of KBZ bank near Kyaikkasan and Banyar Dala streets and found incitement materials to commit riots, money collecting and cash assistance evidence in his phone and so he was detained.

Moreover, the security forces arrested Kyaw Lin Soe (aka) Kalar Gyi, son of U Aye Soe in War Taw Soon Village-tract in Ayeyawady Region together with his created arms. They also arrested Kyaw Thet Aung (aka) Thet Aung, son of U Kyaw Aye from Kyaung Shar Village, together with jingalis and pieces of vinyl.

They also seized riot materials and equipment, including

pieces of vinyl at the house of Ko Ko Oo, who lives in Myaungmya township, and jingalis about five ft from the Amyaung village administration office of Pyapon, and they arrested Aye Aung, son of U San Tin his workplace in Dedaye Township together with spears and other riot-related materials.

The security forces also raided Punna Gone Village in Shwabo Township of Sagaing Region according to the tip-off that the

violent people conduct training for 200 villagers. Then, they detained U Hlaing Gyi, aged 48, son of U Poe Phu from that village and U Aung Thein, aged 52, son of U Tin Sein from Seik Khum Village, together with riot arms.

Moreover, the security forces arrested Maung Maung Lwin, son of U Net and owner of Metta Lwin Pyin Gas Sales, together with riot equipment and arms in Chin State, and Maung Kyar Ht-

war, son of U Kyi Nyo from Magway Region, Wai Linn, son of U Ba Kyi and Zin Ko, son of U Han Win from Hantharwady Village, Ma Myat Nwe Win, daughter of U Htay Shwe from Myoma Taung Gone Ward were also arrested together with their homemade weapons.

Similarly, the security forces seized crossbows, knives, axe, pieces of vinyl bearing CDM letters at the house of Zaw Gyi, son

of U Aung Tun at No (2) Ward of Ohn Taw Ward in Taungdwingyi. They arrested five men, including Htay Nyunt Hlaing, son of U Sit Tol. They were having meals at Mya Myint Mo restaurant beside Myo Thit road and the catapults and knives.

The police will take action against those arrested together with homemade weapons. — MNA

## Terrorists attack Road Transport Administration Department by firebomb in Insein



TERRORISTS attacked the Road Transport Administration Department with a firebomb in Insein Township, Yangon Region, according to the Statement of the Myanmar Police Force.

The event happened in the early morning yesterday, around 4:05 am. Two men from a Land Cruiser car threw the firebomb for no reason to the department situated on Insein Road, Gyogon ward (west), Insein Township and drove towards Mayangon Township.

The fire was extinguished at 4:10 am with the destruction of one hand-washing basin, three billboards, two pieces of vinyl and one trash can inside the RTAD.

A joint team of security forces inspected the scene as soon as the information received and found eight cans of Myanmar Beer and three kerosene bottles used in the shooting. The police are investigating to take legal action against those who used firearms for no reason.—MNA

# Sale of toddy-palm chair declines in Kyaukpadaung



Dy-palm chairs sold well. How ever the sale of toddy-palm charm has dropped significantly this year because there are few local tourists.

THE Indaw Kyay village in Kyaukpadaung Township is being engaged in toddy-palm chair making business.

The local people are manufacturing many toddy palm chairs. This year, the toddy-palm chair's demand has dropped significantly, said U Win Naing, a toddy-palm chair maker.

The Indaw Kyay village is manufacturing toddy-palm chairs, palm tables and palm boxes. The village is located on Kyaukpadaung-Meiktila road, and it is five miles far from Kyaukpadaung town.

The village collects the

toddy-palm yearly and is making many toddy-palm chairs. They are generating family income from selling the toddy-palm chairs. The toddy-palm chairs from Indaw Kyay village are shown on the road.

The local people visiting Bagan-Nyaung-U archaeological site stop their car and buy the chairs when they go back to their place.

Last year, the toddy-palm chairs sold well. However, the sale of toddy-palm charm has dropped significantly this year because there are few local tourists.

The palm chair makers are buying the branches of toddy palm for K50 per one to make the toddy-palm chairs.

Other materials such as hammers and nails are needed to make the toddy palm chairs. They sell a chair for K4,500 for a normal chair and K6,000 for a reclining one.

The price of toddy boxes is dependent upon the size and the design.

This year is one of the bad sales of the toddy palm chairs in Indaw Kyay village in Kyaukpadaung Township, U Kyaw Kyaw Naing explained. — Ko Htein (KPD)/GNLM

## Myawady border trade rises above US\$600 mln as of 12 March

THE border trade through Myawady between Myanmar and Thailand climbed up to US\$600.5 million between 1 October and 12 March in the current financial year 2020-2021, reflecting an increase of \$50.8 million as against a year-ago period.

The trade through the Myawady border stood at \$549.7 million in the corresponding period of the last FY 2019-2020.

Myawady-Maesot border trade has remained mal, although Thailand ordered restrictions in Maesot, according to the Myawady Chamber of Commerce.

Myawady border trade did not halt owing to the restriction orders by Thailand. Myanmar trucks cannot enter Maesot, but trucks from Thailand come and pick up the goods at Myawady post, the chamber stated.

"We experienced trade suspension via Myawady in October 2020. The halt in trading undoubtedly harms the traders and truck drivers from both sides. It is good that trade does not stop at present," said a trader from Myawady.

At present, the Myawady border does not have trade barriers except transaction problem triggered by the shutdown of the private banks, said U Min Khaing, chair of Myanmar Corn Industrial

Association.

"Trade is regularly flowing in and out of the country. What a problem is that we cannot claim income through a legitimate financial market during the meantime.

Now, the trade is carried out through hundi operators. The closure of formal financial markets except the state-owned banks render the cash flow difficulties," U Min Khaing said.

Hundi business is weak to protect transactions and less secure. Additionally, they charge too much for services, U Min Khaing stressed.

Myanmar is currently shipping about 5,000-6,000 tonnes of corns to Thailand through the Myawady border every day.

Myanmar is allowed for corn export between 1 February and 31 August with Form-D, under zero tariff.

Myanmar corn exports were exempted from tax between February and August. Thailand imposed a 73-per-cent tax on corn import to protect their growers' rights if the corns are imported during the corn season of Thailand, as per the notification of the World Trade Organization regarding corn import of Thailand.

The border trade between Thailand and Myanmar between

1 October and 12 March in the current FY plunged to US\$1.57 billion from \$1.9 billion registered in the year-ago period, according to data from the Ministry of Commerce.

During the last year, Myanmar has increasingly exported corns to Thailand through the Myawady border gate.

Myanmar's corn exports to Thailand significantly soared to over 1.2 million tonnes through border gates between Myanmar and Thailand during October and May period in the 2019-2020FY, an official of the Ministry of Commerce said.

There are seven border posts between Myanmar and Thailand, Tachilek, Myawady, Kawthoung, Htikhee, Myeik, Mawtaung and Maese.

The majority of the border trade with Thailand is conducted via Myawady.

Myanmar primarily exports corn, natural gas, fishery products, coal, tin concentrate (SN 71.58 per cent), coconut (fresh and dry), beans, and bamboo shoots to Thailand. It imports capital goods such as machinery, raw industrial goods such as cement and fertilizers, consumer goods such as cosmetics and food products from the neighbouring country. — KK/GNLM

## Domestic gold price up by K80,000 within three weeks

ACCORDING to the domestic market, the price of precious pure gold metal increased by K80,000 per tical (0.578 ounces, or 0.016 kilograms) in the past three weeks.

The price stood at only K1,302,000 per tical on 4 March, and then, it tremendously soared to K1,385,000 per tical on 23 March, the gold traders said.

However, the rate has not reached the maximum of above K1,400,000 per tical registered in February.

The international gold price was pegged at around US\$1,700-1,736 per ounce in March, despite a sharp rise in the domestic market. In January 2021, the gold price was ranged between the minimum of K1,316,000 per tical (28 January) and the maximum of K1,336,000 per tical (6 January). It reached an all-time high of K1,410,000 per tical on 3 February and hit the minimum of K1,340,000 per tical

on 2 February.

According to gold traders, the local gold reached the lowest level of K1,310,500 (2 September) and the highest level of K1,314,000 (1 September). In October, the rate ranged between K1,307,800 (30 October) and K1,316,500 (21 October). The rate fluctuated between the highest of K1,317,000 (9 November) and the lowest of K1,270,000 (30 November). In December, the pure yellow metal priced moved in the range of 1,280,000 (1 December) and 1,332,000 (28 December).

With global gold prices on the uptick, the domestic price hit fresh highs last year, reaching K1,000,000 per tical between 17 January and 21 February, crossing K1,100,000 (22 June to 5 August), climbing to over 1,200,000 (7 August-4 September), and then reaching a record high of K1,300,000 on 5 September 2019. — NN/GNLM

# Congress to grill US internet giants over disinformation

THE heads of Facebook, Google and Twitter will testify before Congress Thursday on disinformation, following a tense US election, Capitol attack and rise of a new administration seemingly intent on doing battle with Big Tech.

The remote video hearing will be the fourth for Facebook's Mark Zuckerberg and Twitter's Jack Dorsey since last July and the third for Google's Sundar Pichai: evidence of how the companies' vast economic and political power has landed them squarely in the crosshairs of Democrats and Republicans alike.

"Whether it be falsehoods about the Covid-19 vaccine or debunked claims of

election fraud, these online platforms have allowed misinformation to spread, intensifying national crises with real-life, grim consequences for public health and safety," said the heads of the two Congressional subcommittees holding the hearing, in a statement.

A recent backlash against the tech behemoths, which dominate key economic sectors, has intensified as their influence has grown during the coronavirus pandemic.

"I don't expect more than theater" at the hearing, said analyst Carolina Milanesi of market research firm Creative Strategies. —AFP ■

# Netanyahu's Likud in lead following Israel vote: exit polls

PRIME Minister Benjamin Netanyahu's Likud party was on track to win the most seats in Israel's fourth election in two years, exit polls showed Tuesday, but he was not guaranteed a governing majority.

Initial projections from Israel's three main broadcasters gave Likud between 31 and 33 seats in the Knesset, far outpacing nearest rival Yesh Atid, a centrist party projected to take between 16 and 18 seats.

Likud's tally, along with the support earned by its right-wing religious allies, gives the pro-Netanyahu bloc an estimated 53 or 54 seats, according to the initial projections which are subject to

change. But 61 seats are required for a majority in the country's 120-member parliament, the Knesset. The parties opposed to

Netanyahu were projected to win 59 seats. The surveys indicate Netanyahu could secure a right-wing majority coalition with sup-

port from his former protege and defence minister Naftali Bennett, leader of the religious nationalist Yamina party.—AFP ■

## Fujimori plans to 'save Peruvians' if elected president

DESPITE facing a potential 30-year prison sentence for corruption, Keiko Fujimori is determined to follow in her father's footsteps and claim Peru's presidency at the third attempt.

The 45-year-old, who failed already in 2011 and 2016, says she wants to "save Peruvians from death and hunger" if successful this time around in the April 11 general election.

But she'll have to stay out of prison to do that, and two weeks ago prosecutors said they would seek a 30-year jail term for Fujimori, who is accused of accepting \$1.2 million in illicit funding for her previous presidential bids.

She has already spent 16 months in pre-trial detention and since her release by a judge in

May 2020 her thirst for power has not abated.

"My intention is to save Peruvians from the death and hunger that is happening in our country," Fujimori told AFP from her home in an upmarket neighborhood east of the capital Lima.

She feels the country's current pandemic-inflicted travails are similar to the situation her disgraced father Alberto Fujimori faced when he took power in 1990.

Peru has suffered more than 50,000 deaths from Covid-19 and registered over 1.4 million infections amongst the population of 32 million.

"The health and economic tragedy reminds me of the years of terrorism and economic crisis. It's a very dramatic situation and

Fujimorism has shown it has the ability to take our country forward in such difficult moments," said Keiko Fujimori.

During a decade in power,

Alberto Fujimori was credited with solving Peru's twin problems of hyperinflation and the terrorism wrought by the far-left Shining Path rebels.—AFP ■

## Massive container ship blocks Suez Canal

A giant container ship has blocked the Suez Canal in Egypt, tracking websites showed Wednesday, bringing marine traffic to a shuddering halt along one of the world's busiest trade routes.

A photo posted Tuesday showed the Taiwan-owned MV Ever Given, a 400-metre- (1,300-foot-)long and 59-metre wide vessel, lodged sideways and impeding all traffic across the waterway as excavation trucks struggled to dig it out.

Shipping website Vessel Finder said the ship was bound for Rotterdam in the Nether-

lands, and it is unclear why the supertanker has stopped moving.

Over 150 years old, the Suez Canal is one of the world's most important trade routes, providing passage for 10 per cent of all international maritime trade.

Nearly 19,000 ships passed through it last year with a total tonnage of 1.17 billion, according to the Suez Canal Authority (SCA).

It has been a boon for Egypt's struggling economy in recent years, with the country earning \$5.61 billion in revenues from the canal last year.—AFP ■

### NEWS IN BRIEF

#### N. Korea fired two missiles in first test under Biden: US, South

NORTH Korea fired two short-range missiles just days after a visit to the region by the top US defence and diplomatic officials, but President Joe Biden said they were not a serious provocation.

It was nuclear-armed North Korea's first launch since his inauguration -- Pyongyang has been biding its time since the new administration took office, not even officially acknowledging its existence until last week.

Washington is reviewing its approach to Pyongyang after a tumultuous relationship between president Donald Trump and North Korean leader Kim Jong Un, which went from trading insults and threats of war to a diplomatic bromance and several meetings, but made no substantive progress towards denuclearization.—AFP ■

#### Archives uncover forgotten names of Auschwitz inmates

EWA Bazan, an archivist at the Auschwitz-Birkenau Museum, compares her work on newly-accessible records to piecing together a "puzzle" that is revealing new names and stories of the Nazi death camp's inmates. Ninety percent of the notorious camp's files were destroyed by its guards before they fled but a recently completed two-year collaboration with the Arolsen Archives in Germany is bringing new information to light.

"We didn't know what to expect when we started the project," Bazan told AFP, barely hiding her emotion.

The patient, humble research carried out by Bazan and her colleagues has uncovered the previously unknown identities of an estimated 4,000 camp inmates as well as information about 26,000 others.

Currently, the identities of around 300,000 inmates out of the 400,000 estimated to have been held at the camp are known.—AFP ■

# India opens up faltering vaccine drive to all over-45s

INDIA announced Tuesday it will open its vaccination drive to all over-45s from April 1 in a bid to boost its massive but flagging inoculation drive as infections rise.

India has so far vaccinated nearly 50 million people but the programme to inoculate 300 million people by the end of July is behind schedule, experts say.

Until now only "frontline" workers in healthcare and other areas, together with people over 60 and those over 45 with co-morbidities, have been eligible for either the AstraZeneca vaccine or a homegrown Bharat Biotech shot.

"Following scientific and (Covid19) task force advice, the cabinet today decided to open vaccinations for everyone over 45 years from April 1," Prakash Javadekar, information and broadcast minister, told reporters.

Javadekar also announced that state governments had been directed to provide the second dose four to eight weeks after the first, compared to an earlier regime of four to six weeks.

Experts say that many people are reluctant to get vaccinated for a variety of reasons including safety concerns and apathy about the pandemic after a sharp fall in infections since September. Prime Minister Narendra Modi, who was vaccinated on March 1, has issued several appeals in recent days asking "all those who are eligible to take the vaccine."

"Together, let us make India Covid-19 free!" he said on Twitter earlier this month.

The number of infections has been rising again in recent weeks, and several regions have been reimposing restrictions on gatherings and activity. —AFP ■

## Overwhelmed Miami Beach extends spring break curfew

THE US city of Miami Beach, overrun by crowds of spring break tourists throwing Covid caution to the wind, has extended a state of emergency to stem the chaos – drawing accusations of unfairly tough tactics against mostly Black revelers.

Video and photos on social media show half-naked women twerking on the roofs of cars, men offering them wads of bills and a crowd of tourists huddled side by side, dancing and passing bottles from hand to hand – plus brawls, gunshots fired in the air and stand-offs with police.

"A lot of times when spring breakers come, whether they're black, white or whatever, there is some sort of anarchy," Retha Boone-Fye, program director for the Black Affairs Advisory Board of Miami-Dade County, told AFP, saying the city had every right to expect visi-

tors to behave. "Where we part ways is the way that the black visitors are dealt with," she said.

On Saturday city manager Raul Aguila imposed a nighttime curfew on the most touristy streets of South Beach, the centre of the party, and ordered the closure of the three bridges that connect the island with Miami from 10:00 pm to 6:00 am.

Commissioners Sunday authorized Aguila to keep the emergency in place until April 13, the end of the annual university vacation period that draws thousands of students each year – but the emergency measures, valid Thursday through Monday, are not easy to implement.

On Saturday and Sunday nights, there were images of dozens of police cars trying to evict the crowd of revelers, sometimes throwing pepper spray projectiles. —AFP ■

## Gym and nutritionists: inside South Korea’s T1 eSports empire

A Nike-sponsored gym, support staff including nutritionists and English language classes are all part of the set-up at T1, one of the world’s top eSports organizations, where around 70 gamers are looking to emulate its highest-profile member, League of Legends giant Faker.

Explosive growth has turned competitive video gaming into an increasingly professional sport, with a youthful, ever-growing fan base that appeals to sponsors and ad-

vertisers.

Players — mostly in their 20s or even teenagers — can attract a global following to rival stars in traditional sports, with the best making millions of dollars in salaries and prize money.

South Korea is a leading power in eSports and in a brand new, 10-storey building in Seoul’s expensive Gangnam district, dozens of T1’s professional and budding gamers train, following a routine similar to mainstream sports. “We

have a gym, a cafeteria, chefs... everything that these young players need to perform their best,” said John Kim, the organisation’s chief operating officer. The routine is intense: around 10 hours a day with coaches and trainers, strategising and polishing their skills for the next match.

Promotional photos show the team in uniform, half of them in glasses and most with identical pudding-basin haircuts. —AFP ■

## Bale expects Real return after Spurs loan

GARETH Bale said Tuesday that he plans to resume his Real Madrid career once his loan at Tottenham expires at the end of this season.

Wales forward Bale returned for a second spell with Tottenham in September after being frozen out by Real manager Zinedine Zidane.

He has endured a difficult time back in the Premier League, plagued by fitness issues, inconsistent form and a dispute with Tottenham manager Jose Mourinho over his readiness for an FA Cup tie at Everton. The 31-year-old’s Madrid contract runs until the end of the 2021-22 season and

he revealed he will head back to Spain after the delayed Euro 2020 this summer. “There’s no distraction for me,” Bale told a press conference. “I think the main reason I came to Spurs this year was to play football first and foremost.

“Going into the Euros I wanted to be match-fit. The original plan was to do a season at Spurs and after the Euros still have a year left at Real Madrid.

“My plan is to go back, that’s as far I have planned.” Mourinho said earlier this month that Bale’s future beyond the end of the season was a matter for Real. —AFP ■

## Man City to install rail seats that could become safe-standing area

MANCHESTER City are to install more than 5,000 rail seats at the Etihad Stadium in order to take advantage of any potential change in the law to allow safe standing.

The work will take place before the start of the 2021/22 season, meaning there will be no disruption for supporters, who by then are expected to be able to return to matches after the coronavirus lockdown.

Rail seats can be folded

away and locked in position to create a safe-standing area with barriers.

All-seater stadiums have been mandatory in the top two tiers of English football since the 1994/95 season following recommendations on safety made in the Taylor Report.

The report was commissioned after the 1989 Hillsborough disaster, which resulted in the deaths of 96 Liverpool fans after crushing on the

standing-only terraces before their FA Cup semi-final against Nottingham Forest.

But there has been a renewed push in recent years for safe standing to be brought back.

City, poised to win a third Premier League title in four seasons, believe introducing the rail seats now will enhance safety in an area already affected by persistent standing on matchdays. —AFP ■
