Plan underway to reopen basic education schools in 2021-2022 academic year: Vice-Senior General



State Administration Council Vice-Chairman Vice-Senior General Soe Win meets officers, other ranks and families at the gymnasium of Taunggyi Station yesterday.

VICE-CHAIRMAN of the State Administration Council Deputy Commander-in-Chief of Defence Services Commander-in-Chief (Army) Vice-Senior General Soe Win met officers, other ranks and families at the station gymnasium in Taunggyi yesterday.

Also present were Daw Than Than Nwe, wife of the Vice-Senior General, Lt-Gen Aung Zaw Aye from the Office of the Commander-in-Chief (Army) and wife, senior military officers from the Office of the Commander-in-Chief (Army, Navy and Air), Commander of Eastern Command Brig-Gen Ni Lin Aung and wife, officers, other ranks and families

of Taunggyi Station.

At the meeting, the Vice-Senior General explained efforts of the Tatmadaw to pave the way of multiparty democracy starting in 1988, drawing of the Constitution (2008) and approval of it with support of the entire nation, no participation of NLD with the boycott in the multiparty democracy election in 2010 in accord with the Constitution, endeavours of the government led by President U Thein Sein for improvement of political, economic and social affairs for successfully walking on the multiparty democracy, amendment and revocation of some provisions of the election

law for opposition party NLD to join the multiparty system with organizational efforts, and full cooperation of the Tatmadaw with successive governments holding up the national politic concepts.

Moreover, the Vice-Senior General clarified efforts made by the government led by President U Thein Sein amidst political crises, pressures imposed by foreign countries and armed conflicts, attempts of NLD in taking dissatisfaction as advantages in canvassing for the 2015 election with slogan: time to change as incentive for the people, in ruling the country with formation of the government after winning

the election, non-implementation of pledges and promises in the canvassing of NLD, drawing and enactment of the State Counsellor Law despite prohibition as the form of democracy bullying, appointment of the State Counsellor and placing the post of State Counsellor between the president and vice-president in release of State protocol, no completion of political and economic measures, fading of language and religion in its wrong concept in the religious affairs, use of various organizations for the people to misunderstand the Tatmadaw, encroachment on State's independent management with

appointment of foreign advisers, financial loss of the State, no support of the patriotic people to NLD for declining of State's culture, patriotic spirit and economy, staging of no vote campaigns, and anxieties of NLD for winning the 2020 election.

Furthermore, the Vice-Senior General explained the request of the candidates who faced loss in the election to the Tatmadaw for scrutinizing the election, more than 10.4 million errors of voter lists, informing the Union Election Commission, actually responsible for inspecting the voter lists, about the inspection

Press Release

ON 9 March 2021, the Ministry of Foreign Affairs has recalled Ambassador of the Republic of the Union of Myanmar to the United Kingdom of Great Britain and Northern Ireland U Kyaw Zwar Minn for his actions of issuing statements of his own will without adhering to the existing orders, instructions and policy guidelines of the State.

Meanwhile, U Kyaw Zwar Minn failed to adhere to the State policies and the Headquarters' instructions. He also abused his authority to exert pressures and coercive measures, drove staff members out of the office premises for not complying with his instructions, threatened to vacate Embassy personnel from their residences, exerted pressure on the staff staying at the Chancery to move out, locked up from outside to prevent them from leaving the office and personally took control of the State-owned Chancery and all the Embassy vehicles.

As such, the Ministry of Foreign Affairs has dismissed U Kyaw Zwar Minn from the service with effect from 7 April 2021 in accord with the Civil Service Personnel Rules and assigned the Deputy Chief of Mission as Chargé d'Affaires a.i. of the Myanmar Embassy in London on the same date.

Re-invitation to Myanmar citizens who arrive in various regions for many reasons

1. Some student youths, State service personnel and citizens, evaded to areas of EAOs and foreign countries with worries because of incitement and intimidation of NLD members, the extremists who support that party, CRPH unlawful association, incitement of CDM and persons and organizations at home and abroad not wishing to restore peace and stability of the State since after 1 February 2021 when the Tatmadaw assumed the State responsibility.
2. They are further worried about the dictatorship statement and speeches of CRPH unlawful association and some relevant persons. As they face no security guarantee and difficulties in socio-economic life in their areas, they wish to return to their native lands.
3. As those who evaded from their native areas are also citizens, the State Administration Council will arrange their returns from evaded areas to various regions of Myanmar.
4. Information was released that if those who evaded to various areas except the persons who committed any kinds of crime wish to return to their native lands in Myanmar of their own accord, the citizens abroad are to contact nearby ward, village, township and district administration bodies and relevant embassies, military attaché offices and consulates without facing action taken in accord with the law.

of voter lists, and assumption of the State duty by the Tatmadaw in accord with the Constitution due to attempts of NLD to grasp the State powers when the UEC, the Hluttaw and the government did not address the problems.

With regard to the formation of the State Administration Council, the Vice-Senior General said the structures of the region and state, district and township including State Administration Council with the majority of civilian members in efforts of the Tatmadaw to control the State powers during the period allowed by the Constitution, implementation of policies adopted by the previous governments for political, economic, health and education sectors, reconstitution of the new Union Election Commission, more than 4 million voter list difference between the list of previous commission and list of immigration department for 98 townships, taking out of more than 14 million ballot papers, use of over 9 million ballot papers and loss of more than five million ballot papers and plans to inspect remaining townships.

The Vice-Senior General highlighted current political situations. He explained the emergence of unlawfully-formed CRPH and its acceptance of cash assistance from foreign countries, giving cash assistance to protesters, armed insurrection, unlawful killing, setting fire to factories, police stations and administrative

buildings, killing people who peacefully live, acts of some media and majority of western countries in broadcasting images of security forces in brutally killing peaceful protesters, and efforts of security forces in controlling the riots under the riot manual (1956) and the crowd control manual (2015).

Regarding the educa-

tion and health sectors, the Vice-Senior General clarified non-enrollment of 3.7 million children, plans underway to reopen basic education schools in 2021-22 academic year with endeavours of the Chairman of the State Administration Council Commander-in-Chief of Defence Services, public difficulties in the health sector

despite having 1,177 hospitals in the country, admitting of the military hospital for providing treatments to the people, and reopening of 793 hospitals and plans underway to reopen remaining ones. CDM activity is a country-destroying movement but civil disobedience movement. Likewise, CRPH declared as an unlawful association becomes a committee representing Pyi-Pyay Hluttaw (exiled parliament). The Vice-Senior General also explained the promotion of education and health sector, full electrification, and generating solar power and hydropower.

The Vice-Senior General urged officers, other ranks and families to pay attention to incitements on social media, arresting and killing by rioters with abuse of narcotic drugs, build military unity, take care of health for individuals and military units and participate in individual and team-wise sports events.

After the meeting, the Vice-Senior General, wife and party presented foodstuffs produced by Tatmadaw factories and cash assistance to Tatmadaw members and families of Taunggyi Station. — MNA

UNION MINISTER for Foreign Affairs U Wunna Maung Lwin participated in the video conference of the ASEAN-UK Open-Ended Troika Dialogue, which was held at 1:30 pm on 8 April 2021 from the Ministry of Foreign Affairs, Nay Pyi Taw.

The meeting was chaired by Dato Erywan Pehin Yusof, Minister of Foreign Affairs II of Brunei Darussalam and was attended by Foreign Ministers and high representatives from ASEAN Member States and Foreign Secretary of the United Kingdom. The Secretary-General of ASEAN also attended the meeting.

At the meeting, the Foreign Ministers exchanged views on cooperation between ASEAN and the UK related to COVID-19 and health-related issues, including on building a resilient and sustainable economic recovery and climate

change.

During the meeting, Union Minister for Foreign Affairs U Wunna Maung Lwin stressed that the opened-ended troika dialogue had enable ASEAN Member States and the UK to exchange views on the important issues such as COVID-19 pandemic, economic recovery and climate change. He further

informed that State Administration Council's roadmap also emphasize on taking effective measures to prevent COVID-19, and economic recovery. In the regional context, he expressed his happiness to see the collective efforts made by ASEAN Member States to prevent the spread of COVID-19 in the region and the establish-

ment of the ASEAN Coordinating Council Working Group on Public Health Emergencies, which he believed has become instrumental for synchronizing actions against COVID-19. He also expressed his happiness to UK for reaching out to ASEAN with a view to working together in the fight against COVID-19 pandemic. In this regard, he

welcomed the contribution made by ASEAN partners and ASEAN Member States to the COVID-19 ASEAN Response Fund and informed the meeting that Myanmar would be also contributing to the COVID-19 ASEAN Response Fund.

As for building resilient and sustainable economic recovery, the Union Minister encouraged UK to support the implementation of ASEAN Comprehensive Recovery Framework (ACRF). On Climate Change, he welcomed UK's commitment to support ASEAN with science-based clean recovery assistance and developing green financial systems and energy efficiency across the region.

He emphasized the need to breed high quality and new varieties according to the different water and soil conditions of each

state and region, do research and develop the most profitable cropping patterns and cultivation methods in each area and focus

Since its establishment in 1954, the Department of Agricultural Research has produced 253 new varieties of crops, including 91 types of paddy. With the Branch of Agricultural Education collaboration, these new varieties and farming methods and technologies have been distributed to farmers.

The Deputy Minister urged all to carry out the agricultural development works in line with the Civil Service Codes of Conducts. The meeting also discussed the research works being implemented with the departments' cooperation. The Union minister and the deputy minister coordinated the discussion as necessary.—MNA

4. According to the inspection, a total of 381 polling stations in these three townships took out 361,988 ballots and used 236,143 ballots. It left 119,616 ballots instead of 125,845 ballots. The difference was 7,510 ballots, and it found 1,281 extra ballots. The extra/shortage ballots and illegal extra-ballots were found at respective poll stations. Findings were as follows:

Electrification and no shortages of fuel are the primary duty of the ministry: MoEE Union Minister

SERVICE personnel from oil fields should strive for the production of a larger volume of natural gas to generate electricity and crude oil for oil refineries through various ways and means, Union Minister for Electricity and Energy U Aung Than Oo said at the meeting with staff from Petrochemical Factories (Thanbayagan) yesterday.

He noted that as the supply of electricity for the State and no shortages of fuel are the primary duty of the Ministry of Electricity and Energy, departmental heads to encourage staff and personnel to soonest finish the projects.

He also viewed the production of condensate, petroleum, fuel oil and liquefied petroleum gas at Petrochemical Factories (Thanbayagan), which refines 300,000 gallons of crude oil per day.

He also looked into the storage of crude oil in Htaukshabin and Kani oilfield and pumping units in Mann oilfield. — MNA

MoSWRR holds meeting on prevention of violence against women law (draft)

THE Ministry of Social Welfare, Relief and Resettlement held the coordination meeting to approve the Prevention of Violence Against Women Law (Draft) yesterday morning in Nay Pyi Taw.

For the adequate protection against all forms of violence, including sexual violence against women and girls, the Ministry of Social Welfare, Relief and Resettlement, in collaboration with the Gender Equality Network, the United Nations Gender Theme Group, drafted the Law on Prevention of Violence Against Women with the technical assistance of international organizations.

The law was drafted with the study on the laws from other countries, including ASEAN countries. A steering committee, an advisory committee and a working committee were formed to complete the law.

Myanmar National Committee for women's Affairs Chair

Union Minister Dr Thet Thet Khine of the Ministry of Social Welfare, Relief and Resettlement said the process of drafting the law started in February 2013 and discussions were held with the relevant departments, women associations and members of the Myanmar National Committee for women's Affairs.

In March 2016, it was submitted to the meeting of the Peace, Stability and the Rule of Law Working Committee and the Union Government Office, then submitted to the Pyidaungsu Hluttaw through the Union Government Office. The drafted law was sent back for review as per the policy of the new government.

After the necessary amendments were made to allow the law to be enacted, it was submitted to the Working Committee twice and then submitted to the Pyidaungsu Hluttaw through the Union Government Office on 23

January 2020.

After the Pyidaungsu Hluttaw published the drafted law in state-owned newspapers from 25 to 28 January, the discussions were held at the Amyotha Hluttaw Bill Committee and the Committee on Rights of Women and Children.

The Union Minister said the drafted law was sent with a com-

ment to the Union Attorney-General's Office on the draft law on preventing violence against women as a law that should be enacted immediately before submitting to the Pyidaungsu Hluttaw.

The meeting discussed the suggestions of the UNFPA, Law Advocacy Working Group, U Soe Myaing, and Akhaya Women My-

anmar on the draft law.

The meeting was also attended by the officials from the Ministry of Defence Ministry of Home Affairs, the Department of Law, Yangon University, Representatives and officials of local NGOs, members of the Working Committee on the Drafting of the Prevention of Violence Against Women (Draft) Law. — MNA

File opened against ex-chief minister, ex-minister of Kayin State under Anti-Corruption Law

THE Anti-Corruption Commission formed an investigation team according to the complaints to take action against former chief minister of Kayin State Daw Nan Khin Htwe Myint and former minister for planning, finance and development of Kayin State U Than Naing under the law for their acts of breaking laws, orders, directives and procedures during their service terms.

According to findings of the investigation team, former chief

minister of Kayin State Daw Nan Khin Htwe Myint and former minister for planning, finance and development of Kayin State U Than Naing issued the land lease grant for more than four acres of land to the private regarding the upgrade of strand road in Hpa-an. So, the State-owned land was lost, facing more than K5,380 million in the State fund loss. From 14 May 2018 to 31 January 2021, they collected finance from businesses with the reason for regional

development. Such fund had to be paid into the State financial accounts in line with notification 58/2019. However, they opened separate banking accounts at private banks by taking more than K9,697 million.

Without abiding by the directive included in paragraph 15 of notification 58/2019 for financial procedures, they disbursed K742.5 million to 19 persons, but they did not pay back the loans. So, the State fund was lost. Re-

garding the advanced shopping centre construction project, they accepted K500 million in advance from the tender winning company without signing the work contract. However, they did not pay it into the State fund. Former chief minister Daw Nan Khin Htwe Myint spent K1.65 million from the state development fund for giving medical treatments in Hpa-an and Yangon in July 2017. Former minister U Than Naing accepted US\$10,000 from a busi-

nessperson for providing surgical treatment of the spine in Bangkok of Thailand, in March 2018. During the canvassing period in October 2020, he took K5 million as a cost for canvassing from a businessperson. They committed corruption cases by abusing their authority based on their political posts and duties. That is why files of the lawsuit were opened against them under Section 55 of the Anti-Corruption Law at Hpa-an Myoma Police Station. —MNA

Union Minister Dr Thet Khaing Win meets public health officers from regions/states

THE Ministry of Health and Sports held the coordination meeting between the Union Minister and States/Regions public health officers on 7 April in Nay Pyi Taw.

At the meeting, Union Minister Dr Thet Khaing Win said his ministry's employees' primary responsibility is to implement healthcare services to the people continuously. Officers of the

Department of Public Health and Department of medical services are responsible for improving people's health from their respective regions/states.

He added that all health workers must work together to prevent the collapse of the healthcare service system, including the country's health administration, despite the incitements in various ways to disintegrate the

healthcare system.

The Union Minister stressed the need to perform the duties of health profession and provide public health and patient care services following medical ethics, provide continued access to medicines for patients with TB and AIDS, improve the coverage of the COVID-19 vaccine, strengthen COVID-19 prevention and control activities, increase

laboratory tests for suspected COVID-19 patients, and resume regular operations in people's hospitals.

He said the ministry has been urging health workers to return to their workplaces to benefit patients starting from 8 February. He is proud of the health workers who are carrying out their duties despite the difficulties.

He highlighted the need to

ensure any shortage of necessary medicines for patients and the oversupply of drugs in the hospital. Those arrangements are being made to provide the staff's essential benefits, including dinner allowance for night duty staff in people's hospitals.

The Union Minister stressed the need for all health workers to work together to carry out their primary healthcare responsibility.



Homemade weapons seized from rioters

POLICE seized weapons and arms used in riots on 7 April. The security forces arrested U Aung Aung, son of U Sein Maung who lives at No (3/196), between Thitsar and Padonmar streets in Oh Bo of Oo Yin Su Ward in Pyinmana Township, Min Kaung San, son of U Zaw Win, who lives at No (65), Aung Thu Kha street in Kyaik Phane Ward of Mawlamyine, NLD member Thein Zaw Oo from Myaynigone Village in Tit Pin Chaung Village-tract of Kawet Station of Myaungmya Township and Tun Tun Aung from Kungyan Village of Thongwa together with their weapons.

Similarly, the rioters attacked the security forces near Aung Myay Bon San Monastery in ChaungU North Ward of ChaungU Township. The security forces dispersed the protest crowd with riot-control weapons and detained two men and their six homemade bombs.

Moreover, about 300 rioters also blocked the public roads. They attacked the security forces in Taze.

The security forces arrested six men among these

rioters and another four men in Thabeikkyin Township with their firearms.

The unscrupulous persons staged strikes and shouted slangs near No (1) BEHS in Auk Chine of Sue Gone in Kyaukse, where refresher courses for PAT were conducted. So the security forces managed the situation and detained Zarni Bone Naing (aka) Japan Gyi, son of U Khin Maung Myint, Aung Kyaw Kyaw, son of U Khin Maung Oo and Zin Myo Ko Ko, son of U Myo Win.

Similarly, on 8 April, the security forces seized weapons used in riots in the parcels with the names of Ko Kyaw and Ko Soe Thura from Doe Nyi Naung passenger bus heading to Kengtung from Tachilek at Malyan combined checkpoint gate.

Moreover, the police confiscated weapons used in riots from the house of Tayoke Gyi (aka) Min Naing Oo, son of U Hla Myint in Ohn Pin Su Pine Ward in Kyaik Htaw (North) Village in Kawhmu Township and Nay Myo Aung from Pyin Taw Village in Kanbalu Township,

The security forces also

found 18 homemade mines, 37 homemade hand grenades, 8 guns and other materials near Bogoyoke street in Taung Phi Lar Ward in Kalay Township during a roadblock clearance operation.

Moreover, they also seized other firearms at the building of Thukha Wadhunha blood donation association in Pin Sauk Monastery compound in Maha Myaing Ward of Taze.

The officials also arrested Aung Kyaw Soe from Aung Chan Tha Ward of Pakkoku Township together with two homemade guns, another three men, including Myint Myat Thiha, son of U Aung Zay Latt on Aye Mya Thaya-Sha Yaw Kha village road in Aye Mya Thaya Ward in Phakant Township, other two men including Yan Naing Tun, son of U Tun who lives in Sut Aung Village and another two men including Kyaw Myint Moe (aka) Ko Moe from Kalar Hmaw Village with their weapons including jingalis.

Those arrested will face effective legal actions, and investigations are underway to capture the rest of the suspects. —MNA

Rioters attack health officers in Hinthada Township, Ayeyawady region

RIOTERS attacked a combined team consisting of members of the security forces and health officers from the Department of Public Health in Zalun Township, Ayeyawady Region, while they were on the way to Thaduchaung village to attend the opening ceremony of Thadu station hospital and to meet the locals for the COVID-19 vaccination at around 8:30 am on 7 April.

About 200 yards before reaching the Byaezongone village, Hinthada Township, about 200 rioters opened fire with handmade guns to the boat of

the combined team.

Due to the attack, the boat had to be beached, and the rioters were demanded to disperse the crowd. Finally, the security forces had to disassemble the masses by the riot-control procedures when the rioters accelerated the attack with slingshots, fire bottles and handmade guns. Three men were detained during the riot. Their weapons used in the riot were also seized, and investigations are underway to take effective actions against those who led the riot. —MNA

YCDC ensures drinking water supply in Dala Tsp



As Dala is close to the mouth of the Yangon River, the saltwater intrusions in wells occur in the township, so the local people are dependent only on ponds and lakes.

YANGON City Development Committee (YCDC) ensures adequate drinking water supply to Dala Township wards, where local people face a water shortage problem as the lakes start to dry up in summer.

The water distribution project under the YCDC has been distributing water from 26 March 2021. The officials have provided 9,600 gallons of water to the local people in the Yazathingyan ward in Dala Township.

Moreover, they also supply 15,600 gallons of drinking water to Hmawsat and Tapinshwehtee wards and Tadachaung Sanpya village as of 8 April.

About 4,562 households in 24 wards have been connected to water pipelines. The YCDC

built 1,200-gallon concrete water tanks in 34 sites with a household water supply and filled the tanks every two days.

Other households in the townships are relying on 332 lakes and ponds.

As Dala is close to the mouth of the Yangon River, the saltwater intrusions in wells occur in the township, so the local people are dependent only on ponds and lakes.

The lakes usually dry up in summer, and water scarcity often happens.

Fishery exports plunge to \$432.8 mln as of 26 March

EXPORT earnings from the fisheries sector during the period between 1 October and 26 March in the Financial Year 2020-2021 touched a low of US\$432.8 million, a decrease of \$53 million from the year-ago period, according to statistics released by the Commerce Ministry.

The figures stood at just \$486 million during a year-ago period. Following the drop in exports, fish and prawn prices dropped by half in the domestic market. The lobsters are now priced at K30,000 per viss (a viss equals 1.6kg), whereas it earlier fetched above K80,000 per viss. Similarly, the sea bass prices decreased from K10,000 to K6,000 per viss while the crab price dropped from K17,000 to K8,000 per viss, the businesspersons said.

Myanmar Fisheries Federation (MFF) expected to earn more than \$800 million from fishery exports in the FY2019-2020, and it reached a target. Myanmar exports fisheries products, such as fish, prawns, and crabs, to markets in 40 countries, including China, Saudi Arabia, the US, Japan, Singapore, Thailand, and countries in the European Union. Myanmar's fishery exports have slightly declined over the past months, owing to the COVID-19 impacts and the current trade delay amid the political changes. Additionally, Food and Agriculture Organization (FAO) and World Health Organization (WHO) issued guidelines to ensure food safety during the COVID-19 pandemic

in April 2020.

The permitted companies are advised to carry out food safety plans, follow the WHO and FAO guidelines, formulate the safety management system, and suspend the exports if any suspicious foodborne virus or virus infection risk are found in the products. They can resume the exports once the products meet food safety criteria set by the General Administration of Customs of the People Republic of China (GACC). China is the second-largest buyer of Myanmar's fishery products, accounting for US\$254 million out of the overall fishery export value of \$850 million in the financial year 2019-2020.

The federation expects to reach a fishery export target of US\$1 billion in the current FY 2020-2021. The MFF is making concerted efforts to increase fishery export earnings by developing fish farming lakes that meet international standards and adopting advanced fishing techniques. To ensure food safety, the foreign market requires suppliers to obtain Hazard Analysis and Critical Control Points (HACCP) and Good Aquaculture Practices (GAQP) certificates.

To meet international market standards, fishery products must be sourced only from hatcheries that are compliant with GAQP. The MFF is working with fish farmers, processors, and the Fisheries Department under the Ministry of Agriculture, Livestock, and Irrigation to develop the GAQP system.

Processors can screen fishery products for food safety at ISO-accredited laboratories under the Fisheries Department.

There are 480,000 acres of fish and prawn breeding farms across the country and more than 120 cold-storage facilities in Myanmar. Myanmar exported 340,000 tonnes of fishery products worth \$530 million in the 2013-2014FY, 330,000 tonnes worth \$480 million in the 2014-2015FY, 360,000 tonnes worth \$500 million in the 2015-2016FY, 430,000 tonnes worth \$600 million in the 2016-2017FY, 560,000 tonnes worth \$700 million in the 2017-2018FY, 580,000 tonnes worth over \$730 million in the 2018-2019FY and \$847.5 million, according to the Commerce Ministry. An MFF official said the federation had asked the government to tackle problems faced in the export of farm-raised fish and prawns through G2G pacts and ensure smooth freight movement between countries to bolster exports. Myanmar's economy is more dependent on the agricultural sector to a large extent. Also, the fisheries sector contributes a lot to the national gross domestic product (GDP). Its fishery production, including shrimps and saltwater and freshwater fish, is far better than the regional countries. If the country can boost processing technology, it will contribute to the country's economy and earn more income for those stakeholders in the supply chain, Yangon Region Fisheries Department stated. — KH/KK/GNLM

Domestic gold price reaches record high of over K1.4 mln per tical



In January 2021, the domestic gold fetched the highest price of K1,336,000 per tical on 6 January. It reached the lowest price of K1,316,000 per tical on 28 January.

THE domestic gold price hit a record high of over K1.4 million per tical (0.578 ounces or 0.016 kilograms) with the high record of the global gold price, according to the domestic gold market.

The gold price hit US\$1,683 per ounce in the world market at the end-March. The price sharply jumped to \$ 1,739 per ounce on 8 April, with a significant uptick of over \$ 56 in ten days. With the mounting of the international gold price, the gold price in Myanmar has also skipped to K1,411,000 per tical on 8 April from K1,375,000 per tical on 31 March, with a significant rise of K36,000 per tical in ten days. As a result, the price of gold in the domestic market touched over K1,410,000 per tical registered last February, according to the domestic gold market. Currently, the daily business of five visses or ten visses of gold is being traded in the market.

In January 2021, the domestic gold fetched the highest price of K1,336,000 per tical on 6 January. It reached the lowest price of K1,316,000 per tical on 28 January. It reached the lowest level

of K1,340,000 (2 February) and the highest level of K1,410,000 (3 February). In March, the rate fluctuated between the most elevated of K1,391,000 (25 March) and the lowest of K1,302,000 (4 March), the gold traders said. The local gold price reached the lowest K1,310,500 (2 September) and the highest level of K1,314,000 (1 September). In October, the rate ranged between K1,307,800 (30 October) and K1,316,500 (21 October). The rate fluctuated between the highest of K1,312,000 (16 November) and the lowest of K1,278,000 (28 November). In December, the pure yellow metal priced moved in the range of K1,275,000 (1 December) and K1,333,000 (28 December), according to the gold traders. With global gold prices on the uptick, the domestic price hit fresh highs in 2019, reaching K1,000,000 per tical between 17 January and 21 February, crossing K1,100,000 (22 June to 5 August), climbing to over K1,200,000 (7 August-4 September), and then reaching an all-time record high of K1,300,000 on 5 September in 2019. — NN/GNLM

Japan Feb. current account surplus logs 1st fall in 7 months

JAPAN'S current account surplus for February marked the first year-on-year decrease in seven months, mainly due to a rebound in imports from a slump seen a year ago due to the coronavirus outbreak in China and weak exports, government data showed Thursday.

The current account balance, one of the widest gauges of international trade, logged a surplus of 2.92 trillion yen (\$27 billion), down 4.7 percent from the previous year while registering the 80th straight month of black ink, the Finance Ministry said in a preliminary report.

The country's goods trade surplus more than halved to 524.2 billion yen from 1.36 trillion yen in the black the previous year, mainly due to an 11.8 percent rise in imports to 5.55 trillion yen for the first increase in 22 months.

Imports from Asian nations expanded 36.9 percent, with a government official telling reporters that those from China, the first major economy severely impacted by the virus outbreak, have largely recovered. —AFP ■

International support grows for raising taxes to fund recovery

THE IMF and United States on Wednesday gave a boost to the international campaign to raise taxes on wealthy firms that have done well during the pandemic in order to finance recovery efforts.

The renewed support for tax changes comes as G20 finance ministers said they would continue work on a minimum corporate tax aimed at undermining the use of tax havens internationally, with a deal

possible by July.

The plan also has the support of France and Germany but US President Joe Biden's administration on Wednesday took the first step by announcing it intended to raise domestic corporate taxes and clamp down on loopholes to ensure US companies making huge profits, at home or overseas, pay a minimum amount to the government.

competition will only end when enough major economies stop undercutting one another and agree to a global minimum tax," US Treasury Secretary Janet Yellen said.

Yellen this week also said she wants the G20 to reach a global agreement on taxation to prevent firms from evading levies by establishing headquarters in countries with lower rates — a practice prevalent among tech companies. —AFP ■

Russia's central bank raps efforts to control prices

RUSSIAN Central Bank chief Elvira Nabiullina criticised on Wednesday government efforts to cap food prices as authorities seek to rein in soaring inflation on President Vladimir Putin's orders.

Consumer prices have been climbing since

March 2020, driven by a slump in oil prices and a drop in the ruble's value after months of historically low inflation. In December, Putin ordered ministers to introduce emergency measures to cap prices of basic foodstuffs such as sugar and

sunflower oil. Speaking at a forum on Wednesday, Nabiullina said it was important not to "get carried away" by price regulation.

"I believe it's necessary to drop price controls as soon as possible because it distorts price indicators in the econo-

my and discourages the development of production," she said. Speaking at a meeting in March, Putin said there was "nothing wrong" if producers reduced their "excess profits". But some businesspeople in Russia have spoken out against admin-

istrative price controls, saying such measures could deal a painful blow to major retailers with already low profit margins.

High prices are a particularly sensitive topic for the authorities ahead of parliamentary polls this autumn. —AFP ■

"This is a dream come true. I'm really working hard every single day. I don't have the words to describe this moment. We did it," Adriano Moraes said in his post-fight interview with ONE Championship.

"It's not a surprise for me because I've been working with the best guys in the world. I'm not the best. I'm just different. Today, it worked out. I'm so happy", he added.

Next, in the Catch Weight (61.5KG) MMA Fight, Rodtang Jitmuangnon (pseudonym) "The Iron Man" beat Danial Williams (pseudonym) "Mini-T" via a unanimous decision.

In the Lightweight MMA Fight, Luri Lopicus defeats Eddie Alvarez via disqualification at 1:03 minutes of round one. —GNLM ■

Chelsea punish wasteful Porto to put one foot in Champions League semis

A classy goal from Mason Mount on Wednesday helped Chelsea to a 2-0 first-leg win over Porto, whose wasteful finishing could have scuppered their hopes of springing another Champions League upset in the quarter-finals. Mount's slick turn and shot in the first half would have been painful enough for Porto, who were the better side for large spells of this first leg in Seville but repeatedly lacked the precision to take advantage.

Instead, their misery was compounded by Ben Chilwell capitalizing on a mistake at the back to score a late second that gave Chelsea another away goal and leaves them on the brink of the semi-finals. They were away goals only in name given both these teams were playing in the unfamiliar Ramon Sanchez Pizjuan,

where they will meet again next week, just with the home and away roles reversed. Porto were in the home dug-out, wore their home kit, had a large club banner in the empty stand behind one goal and their anthem was the one that played out before kick-off.

And Chelsea played the part too, delivering a classic away performance of soaking up the pressure and hitting their opponents on the counter-attack, their quality in the final third proving decisive. Real Madrid could lie in wait for the victors, after they beat Liverpool 3-1 on Tuesday.

Chelsea's win also goes some way to easing the shock of Saturday's 5-2 loss at home to West Brom in the Premier League, which ended Thomas Tuchel's 14-match unbeaten start as coach. —AFP ■

Japan may prioritise Olympic athletes for vaccine: reports

JAPAN is considering prioritizing its Olympic athletes for coronavirus vaccines, aiming to get them inoculated before the pandemic-postponed Tokyo Games open on July 23, local media said Thursday.

Japan's government denied any such plan was being considered, but said it would be "closely watching discussions" about protecting athletes' health. The reported move sparked criticism online, with one Japanese Twitter user demanding: "Give it to my granny first!" Japan's vaccine rollout is moving slowly, with just one million first doses given so far to medical workers since jabs began in February. Older people will start receiving doses only from next week, and so far Japan has approved only the Pfizer vaccine.

A date has not yet been set for vaccinating the broader population, but the government is now considering giving Japanese


athletes both shots by late June, Kyodo News agency reported, citing unnamed government sources.

Private broadcaster Nippon TV and other media also reported the plan, with some pointing out that the proposed timeline would mean healthy young athletes

would finish their inoculations before some of Japan's elderly.

Top government spokesman Katsunobu Kato said there was "no fact in the claim that the government is studying such a plan and the government has no intention of discussing it at this point." —AFP ■

French Open delayed by a week in hope that more spectators can attend

THE French Open was on Thursday delayed by a week to May 30-June 13 in the hope that heightened Covid-19 restrictions in France will have eased by then to allow the maximum number of fans to attend the event.

The French tennis federation (FFT) said the decision had been made in the wake of French President Emmanuel Macron's announcement last month that the government wanted some cultural venues to be back up and running from mid-May onwards, "subject to the improvement of the health situation". FFT president Gilles Moretton said the week's delay "will give the health situation more time to improve and should optimise our chances

of welcoming spectators at Roland-Garros".

"For the fans, the players and the atmosphere, the presence of spectators is vital for our tournament, the spring's most important international sporting event," Moretton added. The qualifying rounds of the clay-court Grand Slam event will now be held on May 24-28, followed by the main draw from May 30 to June 13. Wimbledon, the next Grand Slam tournament after the French Open, said in a statement that the decision had no impact on its planned start date of June 28.

The initial Wimbledon warm-up events, however, start on June 7, midway through Roland Garros. —AFP ■
