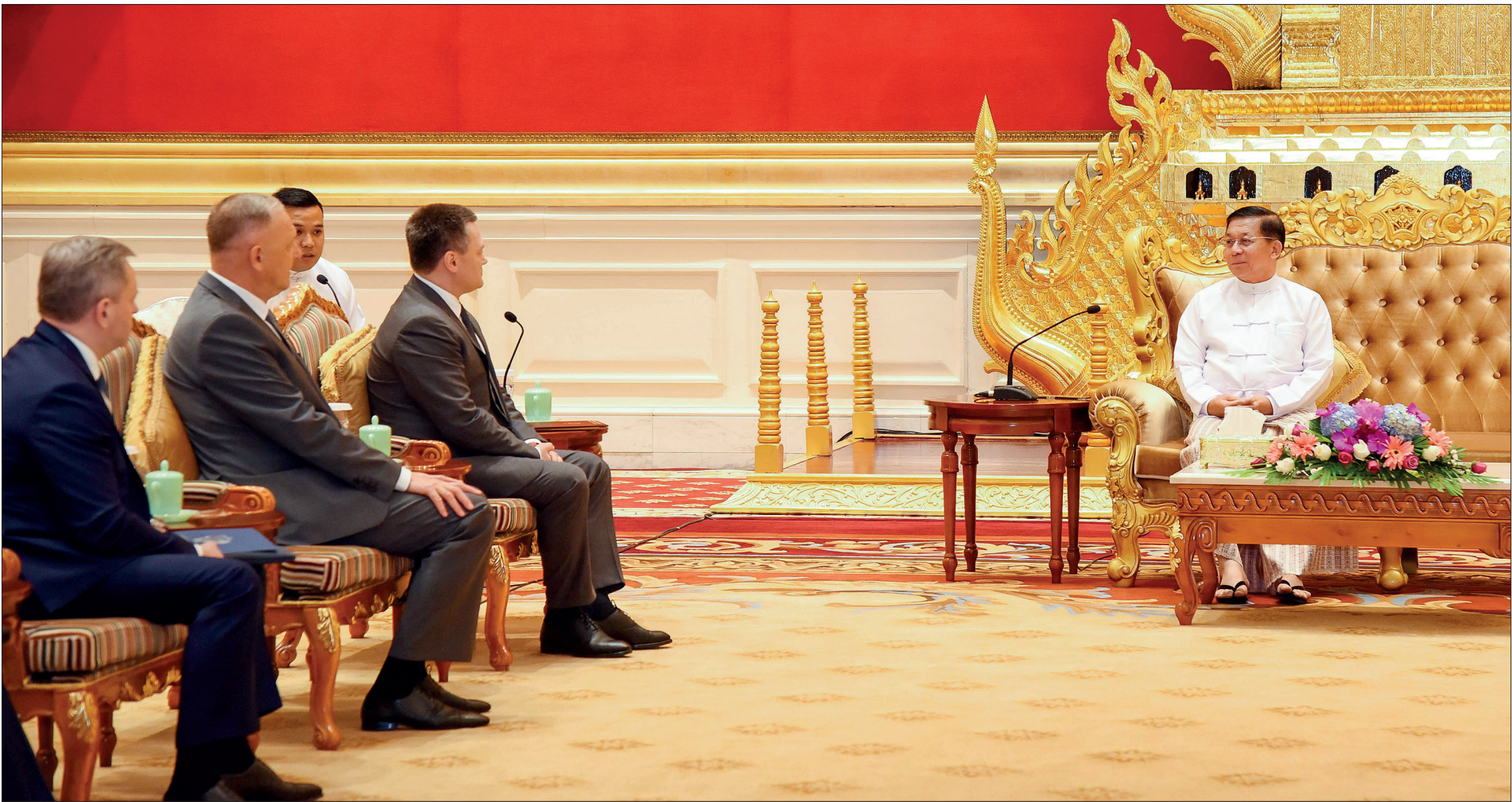


The Republic of the Union of Myanmar State Administration Council: Five-Point Road Map

- 1. Priority will be given to fully realizing peace, stability and rule of law throughout the Union to safeguard the socioeconomic life of the people.
- 2. People-centred development work that enhances socioeconomic well-being will be undertaken to ensure the country's prosperity and food security.
- 3. Processes will further continue to consolidate a genuine, disciplined multiparty democratic system and build a Union based on democracy and federalism.
- 4. Priority will be accorded to work aligned with the agreements set out in the Nationwide Ceasefire Agreement, in order to achieve enduring peace for the entire nation.
- 5. Upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held in line with the 2008 Constitution, and further work will be undertaken to hand over State duties to the winning party in accordance with democratic standards.

Application for registration, political party establishment rights ongoing

UNDER Section 3 of the Political Parties Registration Law, the National Interests Development Party, which desirous of organizing a political party, and under Section 25 of the Political Parties Registration Law, National Political Alliance League, the Inn National League Party, Kokang Democracy and Unity Party (KKDUP) and National Democratic Force Party (NDF), which are desirous of continuing to exist as political parties, yesterday applied to Union Election Commission for permissions to establish political parties under the law and rules.

To date, seven parties have applied under Section 3 of the Political Parties Registration Law, and 31 parties under Section 25 of the Political Parties Registration Law, totalling 38.

Among these 38 parties, nine parties will organize the entire union and 29 parties only within a region or state. Union Election Commission continues verifying the right to establish and register these parties. — MNA/ KZL

Everybody needs to make preparations for easing the impacts of climate change: Senior General

IF the conservation of watershed areas and forests can be done, the shortage of water can be eased, contributing to climate and health of the people, said Chairman of National Water Resource Committee Chairman of the State Administration Council Prime Minister Senior General Min Aung Hlaing at the ceremony to mark World Water Day at the Myanmar International Convention Centre-II in Nay Pyi Taw yesterday morning.

In his address, the Senior General said that the development of urban areas and industries demands a larger volume of water year by year. On the other hand, climate change and human activities make impacts on water sources and the environment, lessening the water sources. Therefore, all global countries are trying to solve the reduction of water sources.

This year's theme for World Water Day was set as Accelerating Change. Water covers 71 per cent of the world, 96.5 per cent of which are oceans and seas. The remaining 3.5 per cent of water is freshwater and renewable water. Among them, 68 per cent of water becomes glaciers and icy plains in the poles and 30 per cent un-

derground. Therefore, some 0.5 per cent of water above ground can be seen as fresh water.

It can be said that Myanmar is teeming with various sorts of rivers and creeks, lakes and natural springs, accounting for 1.7 per cent of freshwater possession across the world. Therefore, it can be said that Myanmar has a plentiful volume of freshwater.

However, some parts of the nation are still faced with shortages of drinking water in summer. Moreover, some rural areas encounter difficulties in socioeconomic life due to shortages of water in agriculture and livestock farms.

The government is undertaking to lay pipelines of springs to the people in water-scarce areas, sinking tube wells, build dams and reservoirs as well as river water pumping stations, and underground sluice gates for storage and distribution of freshwater to the people through various ways and means. People from these areas need to systematically use water, store rainwater and utilize underground water.

If the conservation of watershed areas and forests can be done, the shortage of water can

be eased, contributing to climate and health of the people. Everybody needs to make preparations for easing the impacts of climate change. It is necessary to consider policies on climatic conditions and water. Water resources are a good tool to resist climate change. Hence, all need to seek cheap water supply facilities and treatment methods.

The Senior General stressed the need to enhance technological cooperation, consultation and mutual cooperation in the

utilization of sustainable water. The people were also requested to save water and electricity, participate in growing trees for environmental conservation and avoid undisciplined disposal of garbage to conserve water sources and the environment.

In conclusion, the Senior General requested friendly countries and non-governmental organizations to continuously cooperate in development undertakings on the water by relevant ministries under the leadership

of the government. All the people were also urged to participate in the tasks of water sufficiency for all living beings as a national duty and help in the tasks of implementing the sustainable development goals adopted by the United Nations.

The Senior General presented prizes to winners in the 2023 World Water Day commemorative article contest.

Vice-Chairman of the committee Deputy Prime Minister and Union Minister for Transport and Communications Admiral Tin Aung San gave consolation prize winners in the article contest.

The Senior General and party enjoyed a video clip on 2023 World Water Day and visited the exhibition to mark World Water Day 2023.

The 2023 World Water Day was observed to enable the people to know undertakings on the water sector, water problems and ways to solve them by water-related ministries, to educate those who are related to the water and to unveil the participation of Myanmar in international activities related to the water. — MNA/TTA

58th Myanma Gems Emporium continues for sixth day

The death toll from COVID-19 in the country remained unchanged at **19,490** on 22-3-2023 with no new death reported from the pandemic. The country has vaccinated **30,975,896** people aged 18 and above for COVID-19 vaccines and **6,845,620** people aged under 18 till 21 March 2023. — GNLM

The visit of Russian Prosecutor-General Mr Igor Krasnov is a consequence of a meeting made between Union Minister for Legal Affairs and Union Attorney-General Dr Thida Oo and Russian Justice Minister

Mr Konstantin Chuy Chenko during the 10th St Petersburg International Legal Forum held between 28 June and 1 July 2022 to sign two Memoranda of Cooperation between two countries.

During the meeting, the two sides exchanged views on communication between the Ministry of Legal Affairs and the Prosecutor-General Office of Russia in legal affairs, information and experiences on the law system and legislation of

the two countries, holding of joint cooperation, conference, workshops and plenary sessions and sending of experts to share knowledge and learning.

MNHRC Statement on cardinal considerations to ensure access to education Statement No 4/2023

ARTICLE 26 of the Universal Declaration of Human Rights states that everyone has the right to education. Equal access to education is the primary component to realizing the right. In defining this right, free access at the elementary and fundamental levels are important elements and the compulsory nature of elementary education shall be observed. The Government's implementation of the KG+9 concept is also in line with these requirements.

Easiness and equality are also essential conditions required for meaningful access to education. Regardless of schools, curricula and teachers, the ultimate aim of education is invariably the full development of human personality that will benefit the student, the community and the nation. It can be safely observed that an educated person is, essentially, an asset to the nation. Looking from that perspective, facilitating access to education is a forward-looking policy.

The Myanmar National Human Rights Commission believes that the attempts to fully implement article 26 of the Universal Declaration of Human Rights will be most welcome by all.

Fuel prices sink below K2,000 per litre in domestic market

FUEL price is falling and Octane 92 price declined below K2,000 per litre in the domestic market.

On 21 March, the prices fell to K1,965 per litre of Octane 92, K2,050 for Octane 95, K2,000 for diesel and K2,080 for premium diesel.

The domestic fuel prices are set depending on the price index set by Mean of Platts Singapore (MOPS), the pricing basis for many refined products in southeast Asia, according to the Supervisory Committee on Oil Import, Storage and Distribution of Fuel Oil.

Last August 2022, the oil prices surged to K2,605 per litre for Octane 92, K2,670 for Octane 95, K3,330 for premium diesel and K3,245 for diesel.

The committee is therefore governing the fuel oil storage and distribution sector effectively not to have a shortage of oil in the domestic market and to ensure price stability for energy consumers.

The Petroleum Products Regulatory Department, under the guidance of the committee, is issuing the daily reference rate for oil to offer a reasonable price to energy consumers. The reference rate in Yangon Region is set on the MOPS's price assessment, shipping cost, premium insurance, tax, other general cost and health profit per cent.

The rates for regions and states other than Yangon are evaluated after adding the transportation cost and the retail reference rates daily covered on the state-run newspapers and are posted on the media and official website and Facebook page of the department daily starting from 4 May.

The committee is inspecting the fuel stations whether they are overcharging or not. The authorities are taking action against those retailers of fuel stations under the Petroleum and Petroleum Products Law 2017 if they are found overcharg-

ing rather than the set reference rate.

As per the statement, 90 per cent of fuel oil in Myanmar is imported, while the remaining 10 per cent is produced locally. The domestic fuel price is highly correlated with international prices. The State is steering the market to mitigate the loss between the importers, sellers and energy consumers. Consequently, the government is trying to distribute the oil at a reasonable price compared to those of regional countries.

Some countries levied higher tax rates and hiked oil prices than Myanmar. However, Malaysia's oil sector receives government subsidies and the prices are about 60 per cent cheaper than that of Myanmar. Every country lays down different patterns of policy to fix the oil prices. Myanmar also levies only a lower tax rate on fuel oil and strives for energy consumers to buy the oil at a cheaper rate. — NN/EM

86 Myanmar workers despatched to ROK until 21 March

ANOTHER batch of 36 Myanmar workers arrived in the Republic of Korea on 21 March for working in the Hyundai MIPO Dockyard, according to the Myanmar Embassy in Seoul.

Seventeen workers and 33

workers also arrived on 12 and 17 March respectively with E-7-3 visas to work in shipyards.

The labour attaché of the Myanmar Embassy in Seoul greeted them and provided for their needs. — TWA/MKKS

CBM to govern export earnings to be deposited into local bank accounts

THE Central Bank of Myanmar (CBM) will steer private sectors to ensure that the foreign currency earned from exports will be deposited in the local bank accounts, the CBM's governor Daw Than Than Swe said.

On 20 March, the governor made that remark at a meeting held in Nay Pyi Taw with the companies that fail to deposit export earnings.

According to Sections 18 (A) and 38 (B) of the Foreign

Exchange Management Law and directive 27/2021, exporters to Asian countries must deposit their export income within 45 days from the starting day. Those shipping goods to countries outside Asia must deposit income within 90 days.

The Central Committee on Ensuring Smooth Flow of Trade and Goods, the Ministry of Commerce, the Bureau of Special Investigation and the Working Group on facilitation

of Trade and Goods are monitoring whether there is actual export income into the local bank account or not.

Export earnings are one of the main foreign capital inflows. It also plays a pivotal role in stabilizing the forex market. Strong compliance of the export companies to the Foreign Exchange Management Law, rules and regulations will facilitate money flows. — TWA/EM

YCDC to accept applications for water uptake until Thingyan Eve

THE applications for temporary use of water can be submitted until Thingyan Akyo Day (the eve of Thingyan) and action will be taken against the illegal use of water, the Yangon City Development Committee announced.

For the Thingyan Water Festival, water from the municipal water pipeline, Inya Lake and Kandawgyi Lake must not be used without permission, according to the Engineering

Department (Water and Sanitation) under the Yangon City Development Committee.

Those who want to apply for use of water must send the applications to the Engineering Department (Water and Sanitation) on the fifth floor of the new 12-storey YCDC annexe by 13 April at the latest and staff from the department will give permission in accordance with the rules and regulations. — TWA/CT

Diesel price tumbles near to seven-month low in late March

THE current retail price of diesel dropped to a seven-month low in late March, said a truck owner.

On 22 March, the retail prices were up by K75 per litre for Octane 92 and K60 for diesel.

On 7 August 2021, the prices stood at K1,615 per litre of Octane 92 and K1,970 for diesel. On 21 March 2023, retail reference prices for Yangon Region were K1,815 per litre of Octane 92, K2,050 for Octane 95, K2,000 for diesel and K2,080 for premium diesel. The current diesel price is near the low price recorded seven months ago. Meanwhile,

the Octane price is still up by K350 per litre compared to that recorded in August 2021.

At present, transportation sectors see launching ceremonies of Electric Vehicles (EVs). It could cut fuel consumption to a certain extent.

Following the dip in world crude oil prices, fuel oil prices sank to below K2,000 per litre.

Diesel prices plunge so the freight forwarding businesses save some cost.

The public is a little unknown of the price decline. Nonetheless, those engaged in the transportation sectors and agriculture industries blamed the price increase of fuel oil along with other inputs such as fertilizer. — TWA/EM

China boosts South Pacific influence with Solomons port deal

A state-backed Chinese company has won a contract to develop a key port in Solomon Islands, a major victory in Beijing's quest to gain a strategic toe-hold in the South Pacific.

Solomon Islands' government on Tuesday announced that the China Civil Engineering Construction Corporation had been chosen to lead a \$170 million project to develop the international port in the capital Honiara.

UK inflation unexpectedly accelerates

BRITISH inflation unexpectedly accelerated in February, data showed Wednesday, deepening a cost-of-living crisis and pressuring the Bank of England to hike interest rates despite global markets turmoil.

After slowing for three straight months, the UK Consumer Prices Index (CPI) climbed to 10.4 percent in February -- not far from 40-year highs and more than five times the BoE's two-percent target.

That compared with 10.1 percent in January and dashed market expectations for a slowdown to 9.9 percent.

Food prices surged, particularly for fresh produce that faced shortages, the Office for National Statistics (ONS) added in a statement.

Strikes have spread across Britain as workers protest over pay failing to keep pace with prices.

The BoE — caught between hiking rates to dampen hot inflation or pausing as turmoil rages over the commercial banking sector -- will unveil its latest monetary policy decision Thursday.

Global markets have been shattered by fallout from the recent collapse of two regional US banks and the enforced UBS buyout of troubled Swiss giant Credit Suisse.

Some experts had predicted the BoE will hold off from raising rates further due to markets volatility, but the latest inflation data complicates the picture.

30% of Brazil top state jobs to go to people of colour: decree

At least 30 per cent of appointed positions in Brazil's federal government must be occupied by black and mixed-race people, according to a decree signed Tuesday by President Luiz Inacio Lula da Silva.

The leftist leader, who returned for his third presidential term in January, has vowed to make Brazil's government reflect "the face of Brazilian society", where more than half of the population is black or mixed-race.

"Racism is at the root of inequality, that's why it must be fought like a plague on a plantation," Lula said during an event in the capital Brasilia, where he signed the decree and other measures to advance racial equality in this country of 213 million.

The measure is meant to "encourage the presence of black people in decision-making and leadership spaces," the government said in a statement, adding that it will affect those who self-identify as black or brown.

The quotas for the positions of trust in the civil service, which are usually senior posts of advisers and managers, have to be met by 2025, according to the decree.

"Without race and gender equality there will be no democracy," Lula said. — AFP

Sir Edwin Hall Pascoe (17 February 1878 – 7 July 1949) was born in London to Edwin Pascoe and Mary A Hall, he went to St John's College, Cambridge, and joined the Geological Survey of India (GSI) in 1905. He became the Director of the GSI in 1921 and retired from it in 1932. He had long ago made a name for himself through his excellent work in connection with the petroleum resources of India and Burma, and, during the War, in Iraq on behalf of the Government. He followed a policy of caution and restraint in advising the Government on mineral matters as also in matters of recruitment for new appointments in the expanded Survey.

As the advisory work on the Tin and Wolfram areas of Tavoy was over, Coggin Brown was sent to London in 1919 to act as Mineral Adviser in the newly started Imperial Mineral Resources Bureau, where he remained till 1921, when he was relieved of that work by Fox, who continued in that capacity in London till 1923, when the post was abolished on the plea of the economy. Later it was found necessary to re-establish this post as a part of the personnel of the High Commissioner for India in London and G H Tipper, after he retired from the Survey, became the Mineral Adviser in London from 1929 to 1946.

Burma

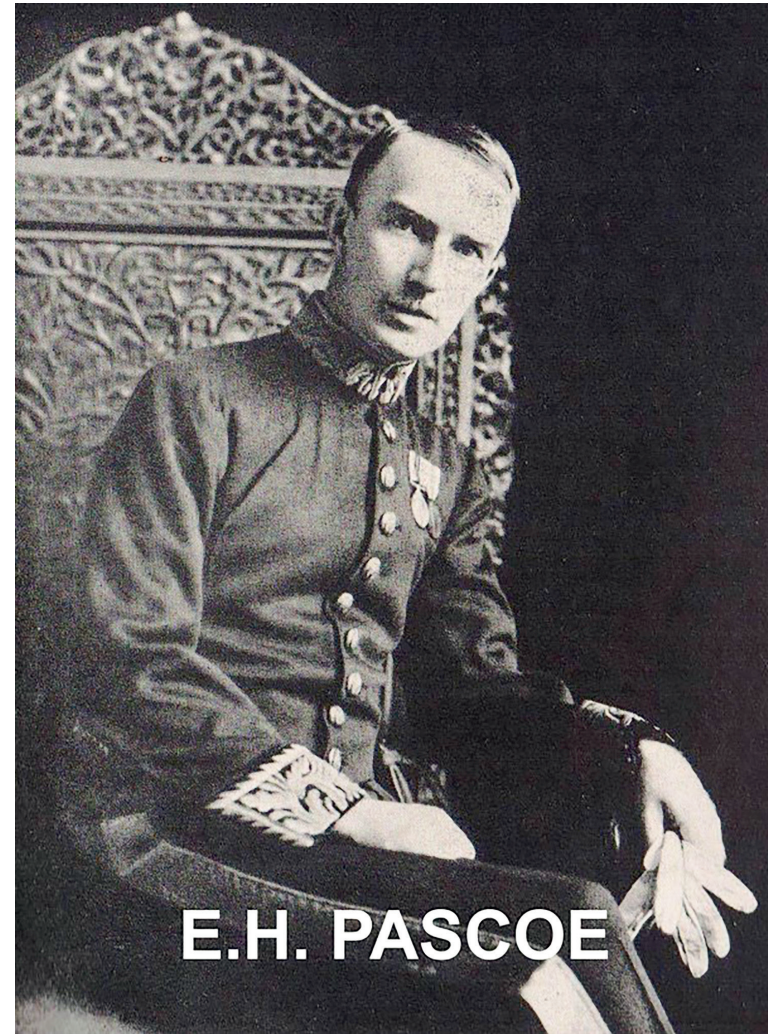
Regarding the coal survey, with the increased strength of officers, in 1921, Pascoe increased the number of field parties from three to six and allotted an increased number of men to Burma. In Burma, Vinayak Rao, F W Walker, E L G Clegg, and B B Gupta carried out systematic mapping in Mergui, Tavoy, Amherst, Minbu, and Pukokku districts with G de P Cotter in charge at first and under J C Brown afterwards, when the strength of Burma party was reinforced by the addition of C T Barber, A K Banerji, P Leicester, H L Chhibber, VP Sondhi and M R

Sahni, and Sethu Rama Rau for a short period. Sondhi carried out an interesting investigation of Late Tertiary vulcanicity, including a study of the explosion craters in Upper Burma. M R Sahni continued the work of La Touche in the Shan States and discovered a unique assemblage of Permian and Mesozoic ammonites, gastropods, and lamellibranchs in the Plateau Limestone. Clegg continued the mapping of the early workers in the Minbu district, and Vinayak Rao and Leicester in the Mergui district. Cotter and F W Walker surveyed the Loi-an coal-field near Kalaw in the southern Shan State.

H L Chhibber commenced the survey of the jade mines area of Myitkyina district in Upper Burma and described a variety of igneous rocks which had been intruded in the Tertiaries. The most interesting feature of this region lies in the preservation of the record of several periods of igneous activity dating from end-Permo-Carboniferous up to sub-Recent times. In 1929 Brown and Banerji began a large-scale geological mapping of the Mogok Stone Tract and divided the Archaean rocks into a number of stages, which were mapped separately. This work was continued by Clegg and L A N Iyer. Coggin Brown studied the Pyu earthquakes of 3 and 4 December 1930, and subsequent Burma earthquakes up to January 1932, and delineated a well-defined seismic zone, aligned (N-S), in the Tertiary belt of Burma. It was Pascoe, who introduced the system of placing an officer of the department as a Resident Geologist in the oil fields of Burma for day-to-day contact with the progress of the investigations and development work in the oilfields. C T Barber was the first Resident Geologist at Yenangaung appointed by Government.

Publications

Before he left India Pascoe had the official Geological Map of

India, compiled in 1911 by Hayden, brought up-to-date. The revised map was published in 1932 on a scale of 1”=32 miles and incorporated the surveys during the intervening period. During the period (1921-30) a large number of publications were issued, of which concerning Burma were: Sethu Rama Rau's Geology of the Mergui district; Murray Stuart's Geological account of a traverse from Assam to Myitkyina through the Hukong valley and to the Chinese Frontier. After his retirement in 1932, he was engaged in the preparation of a revised edition of the Manual of Geology of India and Burma in four volumes. The first volume of this work, which was published just after his death on 7 July, 1949, is a monument to his love for work, thoroughness in mastering details, and encyclopaedic knowledge of the subject. The remaining volumes will be of enduring value to all students of Indian and Burma Geology. Pas-

coe wrote his famous book “The Oil-fields of Burma” and published it in 1912.

Serpentine Intrusions of Burma

The Volume III of the Manual of Geology of India and Burma described the Serpentine Intrusions of Burma. The summary of the report is as follows:-

In Burma, the Deccan Trap in its normal facies has not been identified, but sundry occurrences of basic and ultrabasic intrusions are found and a highly altered basic rock which was probably a gabbro originally.

The Andaman Islands: Basic igneous rocks cover a considerable area in the Andaman Islands. Altered basic and ultrabasic intrusions of plutonic type occupy many of the hills and ridges of the central and eastern parts of Middle Andaman (including Saddle Peak and Saddle Hill) and occur in Rutland Island, and the Twins, the Cinque Islands, and many oth-

er places. These rocks vary from augite, enstatite, and bronzite peridotite with picotite; to more felspathic types of the gabbro group; with occasional crystals of chromite to be seen, and the olivine is often largely altered to a dark green serpentine with veins of chrysotile. Dolerite dykes are seen here and there.

The jaspers, quartzites, calc-gneisses, and porcellanic limestones of Middle Andaman Island, are believed to be of Neocomian age. Fragments and pebbles of serpentine, in fact, often form part of the Eocene conglomerates of Northern Andaman Island. Serpentine, gabbros and diorites are also found in the Nicobar group, a bronzite peridotite playing a prominent part among the basic intrusions on Batti Malv.

Basic intrusions are recorded in the granite and the Mergui argillites of Tavoy. They are restricted to certain localities, for instance, Danithagya, near Kandaung, between Kyaungdaung-maw-gyi and Mawshyi, and near Tavoy Point, and are extraneous in origin to the granite. They run irregularly and vary greatly in size, the largest observed, an exceptionally wide one, being 20 feet across. Generally, they are fine-grained and their minerals are much altered and difficult to determine. Some appear to be basalt but they are of heterogeneous composition.

Thaton: Talc-schists have been found in various parts of Thaton and are thought by Leicester to have been derived from basic or ultrabasic igneous rocks. In the same neighbourhood occur green epi-diorites in which segregations of magnetite are found and a highly altered basic rock which was probably a gabbro originally. Nothing is known regarding the age of any of these rocks.

The Arakan Yoma: Intrusions of serpentine, sometimes decomposed to a steatitic rock, are not common along the eastern foothills of the Arakan Yoma of the Henzada, Prom and Thayetmyo districts, especially among the Negrais beds. Generally, they have irregularly shaped bosses of var-

ying dimensions, but dykes also occur, especially to the northwest of Prom. The rock is a characteristic, dark-coloured serpentine which, in the Prom district, frequently passes into gabbro with phenocrysts of magnesite.

In the western part of the Henzada and the northern end of the Bassein districts, there are some twenty-three distinct and isolated occurrences of serpentine scattered over a length of twenty-six miles from north to south. According to Chhibber, the serpentine is sometimes traversed by narrow veins of light green chrysotile or whitish steatite. The intrusions are thought by Murray Stuart to have altered the surrounding Tertiary sandstones and shales as well as Negrais rocks. Chhibber supports this view and concludes that igneous activity extended over some period from the late Cretaceous to the early Eocene.

The steatite deposits of eastern Kyaukp, of Minbu, and probably also of Pakokku, occur in serpentine. In the steatite mines of western Minbu, the mineral is of good quality and forms veins in the serpentine. Hayden records here dykes and intrusions of grey dolerite in great masses in the Chin Shales; this is the nearest approach to the Deccan Traps in Burma.

The native copper and copper ores were found associated with chromite of the Pakokku Hill Tracts and the Naga Hills, which seem to have been introduced into cracks in the serpentine and, according to Coggin Brown, have perhaps been deposited from the aqueous solution which brought about serpentinization.

The Jade Mines: The serpentine of the Tawmaw area is seen on both sides of the Uru Chaung in four surface outcrops, the total area of which cannot be less than 8,000 square miles. In one of these outcrops occurs the intrusive dyke of jadeite which has made the locality famous. With a general N E – S W trend, the dyke is 200 yards wide and over 300 yards long but varies very much in thickness, it

is worked by Chinese traders who use a primitive process of cracking the rock by fire. The serpentine hills of this area are much alike, with steep sides crowned by a long narrow plateau; west of Nanyaseik there are several serpentine intrusions forming range upon range. Tawmaw is made up of a large mass of peridotite, partially or wholly altered to serpentine; among the types represented are dunite, mica-hornblende peridotite, diallage-peridotite, dillage-perkrite, pyroxenite and amphibolite, saussurite-gabbro and saussurite-hornblende gabbro. The serpentine is of a normal type with remnants of olivine altering to chrysolite, with crystals of magnetite, and with chromite in crystals, grains, irregular concretions, and veinlets. A rock moderately plentiful in small pieces at the jadeite mines is a dark green chromite-bearing member of the epidote group, also Maw-Sit-Sit, but Bleeck named Tawmawite.

Jadeite is regarded as a member of the pyroxene group. The dull green colour often affected by the mineral is due to the presence of iron compounds, but the brilliant emerald green so characteristic and so much prized is the result of the presence of chromium. The jadeite is accompanied by albite, the combination forming a dyke rock that has intruded the serpentine, producing signs of contact metamorphism, the most conspicuous of which is the development of new minerals such as chlorite, clinozoisite, tawmawite, chloritoid, and soda-amphibole; along the zone of contact, the jadeite-albite rock often assumes a banded and schistose character caused by numerous parallel inclusions of amphibolite. The original intrusive is believed by Bleeck to have been a nepheline-albite rock, the jadeite having been developed under very high pressure by the combination of one part of albite with one part of nepheline; the mineral nepheline has been repeatedly recorded in jadeite. Jadeite has been found at Mamon, six or seven miles south of Tawmaw as boulders in the alluvial

deposits of Uru Chaung, along the upper reaches of which it has been observed as far as Sanka; seven or eight miles still further south the mineral occurs as boulders in a Tertiary conglomerate at Hweka.

Bhamo and Myitkyina: In Myitkyina and Bhamo, parallel to the general strike of older rocks, are long strips of igneous rocks intruded, according to Griesbach, into fissures of dislocation. These intrusions are accompanied by numerous dykes which also penetrate the neighbouring formations, the more basic varieties in certain localities carrying the mineral jadeite.

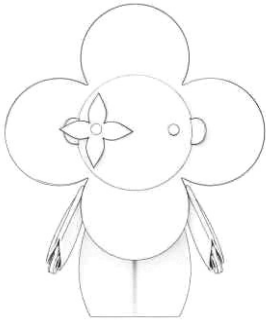
In western Bhamo, at both ends and also in the middle of the Second Defile of the Irrawaddy, as noted by Clegg 1941, are outcrops of serpentine that show an intrusive relationship towards adjacent Cretaceous sediments. At the lower end of the defile, these intrusions terminate the Cretaceous abruptly on both banks of the river; and at the upper end on the right bank; in the middle portion, they separate an outcrop of old sediments of possibly Chaung Magyi age from the Cretaceous. The intrusions consist mostly of dark green serpentine, but less altered specimens point in some cases to a doleritic ancestor. This serpentine outcrop may be continuous with that noted between Bhamo and Sinbo further north. Another line of intrusion is reported to occur in an N-S direction along longitude 97° 30' as far as the “Confluence” between the Mali Kha and the Ninai Kha.

Kachin: In the Hukawng valley, altered peridotites and serpentines have been found by Chhibber surrounded by crystalline schists similar to those of the Jade Mines area. The graphitic and chloritic schists, which are highly crumpled and extensively injected with quartz veins, are accompanied by limestone.

UK food delivery app to axe more than 1,700 jobs

FOOD delivery platform Just Eat Takeaway unveiled plans Tuesday to axe more than 1,700 mostly courier jobs in Britain, as it slashes costs in the wake of huge annual losses. The UK business “is reorganizing and simplifying its delivery operation as part of the ongoing goal of improving efficiency”, it said in a statement emailed to AFP. “As part of this process we have proposed to transition away from the worker model for couriers” in Britain, it added. 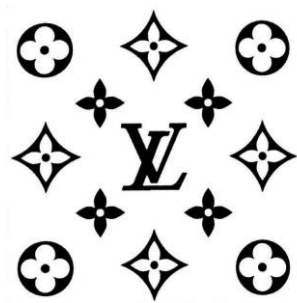

Spain govt faces no-confidence vote by far-right Vox

SPANISH lawmakers on Tuesday began debating a no-confidence motion targeting Socialist Prime Minister Pedro Sanchez brought by the far-right Vox party and fronted by an 89-year-old former communist.

The initiative, which comes before local and regional elections on 28 May and an end-of-year general election, will be put

to the vote on Wednesday.

But it has no chance of success, given the move is only likely to win support from Vox's 52 MPs in the 350-seat chamber.

The main right-wing opposition Popular Party (PP) has said it will abstain.

It is the second such motion against Sanchez brought by Vox, with a previous attempt failing in

September 2020.

This time, the no-confidence move is being defended by an external figure who does not belong to the party, Ramon Tamames.

Jailed for opposing the Franco regime, Tamames was a leader of the Communist Party during Spain's democratic transition after the dictator's death in 1975, but in the ensuing years this economics professor turned to the right.

Addressing lawmakers from the floor rather than from the speaker's box, a visibly frail Tamames justified his stance by the need to defend the Spanish "nation" against a left-wing government supported by Catalan and Basque independence groups.

Accusing the executive of "not respecting the division of powers", he also said it was guilty of a "widespread misuse of public spending for electoral purposes". — AFP

West Bank settlers win Israel parliament vote

ISRAEL'S settler movement celebrated Tuesday after parliament annulled part of a law banning them from living in areas of the occupied West Bank the government evacuated in 2005.

That year the government of Ariel Sharon oversaw a unilateral withdrawal by Israel from the Gaza Strip, and the removal of Jewish settlers from the Palestinian enclave and four set-

tlements in the northern West Bank.

Legislation passed at the time barred Israelis from staying in those areas, but an amendment approved by lawmakers overnight Monday-Tuesday permits Israelis to return to the West Bank settlement sites near the city of Nablus.

Prime Minister Benjamin Netanyahu returned to power

in December at the helm of one of the most right-wing administrations in the country's history.

He vowed to expand settlements across the West Bank.

Israel distinguishes between wildcat outposts, built without its permission, and state-approved settlements which are home to an estimated 475,000 Israelis.

All settlements in occupied territory are deemed illegal under international law.

The parliamentary vote notably paves the way for Israeli authorities to formally allow settlers to return to Homesh, the only one of the four sites whose residents were forcibly removed before their homes were demolished. Israel's ally Washington said the move was "provocative" and in violation of promises to the US. "The United States is extremely troubled that the Israeli Knesset has passed legislation rescinding important parts of the 2005 disengagement law," State Department spokesman Vedant Patel told reporters. — AFP

Japan PM vows continued support for Ukraine in unannounced visit

JAPANESE Prime Minister Fumio Kishida made an unannounced visit to Ukraine's capital Kyiv on Tuesday ahead of a Group of Seven summit he will host in May, vowing as he stood alongside President Volodymyr Zelenskyy to keep supporting the country in its struggle against Russia's invasion.

After meeting with Zelenskyy, Kishida said at a joint press conference that he invited the president to participate online in the G-7 summit in Hiroshima, while promising to supply \$30 million worth of

nonlethal equipment to Ukraine through a NATO fund.

With Japan holding this year's G-7 presidency, Kishida had been the sole G-7 leader yet to visit Ukraine after Russia launched the attack on its neighbour in February 2022. US President Joe Biden travelled to Kyiv last month in advance of the first anniversary of the invasion.

Kishida's visit to Ukraine came as Chinese President Xi Jinping, who began a three-day trip to Russia on Monday, met with Putin. — Kyodo

Greece election to be held in May under shadow of rail disaster

GREECE'S elections will be held in May, Prime Minister Kyriakos Mitsotakis announced on Tuesday, three weeks after the country's deadliest rail disaster sparked protests and piled pressure on his conservative government.

Mitsotakis' term officially ends in July, ahead of which a second ballot may be needed if the first vote fails to produce a majority or a multiparty coalition.

No exact date was given for the polls.

"I can tell you with certainty that the elections will be held in May," the leader of the New Democracy (ND) party said in his first televised interview since the head-on collision between two trains on 28 February.

"A second election may be necessary. It is very likely."

In power since 2019, Mitsotakis' administration has seen its popularity tank since the February train crash killed 57 people and brought tens of thousands of Greeks onto the streets, furious over the country's dilapidated infrastructure and perceived government mismanagement of the crisis. — AFP

Former World Cup winner Mesut Ozil retires

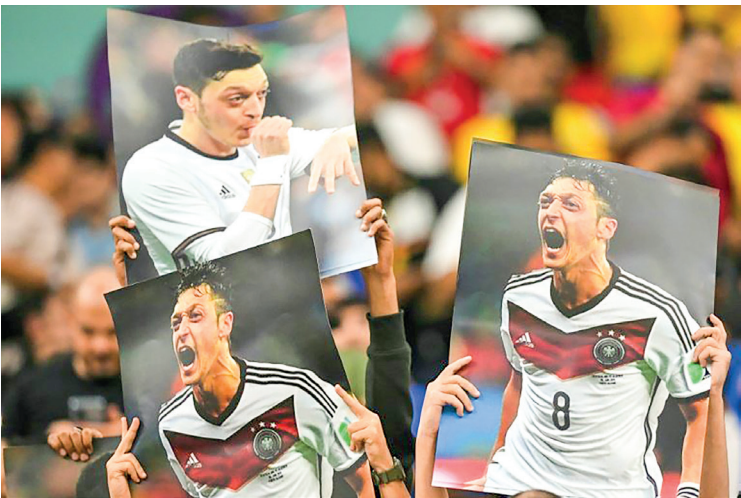
WORLD Cup winner Mesut Ozil announced his retirement from football on Wednesday after an illustrious international career with Germany and club spells with Real Madrid and Arsenal.

The 34-year-old helped Germany to glory in Brazil in 2014 but bitterly quit the international scene after the Germans crashed out of the 2018 tournament in Russia.

"After thoughtful consideration, I'm announcing my immediate retirement from professional football," the attacking midfielder said.

"I've had the privilege to be an international footballer for almost 17 years now and I feel incredibly thankful for the opportunity.

ENGLAND'S quest to win a first major tournament since 1966 starts afresh on Thursday as the Three Lions' Euro 2024 qualifying campaign begins with a testing trip to champions Italy.

After taking time to consider his future following a World Cup quarter-final exit to France in December, Gareth Southgate will remain in charge as England boss for a fourth attempt at glory.

Southgate has overseen a transformation of his country's fortunes on the international stage.

But after reaching a quarter-final, semi-final and final in

their last three major tournaments, anything less than ending a 58-year trophy drought in Germany next year will be seen as a disappointment.

Southgate might have sounded a warning this week about the declining number of England-qualified players playing regularly in the Premier League, but he admitted that is a worry for the long term given the array of talent available to him currently.

Arsenal winger Bukayo Saka and Borussia Dortmund midfielder Jude Bellingham proved themselves to be two of the brightest young talents in world football in Qatar.—AFP
