The Republic of the Union of Myanmar State Administration Council: Five-Point Road Map

- 1. Priority will be given to fully realizing peace, stability and rule of law throughout the Union to safeguard the socioeconomic life of the people.
- 2. People-centred development work that enhances socioeconomic well-being will be undertaken to ensure the country's prosperity and food security.
- 3. Processes will further continue to consolidate a genuine, disciplined multiparty democratic system and build a Union based on democracy and federalism.
- 4. Priority will be accorded to work aligned with the agreements set out in the Nationwide Ceasefire Agreement, in order to achieve enduring peace for the entire nation.
- 5. Upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held in line with the 2008 Constitution, and further work will be undertaken to hand over State duties to the winning party in accordance with democratic standards.

Over US\$13 mln received from exports via Kawthoung border in March

MYANMAR carried out border trade worth US\$13.687 million with Thailand via the Kawthoung border between 1 and 19 March, statistics by the Ministry of Commerce indicated.

Kawthoung border saw

11,732 tonnes of export worth \$11.905 million and 1,097 tonnes of imports worth \$1.782 million, totalling \$13.687 million.

Myanmar exports fishery products to neighbouring Thailand under the FOB system. Ex-

ports surpassed imports at the Kawthoung border. The main export items are fisher products such as shrimp, dried fish, crab, dried and fresh squid, cuttlefish, fish meal, cashew and oil palm, and tapioca starch, ceramic tiles,

salt, steel wire, diesel, octane, silicon, Sulphur, aluminium, charcoal powder, water purifier, spare parts for swimming pool, nylon rope, fishing net, edible bird's nest and parts of a ship are imported. — TWA/EM

UNDER Article 3 of the Political Parties Registration Law, the Union Peace and Unity Party, and under Section 25 of the Political Parties Registration Law, the Karen National Democratic Party, which are desirous of organizing political parties, yesterday applied to the Union Election Commission for permission to establish political parties under the law and rules.

To date, eight parties have applied

under Section 3 of the Political Parties Registration Law, and 32 parties under Section 25 of the Political Parties Registration Law, totalling 40.

Among these 40 parties, 10 parties

will organize the entire union and 30 parties only within a region or state. The Union Election Commission continues verifying the right to establish and register these parties.—MNA/KZL

THE ceremony of the 63rd anniversary of World Meteorological Day (WMD), organized by the Department of Meteorology and Hydrology (DMH), Ministry of Transport and Communications, was celebrated in Nay Pyi Taw yesterday.

The ceremony was attended by State Administration Council Member Deputy Prime Minister Union Minister for Transport and **Communications Admiral Tin** Aung San, Union Minister for Agriculture, Livestock and Irrigation U Min Naung, Union Minister for Natural Resources and Environmental Conservation U Khin Maung Yi, the deputy ministers, heads of departments, departmental officials and guests.

State Administration Council Member Deputy Prime Minister Union Minister for Transport and Communications Admiral Tin Aung San delivered the opening address. He highlighted that the memorial ceremony of World Meteorological Day has been celebrated annually every year on 23 March all over the world. The theme of this year 2023 is 'The Future of Weather, Climate and Water across Generations'. He also pointed out, due to climate change, Meteorological, Hydrological and Climatic Extremes events are becoming more frequent around the world, especially in the island and developing countries, which are the most affected by climate change. According to the statements of the World Meteorological Organization, 2016 was recorded as the hottest year in the world. Again, the La Niña process starting from 2020 up to 2022 was remarked as a "triple-dip" La Niña event. However, it has been observed that the La Niña processes are not as cool as they should be, because they cannot overcome the current global warming. According to the annual analysis of the World Meteorological Organization after 2022, the average temperature of the world has already exceeded the pre-industrial era by 1.06 degrees Celsius. Due to global warming, the melting of the icebergs and average sea level has already risen about 24 centimetres higher than the sea level of the year 1880s, so some island countries are encountered many challenges. In addition, the changing rainfall pattern, flooding due to untimely heavy rain, and in contrast, droughts and water shortages have been

also experienced every year. In order to reduce the increase in temperature, the United Nations Convention on climate change which was held in Paris, France in 2015 agreed that the temperature limited to not more than 1.5 degrees Celsius compared to the level of the pre-industrial period. Now that the rate of climate change is accelerating, all people should collaborate to reduce the impact of natural dis-

asters relevant to meteorology and hydrology. And therefore to be made sure that future generations can survive and thrive.

The Deputy Prime Minister and party enjoyed the video message of Prof Petteri Taalas, Secretary-General of the World Meteorological Organization, and the weather and climate change video clip. Then, the Deputy Prime Minister gave prizes to winners in the 2023 World

Meteorological Day commemorative article contest. He also visited the exhibition to mark the World Meteorological Day 2023.

In the afternoon, the paper reading session continued, and nine research papers were presented on relevant meteorological, hydrological and seismological topics from the Ministry of **Transport and Communications** and the Ministry of Education.

58th Myanma Gems Emporium winds up successfully

THE 58th Myanma Gems Emporium came to a close at the Maniradana Jade Hall in Nay Pyi Taw yesterday afternoon.

The bids for jade lots (from No 1,501 to No 2,150) were opened and examined by officials and the highest bidders for 430 jade lots were announced.

Out of 295 pearl lots on display, a total of 290 lots were sold on 18 and 19 March. Out of 120 gem lots on display, a total of 77 lots were sold on 20 March. Out of 2,150 jade lots on display from 17 to 21 March, a total of 1,544 lots were sold. — MNA/MKKS

Foodstuffs providing ceremony for displaced people takes place in Pinlaung Township

IN collaboration with the Pa-O Self-Administered Zone Administration Body and the Pa-O National Organization-PNO, a ceremony for providing foodstuffs to temporarily displaced people was held at the multi-purpose hall in the Pinlaung Township of Pa-O Self-Administered Zone, Shan State (South), on 22 March.

At first, Member of Pa-O Self-Administered Zone Administration Body Lt-Col Nyi Nyi Tin gave an opening speech and Town Elder U Khun Maung Thaung gave words of encouragement to the temporarily displaced people.

The commodities were presented to the displaced people by Lieutenant-Colonel Nyi Nyi Tin, U Khun Hla Thein, departmental staff of Pa-O Self-Administered Zone, the PNO, Chairman U Win Ko of Pa-O Literary and Cultural Association (Central), Town Elder U Khun Maung Thaung, Santa Kham (PNO), Major Khun Joseph and Township Administrator U Tint Zaw Htet. On behalf of the temporarily displaced people, a resident gave a word of thanks.

There are 930 households and 3,855 displaced people in the Pinlaung Township. It is reported that the food commodities provided to the temporarily displaced people were 352 rice bags, 465 visses of edible oil, 930 visses of chickpeas, and 465 visses of salt with a total value of K29,610,000. — Township IPRD/CT

UNION Minister for International Cooperation U Ko Ko Hlaing in his capacity as Vice-Chairman 1 of the Rakhine State Stability, Peace and Development Work Coordination Committee, accompanied by Rakhine State Chief Minister U Htein Lin, led a diplomatic team comprising ambassadors and diplomats of ASEAN countries, China, India and Bangladesh embassies and representatives of the AHA Centre to observe the preparations made for the repatriation of displaced persons from Rakhine State, relocation of IDP camps, issuance of NVC (National Verification Card) and vocational training schools in Rakhine State.

The words of the Union minister, the Rakhine State chief minister and departmental officials regarding the preparations for the repatriation of the displaced persons and relocation of IDP camps are as follows: -

UKo Ko Hlaing (Union Minister, Ministry of International Cooperation)

We have arranged to repatriate the displaced persons from the Bangladesh side under a pilot project. In doing so, we invited the diplomatic missions of ASEAN countries, neighbouring countries and the Executive Director of the AHA Centre and party to show how the Myanmar government is preparing to accept the prospective returnees. First, we observed the Nga-

khuya reception centre and the Hlaphoekhaung camp which is a temporary transit camp for displaced persons after they have been checked at the reception centres.

We will place them at the transit camp for a short period and relocate them to the designated villages. I have been to Rakhine State three times, including this trip. I found progress in work each time. The ruined wards and shelters have been dismantled and rebuilt. The Assemble Board Houses (ABH) donated by the Government of China have been set up at proper locations in the transit camp. It also provides water and electricity. I feel satisfied with the current situation. Almost everything has been renovated. Although the families will have to stay here just for some time, the Ministry of Social Welfare, Relief and Resettlement will provide child-friendly places for kids, and vocational training for women, as well as kitchen utensils and clothing.

The diplomats who participated in this tour have not ever been here and this is their very first experience. They wanted to know what is going on here because foreign media outlets always express the repatriation issue from a negative perspective. Some are saying that the Myanmar government does not want to accept the displaced people and there is no cooperation from the Myanmar side. On the contrary, Myanmar is ready to

receive the returnees. It has been ready for a long time, and extensive maintenance works for the infrastructure have to be conducted as no returnees have returned yet. The diplomats clearly witness these situations.

These processes for repatriation are not being carried out only by our ministry. The working committees under the Rakhine State Stability, Peace and Development Work Coordination Committee are coordinating and undertaking the preparatory works. The preparatory works are making progress through the collective efforts of ministries

concerned under the respective working committees. The Rakhine State government and regional administrators have also exerted their best efforts on these processes. I thank all for their relentless efforts. We will implement the necessary works as quickly as possible and make all efforts to repatriate the displaced persons under the bilateral agreements.

Upon their arrival, we will provide them with vocational training to support their livelihoods to improve their socioeconomic status. At the same time, the Rakhine State Stability, Peace and Development Work Coordination Committee will ensure proportionate and inclusive development in Rakhine State by equally prioritizing the development of local ethnic communities in Rakhine State. Our main aim is to make every effort for the peace, stability and development of Rakhine State.

U Htein Lin (Rakhine State **Chief Minister)**

The preparatory works for the repatriation processes by the Rakhine State government are achieving more progress than before. Regarding the current pilot project, it is being carried out under the guidance of the Union level and our Rakhine state government is assisting with the necessary things. As priorities, we have done

arrangements including roads, buildings, electricity, water and accommodation so that the reception processes will be in order. After they (the displaced persons) have been checked and received, they will be temporarily placed in the transit camp. Then, we will designate the villages for them to relocate and resettle. We have built housing in some villages for them to live in a proper standard of living. We have also prepared the necessary basic infrastructure in the designated 15 villages. We also have plans to provide other required infrastructure when the returnees settle in those villages.

We are working not only for stability and the rule of law in Rakhine State but also for the development of the region. In doing so, peace and tranquillity are indeed necessary for development, but development can also bring peace and tranquillity. Following the guidance of the Head of State, we are making efforts to develop the MSMEs based on agriculture and livestock which will bring benefits to our region and the country as our region is endowed with good water and land resources. The government also grants loans for socioeconomic development from the State Economic Promotion Fund. We are making arrangements to use the loans

effectively. The Rakhine State government, social organizations and local ethnic people are cooperating and coordinating to fulfil the needs of our region in accordance with the instructions of the Union level.

Mr Mongkol Visitstump (Thai Ambassador to Myanmar)

It is my first visit to Myanmar. I arrived in Myanmar four months ago. With the generosity of Myanmar, the Ministry of Foreign Affairs of Myanmar organized a diplomatic tour this time. It helps open our eyes. And we have an opportunity to hear by our own ears. It is an excellent preparation by the Myanmar government for the returnees, and IDPs, so I wish Myanmar and Bangladesh, both countries can consult to move forward on preparations to materialize. The facilities were built some time; two or three years already and still can serve the returnees.

For Thailand, we have development projects here in Rakhine State. For example, the building of rice mills, capacity building on fish culture and agriculture technology by using advanced equipment. We have donated 16 tractors for machinery and even six motorcycles for the centre to use. Now we are in preparation for sending in technicians to install the rice mill in Maungtaw and for the construction of fish ponds. We can teach how to cultivate fish.

Thailand will support the joint efforts of the Myanmar and Bangladesh governments. I appreciate the Myanmar government's efforts on buildings, facilities and training, even taking care of villagers here (Ngakhuya village) is excel-

U Thein Htay Oo (Permanent Secretary, Ministry of **Border Affairs**)

Arrangements for repatriations were made in 2018-2019. At that time, around 2,000 or 3,000 people were planning to return but they didn't for various reasons. So, I want them (the displaced persons) to know that the two countries have negotiated and, accordingly, necessary arrangements have been made for repatriation. In the previous attempts, we informed them (the displaced persons) in advance that we would accept them in accordance with the five criteria for eligibility to return and that they could return safely. However, they did not return as they were pressured and controlled not to return. Therefore, the international community thought that we did not want to receive them. We thus invited diplomats to show our preparations which have cost the government more than five billion kyats.

If they return under the pilot project, we will receive and check them at Taungpyo Letwae and Ngakhuya reception centres and then place them at the Hlaphoekhaung transit centre temporarily. We have arranged land plots in 15 villages just north of Maungtaw. There are also farmlands at the designed relocation sites and we have arrangements to facilitate their short and longterm livelihoods. I want them to know about our arrangements. However, those who do not want to return barred those who wish to return. We did not force those people out of the country but they left on their own decisions. Yet, foreign countries have reproached our country.

I want them to know about our efforts to receive them. We spent a large amount of funds on the repatriation process. The Rakhine State government, Ministry of Border Affairs and Ministry of Social Welfare, Relief and Resettlement will provide basic food

provision to the returnees for one month. The world does not hear the ground truth of what we have done here. Therefore, we invited the diplomats to share the correct information. Under the pilot project, we will repatriate about 1,500 displaced persons. We have not received any response yet. After the pilot project, we will discuss repatriating over 5,000 people from 1,500 households in the northern part of Maung-

We will accept those newborns in Bangladesh with official certificates from Bangladesh courts but their parents must have lived in our country. We plan to arrange about 750 land plots in 15 villages. If there are more returnees, we will make further plots of land and relocate them systematically. But, they must be the ones born and lived in Myanmar. We have our record of registered family households. If they match with the registered family household list and have not committed any crime, we will receive them. For their safety and security, we have police stations near the 15 villages. I would like to reiterate that we did not force them to leave the country and we always welcome the returnees if they abide by the laws of istration Department) our country.

Dr Ko Ko Naing (Permanent Secretary, Ministry of Social Welfare. Relief and Resettlement)

This is basic sewing training opened at the vocational training school in Sittway Township. The local ethnic women and the women from the temporary IDP camps are attending the training together. They will achieve vocational skills to sustain their livelihoods. Besides these skills, the training will support the social cohesion of communities as they work together in the workplace with the same mission. Social harmony and integration are a necessity for any community. Therefore, the training is meant not only for generating income for women but also to ensure social cohesion and integration among them. We launch this training for women and girls from different communities so that they will get acquainted with each other and could share their experiences. About 50 trainees - locals and women from IDP camps are attending the training.

U Arkar Myint (Assistant Director, General Admin-

We are arranging to complete the relocation of the Kyauktalone IDP camp by the end of March 2023. We will relocate a total of 375 households from that IDP camp. The houses were constructed in 2021-2022 FY. There are 396 houses in total. For the first phase, we will relocate those registered in the household lists of the IDP camp. Next, we will relocate those who cannot return to their own villages.

All people at the IDP camp are residents of Kyaukpyu Township. We built hospitals, clinics, schools, police outposts and water tanks at the resettlement site. Moreover, road access and electricity supply are already connected to their houses. The government arranges food and accommodation for the IDPs using billions of kyats from the government budget.



Moderna rebuked over plan to hike Covid vaccine to \$130

Democratic Senator Bernie Sanders lashed out at the price hike, denouncing the "unprecedented level of corporate greed" in the pharmaceutical industry. "And that is certainly true with Moderna," Sanders said.

Moderna has so far charged between about \$15 and \$26 for doses of its vaccine, according to the Kaiser Family Foundation.

The US government subsidized \$1.7 billion of Moderna's research at the start of the pandemic and then purchased \$10 billion worth of vaccine, Sanders said at a Senate hearing where the company's CEO Stephane Bancel was testifying.

Sanders said Moderna was "thanking the taxpayers of the United States" by more than quadrupling the vaccine's he added.

price "at a time when it costs less than \$3 to manufacture".

Sanders noted several times at the hearing that Moderna conducted buybacks of its own stock and paid its own executives at its Cambridge, Massachusetts, headquarters handsomely.

Bancel defended Moderna, saying the distribution system will change completely when the US government lifts a state of health emergency, perhaps as soon as May. Up until now, Moderna had only one customer, distributed its vaccine to only a few warehouses and did not have to pay for the cost of expired doses.

By switching to a more traditional marketing approach, "we're going to have 10,000 customers" and have to "manage to deliver to 60,000 pharmacies, doctors' offices and hospitals,"

Currently distributed in multidose vials, the vaccine will be sold mostly in single-dose vials or directly in prefilled syringes. And Moderna will have to take care of the unsold doses.

The company expects a "90 per cent reduction in demand," Bancel said.

"We are losing economies of scale. We must assume the wastage risk and cost that the US government used to

Moderna also pledged to set up a program so that the uninsured or underinsured would not have to pay

When pressed by Sanders about the possibility of the company lowering its price for government-run health insurance programs, Bancel said discussions were underway with all customers.

Rising oil prices elevate cuttlefish price

FUEL prices weigh on cuttlefish prices in the Myeik area, said local traders.

"The cuttlefish was priced at K15,000 per viss before. The rising oil prices affected the fresh fish supply and hiked the price up to K25,000 per viss. They are mostly sent to China and India,"

said a trader.

The mating season of cuttlefish is April-May. Fishing of cuttlefish is suspended during the mating season. The fishing season is from the winter to early summer. Cuttlefish live in saltwater. The reproduction rate increases in warm environ-

ments. One-year-old cuttlefish can mate and reproduce. The life expectancy of the cuttlefish is three years at maximum. The female cuttlefish can spawn over 100,000 eggs.

Cuttlefish and squid are commercially valued fishery products. The cuttlefish of 1-10 inches caught in the Myeik area are sent to domestic fish markets. Those cuttlefish sized below 2 inches are dried, while those sized above 3 inches are frozen and processed. Frozen cuttlefish are exported to Thailand and China purchased the processed ones. Cuttlefish and squid are good sources of protein and are rich in protein and other minerals. They can be used in a variety of dishes (fried, steamed, roasted, curry and salad). It is a popular dish in hotels. — TWA/EM

225-MW of electricity in Yangon to be temporarily reduced for 4 days

THE Yangon Electricity Supply Corporation-YESC announced the maintenance and repair work of the Zawtika natural gas pipeline, which supplies gas to power plants in the Yangon region, will be carried out from 23 to 26 March.

During the process, pow-

er generators will be able to produce 225 megawatts of electricity less than normal. Therefore, hydroelectric power plants will supply the required electricity and YESC has said that it will have to reduce the workload if necessary. — TWA/MKKS

Shan garlic price drops back to normal

THE price of some high-priced kitchen goods in the commodity market decreased before the Thingyan holidays. It soothes the daily food expenses, said house-

The regular price for largesize Shan garlic was around K4,000 per viss before, but the price of Shan garlic started to increase on 14 December 2022. It gradually rose to K5,100 per viss at the end of December and K6,300 per viss on 19 January 2023.

On 15 February 2023, new Shan garlic started to enter the market at the rate of K5,500 per viss for large sizes. On 23 March, the wholesale prices of new Shan garlic dropped to K2,850 per viss for S-2, K3,200 per viss for S-3, K3,400 per viss for S-4 and K3,600 per viss for S-5, returned to the price rates before mid-December 2022.

While garlic from Shan State fetched K6,300 per viss, the wholesale price of Kyukok garlic was only K3,700-K3,800 per viss. On 23 March, the large-size Shan garlic was wholesaled at K3,600 per viss and the Kyukok garlic at K4,000 per viss.

New Myanmar garlic grown around Pakokku and Mandalay has arrived at their markets, along with new Shan garlic. Myanmar garlic surpasses Shan garlic in price because the former is whiter in colour and lower in moisture. On 23 March, S-2 Shan garlic was priced at K2,850 per viss and Myanmar garlic at K3,700 per viss. Therefore, Shan garlic has a bigger demand than Myanmar garlic in the Yangon

Approaching bridges, roads to Yangon-Dala Bridge slated to complete at 2023-end

THE Myanmar-Korea Friendship Bridge (Dala) project, which will become a prominent landmark of Yangon commercial hub and tourist spot, commenced in May 2019 and efforts are being exerted to complete the construction works on the bridges and roads approaching the Dala Bridge on both sides at the end of 2023.

The appearance of the bridge has become vividly clear. The aesthetic design of bridges with approaching bridges, including two-lane bridges connecting to Phonegyi Road from the Dala side, and one-lane bridge to Sule Road and Strand Road on the Yangon side is enchanting and it makes Yangon urban city more liveable.

That bridge will become the longest and largest steel cable-stayed bridge in the country, with bored piles foundation, four-metre-wide sidewalks and a maximum loading capacity of 75 tonnes. The approaching bridge on the Dala side is 577 metres long and the one on the Yangon side is 601 metres long. The total length of the bridge is 6,144 feet (1,868 metres). International cargo ships with 15,000 DWT can

pass under the bridge, with a clearance height of 49 metres (160 feet) and width of 301 metres (998 feet). Sub-contractor CML company constructs two towers in the middle of the river and a cable suspension bridge with Korean technology. The main bridge between two towers (pylons) is 370 metres long.

"The construction of the approaching bridges on the Yangon and Dala sides is underway with concrete slab works. The approaching bridges and road parts are soon to be completed. The PY1 is 50 metres high and PY-2 is 45 metres high. The main bridge is to be 130 metres high. The construction works are accelerated with double shifts. About 54 per cent of the project is finished for now. The cable will be installed in each part of the bridge span in September. The construction of the approaching bridges and roads is slated to be completed at the end of the year. The Ministry of Construction is endeavouring to complete the whole project in 2024," said U Kyaw Kaung Cho, deputy director-general of the Department of Bridge.

This friendship bridge pro-

ject was initiated during former President U Thein Sein's trip to the Republic of Korea. Under the agreement of the two leaders of the nations, the feasibility study was undertaken step by step from a pilot project with the assistance of the ROK. In 2015, the Ministry of Construction signed an agreement for the construction of the bridge with

the EDCF loan of Korea.


The GS Engineering Group is the main contractor and developer of this bridge project, spending approximately US\$157.833 million. The interest on the loan is at 0.01 per cent and the repayment period is 40 years.

Upon completion of the bridge, it will bring about business opportunities for the local communities in Ayeyawady Region, linking with the commercial hub Yangon. It will enhance socioeconomic development, and facilitate transport.

The Myanmar-Korea Friendship Bridge will become the largest bridge with the highest clearance between the surface of the water and the bridge.

Security Forces arrest 14 members of Anonymous terrorist group with arms, ammunition in Monywa



THE security personnel arrested 14 members of the Anonymous terrorist group including the group leader together with seven homemade guns, five homemade mortars, 19 homemade mines, 176 round of ammunition and other explosives at the hut near Chindwin River in Ayethaya Ward of Monywa Township on 15 February.

During the arrest, the mem-

bers of Security Forces recused four innocent civilians — two males, one female and one child whom the terrorists abducted as hostages.

According to the confession of the suspects, they arrested that family as the male hostage removed their planted mine in Monywa Township.

The suspects also testified that five terrorists attended the three-month explosive training of the Monywa PDF group in the hilly area in front of Bawditahtaung Pagoda in April 2022.

After the training, they organized the 13-member Anonymous terrorist group to rob and kidnap innocent civilians and to ask for money in December 2022.

Moreover, it was found out that the Anonymous terrorist group launched bomb attacks four times with the financial and weapons assistance of CRPH and NUG terrorist groups – in Htantaw Kyunswal Ward of Monywa township in the first week of January 2023, at the junction of the industrial zone in the second week of January, at motor vehicle station at the corner of Pyidaungsu and Kyaukka roads in Alal Ward on 1 February and in Innsut street of Shwegon Ward of Monywa on 12 March.

According to the investigation, the Anonymous group killed three innocent civilians on 16 November 2022, on 10 January and in the first week of February 2023.

According to the tip-off, the police could remove the unexploded seven homemade mines planted on both sides of Pyidaungsu road and near Boebwayeiktha roundabout and two homemade mines planted near "Sein Yaung Sone" pub along Bogyoke street in Monywa Townshin

The suspects were charged in the cases and further investigation was underway. — MNA/

Kyoto to introduce Japan's 1st empty homes tax

Japan's internal affairs ministry is set to approve a proposal by Kyoto to tax owners of empty homes and holiday houses, a source close to the matter said Wednesday, putting the western Japan city on track to be the first in the country to implement such a system.

The new tax, slated to be introduced in 2026 at the earliest, aims to boost the property market amid an exodus of young people struggling to secure housing in Kyoto. If effective, it could serve as a reference for other cities facing similar problems.

In addition to vacant properties, the non-statutory tax will also target vacation homes and unoccupied secondary residences, with property value and location to be used in calculating the amount of tax.—Kyodo

Toshiba OKs Japan Industrial Partners-led consortium buyout: sources

TOSHIBA Corp has agreed to accept a buyout offer from a consortium led by Tokyo-based fund Japan Industrial Partners Inc., in a deal expected to be worth about two trillion

yen (\$15 billion), sources familiar with the matter said Thursday. The JIPled group is expected to launch a tender offer to buy Toshiba shares from existing shareholders and delist the struggling conglomerate. It also plans to relist Toshiba after a turnaround, the sources said.

The consortium reportedly includes about 20 Japanese companies such as Orix Corp and Rohm Co. A group of banks including Sumitomo Mitsui Banking Corp is expected to finance the deal.

The agreement will conclude the long-running takeover process, which began in April last year after Toshiba said it was looking for new partners willing to invest in the company, in an effort to cut ties with activist shareholders seeking short-term shareholder returns.—Kyodo

Philippines aims to export 54,000 tonnes of durian to China in 2023

THE Philippines aims to export at least 54,000 tonnes of "premium" fresh durian fruits to China this year, the Department of Agriculture said on Wednesday.

"Stakeholders are now beefing up their production to meet the high demands entailed by the agreement," the department said, referring to a fruit export deal secured by Philippine President Ferdinand Romualdez Marcos during his visit to China in January.

The department said Davao City-based Eng Seng Food Products and Belviz Farms are two private durian growers preparing for the Chinese market for Philippine durians. "China is the biggest durian market, so we are very excited and looking forward to exporting durian there. Our target is to export containers of durian weekly," Eng Seng Food Products CEO John Tan said. — Xinhua

India's Rahul Gandhi found guilty of defamation over Modi remark

AN Indian court Thursday found opposition leader Rahul Gandhi guilty of defamation for a three-year-old campaign trail remark implying that Prime Minister Narendra Modi was a criminal. Modi's government has been widely accused of using the law to target and silence critics, and the case in the premier's home state of Gujarat is one of several lodged against his chief opponent in recent

years. Gandhi, the leading face of the opposition Congress party, was sentenced to two years imprisonment but immediately granted bail after his lawyers announced their intention to appeal.

The case stemmed from a remark made during the 2019 election campaign in which the 52-year-old had asked why "all thieves have Modi as (their) common surname". — AFP

Thai police shoot gunman dead after 15-hour standoff

THAI police shot dead a gunman who killed three people and wounded three others, a senior officer said Thursday, after a 15-hour standoff.

The shooter started firing in Phetchaburi, about 100 kilometres (60 miles) southwest of Bangkok, at around 3 pm (0800 GMT) on Wednesday, before police surrounded a house he was in.

The standoff ended early Thursday when armed police stormed the building and killed the gunman, who has not been named but was reported by local media to be a 29-year-old former national park official. —AFP

Australian PM calls on voters to back Aboriginal 'voice'

AUSTRALIA'S prime minister on Thursday made a tearful appeal to voters, asking them to support the creation of an Aboriginal "voice" in lawmaking as he announced the wording of the referendum question. Anthony Albanese said that Australians had a chance to make up for centuries of injustice, to formally recognize Aboriginal and Torres Strait Island groups, and give them a voice in decision-making at a vote later this year. This is "about how our nation sees ourselves. Whether we have the confidence to embrace our history", said Albanese, painting the vote as a chance for Australians to make their country fairer. —AFP

Israel strike damages Syria's Aleppo airport: defence ministry

AN Israeli air strike hit Syria's Aleppo airport on Wednesday causing damage, the defence ministry said, without mentioning any casualties, in the second such attack on the facility this month.

The airport in Syria's second city has been a major conduit for relief flights since a 6 February earthquake devastated swathes of southeastern Türkiye and neighbouring Syria.

"Around 3:55 am (0055 GMT), the Israeli enemy carried out an air attack... targeting Aleppo international airport, leading to some material damage," a defence ministry statement said.

"A number of missiles" were fired from the Mediterranean west of the coastal city of Latakia, it added.

Transport ministry official Suleiman Khalil told AFP technicians were assessing the damage. The Syrian Observatory for

Human Rights said the strike targeted "the airport compound and a weapons depot belonging to pro-Iranian forces on the airport's perimeter." The Britain-based war monitor said the depot had been "completely destroyed".

On 7 March, three people were killed in an Israeli strike

on the airport that brought air traffic, including relief flights, to a halt. The airport reopened several days later.

More than 80 aid flights have landed in Aleppo with relief supplies following the earthquake, according to the transport ministry.—AFP

'Noose around your neck': Colombia's biggest drug cartel rules with fear

IN the cities and towns of northwest Colombia, the ubiquitous graffiti "AGC" signals the ominous presence of the powerful Gulf Clan drug cartel.

Spray painted onto walls, it is meant to instill fear in residents, and keep them mum, as the Clan embarks on a fast-escalating confrontation with the government in an area critical for its bustling cocaine trade, illegal mining and other lucrative criminal ventures.

"To speak about the Clan is to put the noose around your neck," said a resident of Taraza, a town that has recently found itself at the cartel's mercy.

Like many interviewed by AFP in the region, the resident would not divulge their name for fear of reprisal.

Also known as the Autodefensas Gaitanistas of Colombia or AGC, the Gulf Clan is the biggest drug cartel in the world's largest cocaine producer.

It has a long history of violence in an area dubbed the "Bermuda triangle" by locals because of the many people who have gone missing there, only to

be found dead in the river nearby.

Authorities accuse it of fomenting violence and vandalism by illegal gold miners in the northwest region protesting a clampdown on their operations and the destruction of their dredging machinery.

In so doing, the Clan breached the terms of a cease-fire not even three months in, according to the government.

The miners have set up roadblocks, attacked govern-

ment buildings, a bank and civilians — severely disrupting daily life and livelihoods.

On Sunday, a dozen assailants on motorcycles set fire to two buses and four trucks on the National Route 25 — a critical link between the Caribbean coast in Colombia's north and the second city of Medellin in the east.

That prompted President Gustavo Petro to announce the "reactivation" of military operations against the cartel. — AFP

The first and second-placed teams from the two groups for the second round will advance to the next stage along with Uzbekistan, Japan, North Korea, and South Korea.



French MPs battle over AI-assisted Olympics surveillance

FRENCH government plans to trial surveillance cameras upgraded with artificial intelligence at the 2024 Olympics have opponents fuming at what they say is unnecessary and dangerous security overreach.

While the government says such systems are needed to manage millions-strong crowds and spot potential dangers, critics see the draft law as a gift to French industry at the cost of vital civil liberties.

Last week, around 40 mostly left-leaning members of the European Parliament warned in an open letter to French lawmakers that the plan "creates a surveillance precedent never

before seen in Europe", daily Le Monde reported. Debates kicked off late Monday in the National

Sheikh Jassim Bin Hamad Al Thani, the chairman of Qatar Islamic Bank, and Ratcliffe, the founder of chemicals giant INEOS, are the only bidders who have gone public with their intentions.—AFP

The Republic of the Union of Myanmar **State Administration Council: Twelve Objectives**

- (a) To ensure a strong and dynamic Union spirit, the genuine spirit of patriotism.
- (b) To respect and promote the customs and traditions of all National people and preserve and safeguard their faiths, beliefs, culture, and characteristics of patriotic nationalism.
- (c) To strengthen basic health care in order to achieve the emergence of a health system that enhances the longevity and health of the entire nation.
- (d) To comprehensively promote the education sector to make it capable of producing the human resources necessary for building a modern, developed, and progressive democratic nation.

HARRY Kane is ready to break the all-time England goalscoring record in his team's opening Euro 2024 qualifier against Italy, manager Gareth Southgate said on Wednesday. Tottenham striker Kane is locked with Wayne Rooney on 53 goals for his national team after missing a penalty in England's World Cup quarter-final defeat to France. But Southgate says he has put that disappointment behind him coming into Thursday's Group C clash in Naples.

"We've seen with his performances and goalscoring with his club he's put it behind him," Southgate told reporters.

"I know he's going to have added motivation tomorrow night to come back and show

England have a poor record against the world's top sides and Thursday will be an acid test against the team that snatched Euro 2020 triumph from them at Wembley before dumping them down to the second tier of the Nations League.—AFP
