The Republic of the Union of Myanmar State Administration Council: Five-Point Road Map

- 1. Priority will be given to fully realizing peace, stability and rule of law throughout the Union to safeguard the socioeconomic life of the people.
- 2. People-centred development work that enhances socioeconomic well-being will be undertaken to ensure the country's prosperity and food security.
- 3. Processes will further continue to consolidate a genuine, disciplined multiparty democratic system and build a Union based on democracy and federalism.
- 4. Priority will be accorded to work aligned with the agreements set out in the Nationwide Ceasefire Agreement, in order to achieve enduring peace for the entire nation.
- 5. Upon accomplishing the provisions of the state of emergency, free and fair multiparty democratic elections will be held in line with the 2008 Constitution, and further work will be undertaken to hand over State duties to the winning party in accordance with democratic standards.

Duty-assigned staff members in eradicating illegal trade need to be free from corruption: Vice-Senior General

TAFF members need to inform nearby region and state governments or relevant military command head-quarters about their difficulties in time to take action against offenders under the law, said Chairman of the Illegal Trade Eradication Steering Committee State Administration Council Vice-Chairman Deputy Prime Minister Vice-Senior General Soe Win at the meeting 2/2023 of the steering committee at the Ministry of Commerce

in Nay Pyi Taw yesterday afternoon.

Speaking on the occasion, the Vice-Senior General said that illegal trade is a hindrance to micro, small and medium-sized enterprises which lose the capability to compete in the market. The commodities which were imported without tax payment hindered to products of MSMEs. If the action cannot be taken against illegally imported commodities, MSMEs will face difficulties in their development.

Seizures in February 2023 of illegally imported goods in 477 cases were valued at over K12 billion, K4.63 billion (61 cases) more than in January. Likewise, the value of seizures in February 2023 was K8.86 billion (230 cases) more than that in the same period.

The Vice-Senior General stressed the need to generally review that the larger volume and amount of seizure indicated the larger volume of illegal trade.

Hence, he noted that it is necessary to raise the momentum of the eradication of illegal trade which strongly affects the economic development of the State.

Those who are engaged in illegal trade take advantage of weak points in trade policy, orders, directives and procedures, impossibility to check all commodities from the trucks and security restrictions.

MACSS System of the Customs Department and Myanmar Tradenet 2.0 and QR Code system help ensure the smooth flow of commodities and help take action against illegal trade. System and staff must be deployed in harmony in conducting inspection tasks. If so, it will effectively eradicate

illegal trade.

The Vice-Senior General noted that an e-lock system must be applied for curbing illegal trade by using containers for the transport of commodities as much as possible. It is necessary to discuss the setting limited time for an educative period not to distribute the illegally imported goods to wholesale and retail shops as well as shopping malls and a period for taking action against the offenders.

With regard to the reviews of the Illegal Trade Eradication Steering Committee, the seizures from January 2022 to date were overloaded commodities and trafficking the commodities mixed with the goods which were not mentioned in

the import declaration. Hence, duty-assigned staff members need to carefully check the commodities with the use of experience.

It can be seen that some businesspersons relied on ethnic armed organizations in passing the checkpoints to carry their illegal trade commodities. Hence, staff members need to inform nearby regional and state governments or relevant military command headquarters about their difficulties in time to take action against offenders under the law.

The Vice-Senior General pointed out that both governments need to coordinate the eradication of illegal trade not to pass the illegal commodities to other countries and not to en-

ter illegal goods into the mother country. He also urged staff to observe good ways and means of other countries in eradicating the illegal trade.

The Vice-Senior General stressed that the duty-assigned staff members in eradicating illegal trade need to be free from corruption. Those related to the illegal trade will face action in any way. They all are to have security awareness and conscience and make preparations for security measures.

The Vice-Senior General unveiled that businesspersons will be restricted to use containers in trading, applying modern technology, negotiating with neighbouring countries and checking illegally imported commodities in the market so

as to reduce illegal trade.

Secretary of the steering committee Deputy Minister U Nyunt Aung reported on accomplishments over the minutes of the meeting 1/2023 and undertakings of the steering committee. Department officials read the letters presented to the meeting 2/2023.

Union Minister General Mya Tun Oo, U Win Shein and U Aung Naing Oo, Deputy Minister Maj-Gen Aung Lin Tun and officials discussed the eradication of illegal trade. The leader of the office staff of the steering committee reported on the draft decisions of the meeting 2/2023.

After coordinating the reports and discussions, the Vice-Senior General gave a concluding remark. — MNA/TTA

MYANMAR'S COVID-19 positive cases registered 634,078 after two new cases were reported on 29 March 2023 according to the Ministry of Health.

The total number of patients who have recovered from COVID-19 in the country reached 614,533, including 33 new recoveries.

The death toll from COVID-19 in the country remained unchanged at 19,490 on 29-3-2023 with no new death reported from the pandemic.

The country has vaccinated 30,979,183 people aged 18 and above for COVID-19 vaccines and 6,846,645 people aged under 18 till 28 March 2023. — GNLM

Courts to have jurisdiction for intellectual property matters from 1 April

THE Union Supreme Court of (USC) released a notification that courts will have jurisdiction over intellectual property matters as IP courts as the Trademark Law enacted in 2019 will come into effect from 1 April 2023

The USC conferred jurisdiction and mandate over the appeal, revision of the judgment, order and decisions for IP matters under the Trademark Law.

According to Notification 82/2023 dated 10 March of the State Administration Council, the USC released five Notifications 235/2023, 236/2023, 237/2023, 238/2023 and 239/2023 regarding the Trademark Law.

The High Court of the Yangon Region has jurisdiction over the appeal cases against the orders and decisions issued by the Intellectual Property Agency under Section 66 of the Trademark Law and the cases against the suspension orders issued by the Director-General of the Customs Department in line with the section 72 of the Trademark Law.

The courts in Self-Administered zones and district courts can exercise judicial power over the criminal cases filed under the Trademark Law. The judicial power is vested in the High Courts of the regions and states over the appeals and the revisions of the judgements, orders and decisions made by district courts and courts in the Self-Administered

Meanwhile, Kyauktada District Court has original jurisdiction over the civil cases on infringement of intellectual property rights and provisional measures under Section 77 (a) of the Trademark Law.

The High Court of the Yangon Region has jurisdiction over the appeals and the revisions of the judgements, orders and decisions in civil cases made by the IP courts, the USC notified. – TWA/EM

Octane surpasses diesel in prices



THE fuel prices dip in the domestic market tracking the slump in world oil prices. The octane exceeded diesel significantly in price.

The prices moved slightly down to K2,037 per litre of Octane 92, K2,128 for Octane 95, K2,007 for diesel and K2,081 for premium diesel on 29 March. The price stood at K2,145 for Octane 92, K2,240 for Octane 95, K2,110 for diesel and K2,190 for premium diesel on 28 March.

Diesel is commonly used in generators and agricultural machines. Consequently, demand is higher than before. As a result of this, there is difficulty in purchasing in the industrial sector. Therefore, some hike up rent for agricultural machines for unreasonable assumptions despite the decrease in diesel price.

The diesel price hit a high of K3,245 per litre in August 2022. This month, diesel price hovers at approximately K2,000 per litre. The price difference between diesel and Octane has narrowed. Earlier, diesel surpassed Octane in price.

Some businesses consume diesel as commercial power supplies were restricted to a certain extent in March. Yet, they can save some costs amid the diesel price decline.

I anticipate the diesel price to stay low like this for a long time, Ko Htaw, a truck owner told the Global New Light of Myanmar. — TWA/EM

Palm oil wholesale reference price for Yangon Region sets for two-week fall

THE wholesale reference rate of palm oil for the Yangon market continued to fall this week ending 2 April compared to that of the previous week, according to the Supervisory Committee on edible oil import and distribution.

The reference price stood at K4,570 per viss in the week from 20 to 27 March. For the week ending 2 April, the price was set lower at K4,440 per viss, showing a small decrease of K130 per viss this week.

The Supervisory Committee on edible oil import and distribution under the Ministry of Commerce has been closely observing the FOB prices in Malaysia and Indonesia including transport costs, tariffs and banking services, and issuing the wholesale market reference rate for edible oil every week.

Regardless of the reference price, the current market price is too high at over K6,000-7,000 per viss.

If those edible oil retailers and wholesalers are found overcharging, storing inventory intentionally and attempting unscrupulous action to manipulate the market, they will face legal action under the Essential

Supplies and Service Act, MoC released a statement.

The Ministry of Commerce is striving for consumers not to worry over the supply of edible oil. The ministry is also trying to secure edible oil sufficiency, supervise the market to offer reasonable prices to the consumers and maintain price stability.

At present, mobile market trucks operated by oil importing companies, in coordination with Myanmar Edible Oil Dealers' Association, were back to business in some townships on 17 July to offer palm oil at a subsidized rate. They offer palm oil at a fairer price to the consumers directly depending on the reference price. However, there are limited sources of supply although they directly sell palm oil at a reference rate depending on the volume quota. The domestic consumption of edible oil is estimated at 1 million tonnes per year. The local cooking oil production is just about 400,000 tonnes. To meet the oil sufficiency in the domestic market, about 700,000 tonnes of cooking oil are yearly imported through Malaysia and Indonesia. — NN/EM

Illegal timbers, electronics and vehicles seized

AN inspection team led by Myanmar Police Force made inspections on 27 March and captured an unregistered Kenbo 125 motorbike (approximately K300,000) in Shwebo township and the action was taken under the Export and Import Law.

On 28 March, the on-duty

Customs teams confiscated K37,231,650 worth of various electronics that were not declared in the Import Declaration (ID) at the Hteedan Port container checkpoint, two sets of Huawei power rating worth K30,049,284 that were not declared in the Import Declaration

(ID) at the Myanmar Industrial Port Terminal container checkpoint and an inspection team led by the Lashio Township Customs Department seized a total of 0.800 tonne of illegal timbers worth K3.5 million from a vehicle (approximate value of K22 million) heading to Muse from Mandalay near a toll gate on the Mandalay-Lashio-Muse Pyidaungsu highway. The action was taken under Customs procedures.

In addition, a total of 74.8972 tonnes of illegal teak and hardwood worth K28,892,556 was seized in the Mukhar forest reserve in Minhla township. The action was taken under the Forest Law.

Therefore, six arrests (estimated value of K121,973,490) were made on 27 and 28 March, according to the Illegal Trade Eradication Steering Committee.— MNA/MKKS

KAWTHOUNG District Department of Fisheries announced that fishing is to be prohibited in the Myanmar waters for three months from April to June.

During these three months, offshore fishing boats will not be allowed to go fishing. Aquatic products obtained from inshore fishing boats will be exported to neighbouring countries only if there is a surplus after domestic consumption.

During the non-fishing season, fishermen in Yangon, Ayeyawady and Taninthayi regions, Rakhine and Mon states will be allowed to use inshore fishing boats. -TWA/KZW

Three fire outbreaks happen in Yangon within one day

At 3:27 pm, a fire erupted at the Sweety Home mattress factory situated in Hlaingthaya Township. The Myanmar Fire Services Department classified the incident as a level-three emergency, and the fire was eventually extinguished by the fire brigade at 4:29 pm. — TWA/ **KZW**

Weekly market update at Bayintnaung wholesale centre


ETWEEN 23 and 29 March, the prices of palm oil, onion, garlic, mung bean and Khayan Shwewah (Hteiksa) saw prices decline while the rice prices are still on the rise at the Bayintnaung market of Yangon.

Onion

On 28 and 29 March, the market saw the entry of 570,000 visses of onion from various regions. The onion prices for small sizes are higher than the large size ones on 29 March in the Monywa onion market. On the same day, the wholesale prices of Seikphyu (Pinlay) were ranging K1,000-1,175-1,150-1,050 while Myittha onion fetched K1,550-2,000-2,100-1,900 and Monywa onion was priced at K950-1,050-1,000-800 depending on the qualities and sizes.

On 29 March, the Pakokku market saw an entry of 80,400 visses of onion and the Yawsa onion was priced at K850 per viss while K800 for Palesa and K800 for Monywa onion. There

was an entry of 87,120 visses of onion on 29 March in the Myingyan market and the price of summer onion was between K500 and K1,000.

On 29 March, the wholesale prices of potatoes in the Yangon market moved in the range between K1,300 and 1,850 per viss depending on producing areas. The potato from Bhamo and Banbwe was priced at K1,800 per viss.

Chilli pepper

On 29 March, the wholesale prices of chilli peppers were K11,000/10,500 per viss for Panye and Myarni long chilli pepper, K11,500/12,000 per viss for Moehtaung, K12,000/12,500 per viss for Sinphyukyun and K13,500/14,000 per viss for Viet Nam chilli pepper.

Rice

On 29 March, the prices stood at K5,500 per bag for summer rice grown under the intercropping system in the Yangon market while K58,000/61,000 per bag for summer rice (90 days), K65,000/67,000 per bag for monsoon rice (90days) and K65,000 per bag for new Pawsan rice. It was K71,000 for Pawsan rice from Bogale, K74,000 from Myaungmya and K90,000 from Shwebo.

Palm Oil

Between 28 and 2 April, the reference wholesale prices of palm oil in Yangon is K4,400 per viss and it drops about K130 per viss to the previous week.

There may be the entry of about K30,000 tonnes of palm oil before the long Thingyan holidays. The CIF price was only \$1,008 per tonne. On 29 March, the price was K6,530 per viss in the Yangon market.

Export licences granted to traders via Tradenet 2.0 system from 1 April

EXPORT licences can be done through Myanmar Tradenet 2.0 portal starting from 1 April, Trade Department stated.

In order to facilitate the export/import licencing process and conduct exports/imports systematically, traders are allowed to export the goods only after seeking an export licence via Myanmar Tradenet 2.0 platform.

Having digitized the licencing system, licencing for certain lines that do not need to apply for export licence will be automatically passed on the system.

According to 2022 Myanmar Customs, commodities lines with 10-digit HS Code are available to be apply for an export licence on Myanmar Tradenet 2.0 from 1 April, according to Notification 6/2023 released on 22 March.

The department apprised the importers of the rules and regulations for imports that need import licences as per Export/ Import Notification 7/2023 dated 22 March.

Earlier, the Trade Depart-

ment under the Ministry of Commerce released Notification 50/2020 stating that all import items except goods stored in

customs warehouse that need import licences were not allowed to arrive at the Port before the port arrival processing permit

in order to comply with the customs regulation stipulated in Notification 68/2019 of the Ministry Planning and Finance.

Additionally, importers were notified to face legal actions under the Export and Import Law if early arrival of the goods without import licence or permit of the departments concerned was found, as per Notification 6/2022.

Import licence, therefore, is required for all items including goods to be stored at the Customs warehouse before arrival to steer trading activities, and maintain the quality of the goods due to failure to claim the goods from the Customs-bonded warehouse for a long period.

Thus, the Trade Department stated that Notification 50/2020 will cease to be in effect for six months from 1 April 2023 and suspension might extend if necessary. - NN/EM

HONG Kong SAR, the second largest investor in Myanmar, pumped in US\$166.6 million from 12 permitted enterprises and existing enterprises as of February-end in the current financial year 2022-2023 beginning April, according to the Directorate of Investment and Company Administration (DICA).

Hong Kong puts investment into real estate development, electricity, and garment busi-

Singapore is the top source of foreign direct investments in Myanmar in the past 11 months, bringing in \$1.15 billion under 15 projects, including capital expansion by existing enterprises.

China stood as the third-largest investor this FY with an estimated capital of \$113.49 million from 37 permitted enterprises and the existing enterprises.

Those enterprises listed from the Republic of Korea, Chinese Taipei, Belize, Japan, Thailand and the UK also put investments into Myanmar this FY. The existing enterprises from Bangladesh, Japan, Seychelles,

MIC stated priority sectors for investments, including manufacturing of fertilizer, cement, iron and steel, value-added foodstuff, electric vehicle and pharmaceutical and medical supplies, agriculture and livestock farming and related industries, public transportation services and electric vehicles and related businesses.

The economic interaction between Myanmar and Hong Kong SAR has been increasing rapidly. Hong Kong emerged as the fourth largest investor in Myanmar after Singapore, China and Thailand. Between FY2016-2017 and February 2023, 289 enterprises from Hong Kong brought in an FDI of over \$10 billion into Myanmar, according to official data on permitted enterprises released by the DICA. — KK

Better pay and better job prospects were the deciding factors for Maillot -- a relief for ArcelorMittal, where the group's Germany chief Reiner Blaschek acknowledged that attracting young trainees like the 23-yearold is becoming "increasingly

A shortage of skilled workers has become a major headache for businesses in Europe's largest economy, as vast cohorts of older employees go into re-

Chancellor Olaf Scholz's government is battling to find an answer to the challenge of Germany's rapidly ageing population.

Just under two million job posts were unfilled at the end of 2022 in Germany, according to the federal Institute for Employment Research (IAB).

Making the most out of the workers already in Germany would "not be enough" to fill

the gap, Scholz told parliament earlier this month.

"We will also attract urgently needed workers by opening up legal migration channels," he

Job seekers from the European Union, like Maillot, can already work in Germany with no additional visa hurdles, but even that pool of human resource is insufficient. On Wednesday, Scholz's cabinet signed off a new draft bill aimed at easing immigration rules to attract more workers from further afield to the country. — AFP

Biden kicks off campaign touting US economy

PRESIDENT Joe Biden launched a new drive Tuesday to promote a major theme of his expected reelection campaign, touting what he said was a resurgence of US manufacturing — and warning Republicans could tank the economy.

"I've been determined to make things in this country again, to build American manufacturing capacity," Biden said at Wolfspeed, a semiconductor manufacturing plant in Durham, North Carolina, that recently announced a \$5 billion expansion.

Ramping up US capacity in a global race to produce the tiny, high-tech components at the heart of most modern

technology has been a Biden priority since he took office in 2021.

His trip to the factory kicked off what the White House is calling a three-week "Investing in America" tour where top officials will visit some 20 states to tout newly created manufacturing jobs in the semiconductor industry and in a variety of other sectors boosted by massive government incentives.

According to the White House, more than \$435 billion in new investments has been announced under Biden, about half of that in clean energy and electric vehicle companies, and the other half in semiconductors. - AFP

Billion-dollar facelift as Bahrain bids to join Gulf boom

WITH a multi-billion dollar economic revamp in full swing, tiny Bahrain is vying to keep pace with its Gulf neighbours after more than a decade beset by political

It's a difficult path for the island nation that is a neighbour to gas-rich Qatar and connected by a causeway to Saudi Arabia, a key ally and the world's biggest oil exporter.

The United Arab Emirates, another regional powerhouse with well-developed trade, tourism and financial industries alongside its large oil sector, is just a short flight away.

Bahrain has witnessed turbulence since the crushing of an uprising in 2011 but has since begun a modernizing facelift,

NEC reveals 90% accurate landmine-predicting AI technology

NEC Corp on Wednesday said it has developed artificial intelligence technology that is capable to predicting where landmines are most likely buried with about 90 per cent accuracy.

The technology could lead to more efficient removal of landmines and reduce the number of yearly deaths from the underground explosives, and the Japanese company said it aims to provide AI landmine prediction services to governments and international organizations by March 2024.

In an experiment conducted between April and October last year in conflict zones around Asia, NEC used open data on landscapes and military facilities provided by the International Committee of the Red Cross as well as reports from local residents in successfully predicting where landmines in

certain zones were buried, NEC

Using the technology, the time needed in narrowing 800 sites down to probable landmine burial sites can be shortened to a few hours from several years.

Although it is still necessary to manually confirm the landmine burial zones, the company said the technology is hoped to hasten the removal process. -

Hong Kong art market hits prepandemic highs despite curbs

AS thousands of visitors streamed through a Hong Kong exhibition hall and deals were struck for works by Picasso and Yayoi Kusama, art collectors celebrated the Asian financial hub's return to its

bustling heyday.

The scenes at Hong Kong's Art Basel fair last week had not been seen since 2019, with a crackdown on pro-democracy protests and pandemic restrictions in the intervening years radically transforming the city.

More than 86,000 visitors poured through the halls of the fair, reflecting a return to pre-pandemic numbers, with reported sales of more than \$98 million, double those of 2019, according to organizers. Among the biggest deals were a 1964 Picasso sold for \$5.5 million, as well as works by Japanese artist Kazuo Shiraga (\$5 million) and a strikingly surreal "pumpkin" by Kusama (\$3.5 million), according to reported sales figures released by the fair.

The energy at Art Basel reflected the increasing importance of the Asian art market, said organizers, who told AFP that their work was not impacted by the city's national security law. — AFP

Japan PM: No plans to dissolve lower house despite backlash

JAPANESE Prime Minister Fumio Kishida on Wednesday said he has no plans in the near future to dissolve the lower house of parliament and call a snap election.

"I'm not considering now dissolving the lower house for a snap election," Kishida told a parliamentary committee meeting.

Kishida said his priorities are dealing with important matters and making sure decisions made by the government are accountable.

His remarks were in response to a question by an opposition party member about dissolving the lower chamber of Japan's bicameral party.

Kishida's ruling Liberal Democratic Party-led coalition control both the more powerful lower and upper chamber.

Japan's prime minister also said in response to the question that there were urgent tasks that needed to be attended to including policies to support children and child-rearing amid the country's drastically low birthrate, as well as issues related to changing energy policies.

In addition, Kishida also said that bolstering Japan's defense capabilities was a pressing matter that also took precedence over the possibility of calling a snap election. — Xinhua

Five years after cannabis was legalized in California, black market transactions like this one — where no one pays any taxes, and the product is not regulated — remain commonplace.

"Legal shops are too expensive," the 27-year-old tells AFP, as he lights up his preroll.

Over the course of a year Buddakey estimates he saves the equivalent of a paycheck from his patient transport job

by avoiding the state-sanc-

"I'd rather pay less for the same thing. And I know it's the same thing, because it gives me the same feeling."

Buddakey's working-class neighbourhood in east Los Angeles is teeming with stores like this one, many marked by a green cross.

Although they are illegal, they openly advertise online, and many have their own web-

Inside one of them, a man who gives his name only as "Joe" welcomes a steady

Car battery recycling market gears up for future boom

RESEARCHER Anna Vanderbruggen peers into a vat of dark bubbling liquid, the result of a process she has developed to recover graphite from old lithium-ion batteries.

Although graphite represents up to a quarter of the weight of the batteries, no one has yet come up with a viable plan to recycle it, according to Vanderbruggen.

The 29-year-old researcher is still fine-tuning her method but

has already received an award from the European Institute of Innovation and Technology (EIT) for her efforts.

As Europe shifts gear from fossil fuel vehicles to electrified cars, recycling graphite as well as other elements in batteries is gradually becoming a major focus. All the more so as the continent seeks to wean itself off its reliance on countries like China for raw materials.

"Battery manufacturers

were not interested" in recycled graphite up to now because "they could get it at low cost in China", Vanderbruggen told AFP.

Her method, developed at the Helmholtz Research Institute in Freiberg, Germany, involves extracting graphite from "black mass", a powder that also contains cobalt, nickel, lithium and manganese. "You put the black mass in water and add some chemicals and air bubbles, like in a jacuzzi," Vanderbruggen, who is from France, said. "The graphite attaches itself to the bubbles, whereas the metals are hydrophilic and therefore remain in the water."

Vanderbruggen also works as a consultant for businesses exploring the opportunities that recycling electric car batteries could bring in the future.

Rising costs

Increasing raw material costs and shortages have led to a surge of interest in the field.

The price of lithium has increased by 13 per cent over the past five years, according to Philippe Barboux, a professor of chemistry at PSL University in Paris.—AFP

Europe rights court hears climate cases against governments

THE European Court of Human Rights will hear cases against France and Switzerland over alleged failings to protect the environment Wednesday, the first time governments are in the court's dock for alleged climate change inaction.

The case against Switzerland is based on a complaint by an association of elderly people — who call themselves the "Club of Climate Seniors" — concerned with the consequences of global warming on their living conditions and health, the ECHR said.

They accuse the Swiss authorities of various climate change failings which they say amount to a violation of the government's obligation to protect life and citizens' homes and families.

"This is a historic event," said Anne Mahrer, 64, a member of the Swiss club, backed by Greenpeace Switzerland, where the average age is 73.

Around 50 of its 2,000 members will travel to Strasbourg for the hearing, Mahrer told AFP. All reports on global warming over the past 20 years show that "everybody is affected", but the elderly more than others, especially older women because of cardiovascular and respiratory risks, she said.—AFP

T-Rex skeleton on show in Zurich before auction


YOLANDA Schicker-Siber gingerly fastens a pointy claw bone with a thin metal wire, putting the finishing touches on a giant Tyrannosaurus-Rex skeleton before a rare auction in Switzerland next month.

The Aathal Dinosaur Museum's curator was on Tuesday helping complete perhaps the world's biggest construction kit-reassembling a 67-million-year-old T-Rex dubbed Trinity.

Trinity was sent to Zurich from Arizona in the United States in nine giant crates.

The 3.9-metre (12.8-foot) skeleton has been mounted on a red carpet and under crystal chandeliers in a Zurich concert hall, where it will be on public display before going under the hammer on 18 April.

The Koller auction house has estimated it will fetch between six to eight million Swiss francs (\$6.5-8.7 million). But Christian Link, in charge of natural history memorabilia at Koller, said he believed that was a "pretty low" estimate.—AFP

Race against time to save dozens missing after Ecuador mudslide

RESCUERS raced against time in southern Ecuador on Tuesday to find survivors of a weekend landslide that left at least 11 people dead and more than 60 missing.

Torrential rain overnight Sunday triggered a mudslide that buried dozens of homes and injured 30 people in the village of Alausi some 300 kilometres (180 miles) south of the capital Quito, officials said.

As hopes faded of finding survivors under the rubble, rescuers with dogs and neighbours alike worked feverishly at removing debris, some with their bare hands.

"My daughter is here, my granddaughter, my whole family," Carlos Maquero told AFP among the ruins, desperate for a breakthrough.

"I want you to understand the pain we're going through," the 40-year-old merchant said.

The same region was hit by an earthquake just over a week earlier in which 15 people were killed.

There is a "buildup of tonnes and tonnes of earth," making it difficult to find survivors, Fernando Yanza, a firefighter working to rescue those trapped, told AFP.

Robotic exoskeletons expand options for paraplegic patients

LIN Han, 34, put the robot exoskeleton on a stool and eased himself into it, securing his feet, legs and waist with straps. Grasping the special crutches and pressing the buttons on them, he was slowly raised into a standing position.

He is one of several people in China making use of modern robot technology to give them mobility — and a new lease on life — following serious illness or injury.

Lin has suffered from paraplegia for nearly a decade, after he fell from the fourth floor at work, seriously injuring his spine and losing all sensation below the navel. The accident brought him tremendous pain, both physically and mentally, until he was introduced to a wearable robotic exoskeleton.

Once he has the exoskeleton on, with a click of a button, he can stand up, walk and even take a stroll around the neighborhood.

"In addition to providing walking assistance, it's also

very helpful in rehabilitation training," said Lin, adding that he now takes an hour-long walk every morning and afternoon, which helps prevent muscle atrophy. "My whole body is getting stronger," he said.

Research and development

(R&D) on the robotic exoskeleton began in 2010 at the University of Electronic Science and Technology of China. In August 2015, the team brought the robotic suits to a rehabilitation center in Chengdu, capital of southwest China's Sichuan Province, looking for volunteers to try them out. Lin, who was receiving treatment there, was reluctant to give it a try. The team offered meticulous instructions to help him get used to the fancy new suits. He worked hard and gradually gained confidence in using the apparatus safely.

Lin says the exoskeleton has enabled him to wave goodbye to the old days, in which he faced a range of problems including urinary incontinence.

In November 2020, Lin tied the knot. Now he is the happy father of two children. "We continue to improve and make breakthroughs in human-computer interaction, materials and artificial intelligence algorithms, so that disabled people can use exoskeleton robots more comfortably," said Cheng Hong, head of the R&D team. — Xinhua

Italy government seeks to ban synthetic meat

THE Italian government on Tuesday introduced legislation to ban the production and sale of synthetic foods, including artificial meat.

The new parliamentary bill "is based on the precautionary principle because today there is no scientific evidence of possible harmful effects linked to the consumption of synthetic foods", said Health Minister

Orazio Schillaci, at a press conference following a cabinet meeting that gave the green light to the initiative. Fake meat has long been produced, with varying degrees of success, from vegetable sources like soya, peas or beans.

But the new legislation targets synthetic products being developed in laboratories from animal cells, without killing the

donor animal

If the ban is approved by parliament, penalties for violators would include fines of up to 60,000 euros (\$64,000).

Italy's agricultural association Coldiretti organized a flash mob near the seat of government in central Rome on Tuesday afternoon, with the message "no to synthetic food".

"Italy, which is a European leader in food quality and safety, has a duty to be at the forefront of food policies to defend citizens and businesses," Coldiretti president Ettore Prandini said in a statement.

In order to come into force, the bill will have to be adopted within two months by parliament, which will have the possibility to amend it during debates.

Currently no marketing applications for such foods have been made in the EU, and it is likely to be at least 2025 before such foods appear on shelves in Europe. — AFP

Over 10 % of Japanese children with COVIDrelated brain disease pass away: survey

MORE than 10 per cent of Japanese youngsters who acquired acute brain syndrome after contracting COVID-19 have passed away, according to the findings of a recent national survey released by a study team from the health ministry.

Between January 2020 and May 2022, the survey discovered 34 cases of acute encephalopathy linked to COVID-19 infection in individuals under the age of 18.

The team looked at 31 patients who had no underlying conditions that might have contributed to the brain damage.

Of the 31 children, 19 made a full recovery, but four of them did not, and problems were identified in eight more. Of the eight, five were said

to be suffering from severe side effects, including being bedridden and unconscious.

Seizures, which roughly half of the patients had, diminished consciousness, and altered speech or behaviour were the main initial symptoms, according to the survey.

When the Omicron coronavirus strain became common in January 2022 or later, the majority of individuals experienced acute encephalopathy.

The ratio of children with COVID infection who experienced brain symptoms before and after 2022, however, showed no appreciable difference, suggesting that Omicron may not necessarily be making the brain disease more likely to manifest, the study showed. — Xinhua

WHO says medium-risk adults don't need extra Covid jabs

The WHO is looking for new Covid vaccines that cover a broad spectrum of variants, have longer durability and better performance against infection and transmission.

THE World Health Organization said Tuesday it is no longer recommending additional Covid-19 vaccine booster doses for regular, medium-risk adults as the benefit was marginal.

received their primary vaccination course and one booster dose, there is no risk in having further jabs but the returns are slight, the WHO's vaccine experts said.

The UN health agency's Strategic Advisory Group of Experts on Immunisation (SAGE) issued

updated recommendations after its regular biannual meeting.

SAGE's new advice reflects the impact of the dominant Omicron variant of the virus and high-level immunity now achieved For such people who have in the population through infection and vaccination, the WHO said.

Three new, simplified priority

SAGE came up with three new, simplified priority categories for Covid vaccination: high, medium and low, based on risk of



severe disease or death

SAGE recommended additional booster shots after the first one only for people at the highest risk of developing severe Covid-19

They include older adults; younger adults with comorbidities such as diabetes, people with immunocompromising conditions like HIV, pregnant women, and frontline health workers.

The medium priority group includes healthy adults, usually under 60, and children and adolescents with comorbidities.

SAGE recomends a primary series and a first booster dose.

"When it comes to the medium-risk group, additional booster doses... are no longer recommended," said SAGE chair Hanna

"The vaccine is safe and it's efficient against serious disease and death," she said, but for this risk group, while there was no harm in having another shot, "the benefit of these additional boosters is actually quite marginal".

Countries phasing out internal combustion engines

THE European Union approved on Monday a deal that will lead to the phaseout of sales of new fossil fuel cars by 2035, with a final green light by energy ministers due on Tuesday. The 27-nation bloc joins more than a dozen other nations which have set deadlines for ending sales of new cars with internal combustion engines (ICE) which emit toxic gasses that are a major driver of climate change.

Norway is the trailblazer in ending the reign of ICE vehicles, with only zero-emission new vehicles -- either battery electric or hydrogen -- to be sold from 2025.

Britain, Israel and Singapore plan to ban the sale of new vehicles with internal combustion engines in 2030. In Britain, the measure is part of an effort to create a "green industrial revolution" that aims to create thousands of jobs. China has taken a lead in the manufacturing of battery electric vehicles, with hundreds of companies making cars and generous public subsidies available. Chinese firms also dominate the production of the raw materials used in electric batteries and their manufacture.

The world's top polluter with the world's largest auto market, China has set waypoints towards

eliminating new fossil fuel cars. It aims for battery electric, hybrid and fuel cell vehicles to account for 20 per cent of sales in 2025. It aims for them to account for a majority by 2035. According to President Joe Biden's climate plan, half of new cars sold in the United States should be zero-emissions in 2030. Large subsidies are being used to protect local manufacturers and attract battery production. Plug-in hybrids are included in that goal, however. While these vehicles have fossil fuel motors, they can run several dozen kilometres on their batteries.—AFP

Pirates boarded Danish ship in Gulf of Guinea

PIRATES boarded a Danish-owned Liberian-flagged oil tanker in the Gulf of Guinea over the weekend, the owner said Tuesday, adding that contact with the 16 crew members had been lost.

The 135-metre-long Monjasa Reformer "experienced an emergency situation" on Saturday around 160 miles (260 kilometres) west of Port Pointe-Noire in the Republic of Congo, owner Monjasa said.

The shipowner added that the crew had sought refuge in the tanker's secure room or "citadel" when the pirates boarded, "in accordance with the onboard anti-piracy emergency protocol". "Onboard communications channels are currently down and we are working with the local authorities to establish communication to understand the situation on board and provide all the support needed by

the crew to overcome these dreadful events," Monjasa said.

It said "the vessel was sitting idle" when the incident took place. Monjasa declined to give information on the nationalities of the crew members when asked by AFP.

According to an official at the port of Pointe-Noire, the ship had arrived in Congolese waters on 18 March and left on 22 March, and was in international waters when it was attacked.

"Three men took control of the ship and since then the crew can no longer be reached," the official told AFP.

Sotheby's said last month that more than 300 items owned by the movie star and car racer Newman and his wife of 50 years Joanne Woodward would go under the hammer on 9 June.

On Tuesday the auction house unveiled the two Rolex Daytonas, classic and coveted watches that celebrate the model's 60th anniversary this year, and which Sotheby's said Newman wore during his celebrated racing career.

The 'Zenith' Daytona Rolex was presented to Newman in 1995 to mark his victory in Florida's 24 hours of Daytona Race

Regional economic integration advancing in Asia: report

REGIONAL economic integration has been advancing in Asia, according to a report released by the Boao Forum for Asia (BFA) on Tuesday.

The BFA Asian Economic Outlook and Integration Progress Annual Report 2023 states that in 2021, global dependence on Asian trade in goods remained stable, and the trade dependence between Asian economies remained at a relatively high level. The status of ASE-AN and China as hubs for trade in goods remained unchanged.

Most major Asian economies have increased their dependence on Asian factories over the past decade, according to the report. "Asia has a significant advantage of producing competitive products in global value chains. Of the top 22 intermediate

products from Asian factories in terms of export value, 21 have shown significant growth in exports, with electronic component products such as integrated circuits growing the fastest, at a growth rate of up to 28.8 per cent in 2021," the report said.—Xinhua

Room for one more? Saudi moves in on Gulf aviation market

UNDETERRED by a crowded Gulf market, Saudi Arabia is going all in on an aggressive aviation expansion, with a massive jet order and the launch of a new national carrier.

The project aligns with a bid to remake the

once closed-off kingdom as a business and tourism magnet, but analysts say that even with official backing, its path to success is complicated.

This month Crown Prince Mohammed bin Salman, Saudi Arabia's de facto ruler, unveiled Riyadh Air, the new airline which is intended to transform the capital into "a gateway to the world", according to state media. Two days later, officials said Riyadh Air and Saudia, the kingdom's existing flag-carrier based in Jeddah, would purchase 78 Boeing 787 Dreamliner jets. The deal, which the White House valued at "nearly \$37 billion" with options for up to 121 planes, constitutes the fifth largest by commercial value in Boeing's history. Riyadh

Air's chief executive, Tony Douglas, told AFP that the airline would serve the international, regional and domestic markets -- putting it in direct competition with Gulf heavyweights Emirates and Qatar Airways. That raises hard

questions about how Riyadh Air will grab market share, especially at a time when long-haul non-stop flights that avoid the Middle East altogether are on the rise, said independent aviation analyst Alex Macheras.—AFP

US, Japan strike deal on boosting supplies of EV battery minerals

THE United States and Japan said Tuesday that the two countries have reached an agreement on reinforcing supply chains of minerals vital in producing electric vehicle batteries.

The agreement will

allow Japanese companies to receive EV tax breaks if critical minerals from the United States or countries with which it has free trade agreements are used in the cars' batteries, the two governments said. The deal is part of a larger effort by the administration of US President Joe Biden to strengthen its economic security by diversifying procurement sources of important materials among allies and like-minded countries, as

well as to counter China's growing influence in high-tech sectors. The accord means that Japan will be treated as equivalent to an FTA partner in relation to the five minerals, including cobalt, lithium and nickel. —Kyodo

8,000 steps once or twice a week cuts mortality risk: study

WALKING 8,000 steps — about four miles (6.4 kilometres) — one or two days a week may significantly reduce the risk of an early death, according to a study released on Tuesday.

While regular exercise is known to lower mortality risk, the study published in the journal JAMA Network Open looked at the health benefits of walking intensively

only a few days a week.

For the study, the researchers from Kyoto University and the University of California, Los Angeles analyzed data from 3,100 American adults.

They found that those who walked 8,000 steps or more one or two days a week were 14.9 per cent less likely to die over a 10-year period than those who never reached that mark.—AFP

Sri Lanka to reduce fuel prices as economic conditions improve

SRI Lanka's Power and Energy Minister Kanchana Wijesekera said on Wednesday that fuel prices will be reduced in the country from 29 March at midnight.

The price of 92 Octane petrol will be reduced by 60 rupees (0.18 US dollar) to 340 rupees per litre, and that of 95 Octane petrol will fall by 135 rupees to 375 rupees per litre.

The price of diesel will be reduced by 80 rupees to 325 rupees per litre and that of super diesel will be reduced by 45 rupees to 465 rupees.

Meanwhile, the price of kerosine will be reduced by 10 rupees to 295 rupees.

Wijesekera said last week that the Sri Lankan government would reduce fuel prices as a result of falling international oil

prices and the crisis-ridden country now having the ability to get competitive prices from suppliers due to the International Monetary Fund loan approval.

The minister also said the Sri Lankan rupee is appreciating against the US dollar.

According to the minister, President Ranil

Wickremesinghe had advised him to reduce fuel prices following the IMF bailout package and the stabilization of the economy.

Sri Lanka increased fuel prices by over 200 percent in 2022 amid an economic crisis in the South Asian country. (1 US dollar equals about 324.5 Sri Lankan rupees).— Xinhua

Senegal's gold rush brings hope and despair

MOHAMED Bayoh climbed into the deep, pitch-black hole, hoping to emerge with a nugget that would change his life.

The 26-year-old Guinean is one of thousands of West Africans who have flocked to remote eastern Senegal in search of gold.

The rush for the precious metal has dramatically transformed Bantakokouta, a town on the borders of Mali and Guinea.

The locals numbered just a few dozen two decades ago, now there are several thousand on the back of a floating population of dream-seekers and risk-takers with gold in their eyes.

Over time, their antlike labour has left the landscape looking like a Swiss cheese.

As far as the eye can see, through the pervasive dusty mist, small huddled groups protected from the sun by makeshift branch shelters haul up spoil scratched from the ground.

Women sit nearby, sorting the rocks into two

mounds—a big one for the discards and a much smaller one for the promising samples.

The same scenes are played out every day, with no guarantee of any success.

"Working here is like playing the lottery, you are never sure of winning," sighed Bayoh, who said he was nonetheless determined to stay put until he gets rich.

Other sites in the goldrich region have been taken over by mining corporations, sometimes triggering land disputes with local people. But in Bantakokouta, informal mining has been allowed to carry on.

Diggers stay typically stay for a few months — sometimes just days — to chance their arm, hoping for a lucky strike that will enable them to send money home or start a business.

Bayoh was clear in his objective: to "find a lot of gold," he said.

Credit Suisse ex-chairman says owes nothing after debacle

THE former chairman of Credit Suisse says he never received any bonus and owes nothing following the scandal-plagued bank's emergency sale to UBS, a Swiss newspaper reported Tuesday.

Urs Rohner's decade-long tenure was mired in a series of controversies, including the bank's exposure to the collapses of investment firms Archegos and Greensill in the last year of his chairmanship in 2021. Already roiled by past scandals, Credit Suisse shares sank earlier this month over concerns of contagion from the failures of three US regional banks, leading to its government-engineered buyout by Swiss rival UBS.

Pressures is growing

for Credit Suisse bosses to be held to account and return their bonuses in light of the bank's failings.

Rohner's spokesman told the CH Media newspaper group that the former chairman received his payments regardless of the bank's results.

"As chairman of the board, he did not get a bonus, which is why there is nothing to reimburse," the spokesman said.

Rohner voluntarily turned down a total of five million Swiss francs (\$5.5 million) that he was owed as part of his pay package between 2014 and 2021, the spokesman added.

CH Media reported that Rohner was paid around 52 million francs during his tenure.—AFP

Russia launches large-scale commandand-staff exercise

RUSSIA'S Strategic Missile Forces have launched a large-scale command-and-staff exercise that will involve the Yars intercontinental ballistic missile system, the Russian Defence Ministry said on Wednesday.

"The exercise will involve over 3,000 servicemen and about 300 pieces of military hardware. A commission of the Strategic Missile Forces' command will assess cohesion among the personnel fulfilling their tasks," the ministry said in a statement.

The Omsk Missile Formation and the Novosibirsk Missile Formation, equipped with Yars

mobile launchers, will participate in the exercise, said the statement.

The servicemen of the Strategic Missile Forces would carry out a complex of measures to train concealment and counter-measures against modern aerial survey systems, it added.

The RS-24 Yars, a modification of the Topol-M missile, is Russia's strategic missile system armed with a solid-propellant intercontinental ballistic missile. It reportedly has an operational range of up to 12,000 kilometres and can carry multiple nuclear warheads. — Xinhua

The flying hospital bringing Ukraine's wounded west

YOU can see the pain held just in check in the faces of Ukraine's war wounded as they are evacuated in a flying hospital.

"It's the first time I've taken a plane," says 22-year-old Mykola Fedirko, who was hit by a shell holding off Russian troops in a trench in the Donetsk region. "I would have loved to be going to Denmark for a holiday and not to hospital because of my wound," says the 22-year-old salesman-turned-soldier, whose lower leg is held in place by metal pins. —AFP

UK's Guardian apologizes for founders' slavery links

THE owner of British newspaper The Guardian apologised Tuesday for the role of its founders in transatlantic slavery and announced a "decade-long programme of restorative justice", following an independent investigation. The more than two-year "academic review" into the newspaper's early 19th century creation discovered its main founder John Edward Taylor and many of his financial backers had links to slavery, the paper said.—AFP

US aircraft carrier enters S Korea port amid N Korean posturing

A US nuclear-powered aircraft carrier arrived at a port in the South Korean city of Busan on Tuesday, as tensions ratchet up with North Korea following a series of missile tests and other provocations. The warship's arrival came a day after North Korea fired two ballistic missiles in an apparent response to US-South Korea joint military exercises and, according to the North's state media, leader Kim Jong Un inspected work related to the country's nuclear weapons programme.

It is the first time since September last year that a US nuclear carrier entered a South Korean port.

The US Navy's Nimitz docked after its strike group

participated in a training exercise with the South Korean navy in open waters near South Korea's southern island of Jeju on Monday.

It also conducted a drill with the Japanese Maritime Self-Defence Force in the Pacific Ocean and the East China Sea for four days through Sunday.—Kyodo

Rights groups warn over UK plan to move Afghan refugees from hotels

BRITAIN on Tuesday announced it would move around 8,000 Afghan refugees out of temporary hotel accommodation and into permanent homes, but rights groups warned it could cause them "misery and anxiety".

The UK has welcomed around 24,500 Afghans under resettlement and relocation

schemes introduced as the Taliban took over their country in 2021. Around 8,000 of those, half of them children, remain in temporary hotel accommodation.

Veterans' affairs minister Johnny Mercer on Tuesday told MPs that it was an "unsustainable situation" that "needs to change. "Bridging hotels were not and were never designed to be a permanent solution... we have a duty to end this practice," he said

Mercer added the government wants to "step up our support" to help resettled and relocated Afghans access "independent settled accommodation".—AFP

Morocco treads fine line between courting Israel, Palestinians

MOROCCO is struggling to balance its alliance with Israel with support for the domestically popular Palestinian cause, an increasingly complex challenge with Israel ruled by its most right-wing government ever.

The North African country normalised its ties with Israel in December 2020, part of a series of deals known as the Abraham Accords, backed by the administration of then-US President Donald Trump.

In exchange, Rabat won a key concession from Washington: recognition of its sovereignty over the disputed Western Sahara, where the Polisario movement seeks independence.

But the move was at odds with a strongly pro-Palestinian public mood in Morocco.

That square has been hard-

er to circle in recent months as violence has surged in the Israel-Palestinian conflict, with the army carrying out deadly raids in the occupied West Bank.

But Rabat has been quick to defend itself.

A case in point is the royal palace's reaction after the opposition Islamist Justice and Development Party (PJD) "deplored" the Foreign Minister Nasser Bourita for allegedly defending Israel publicly, even as it commits "criminal aggression against our Palestinian brothers". King Mohammed VI's office hit back, accusing the PJD of voicing "irresponsible excesses and dangerous approximations regarding relations" between Morocco and Israel.

"Morocco's position towards the Palestinian question is irreversible," it said, adding that Rabat's foreign relations are the prerogative of the monarch.—

Peru prosecutors probe president over alleged money laundering

PERUVIAN prosecutors said late Tuesday they were investigating President Dina Boluarte and her ousted predecessor Pedro Castillo for alleged money laundering and illegal campaign financing during the 2021 presidential election.

The probe is an expansion of an investigation against the pair over allegations of illegal financing.

Boluarte, Castillo and his former adviser Henry Shimabukuro were being investigated for "the crimes of prohibited financing of political organizations, money laundering and criminal organization", the public prosecutor's office said on Twitter.

"The alleged commission of these crimes would have occurred during the electoral campaign of (the left-wing party) Free Peru in 2021," when Castillo was running for the presidency and Boluarte for the vice-presidency, it said.

The prosecutor in the case,

Richard Rojas, made the decision after Shimabukuro declared he had evidence Boluarte was aware of alleged irregularities in the collection of campaign funds.

Peru has been embroiled in a political crisis since Castillo was ousted and arrested on 7 December charged with rebellion for trying to dissolve congress and rule by decree. Boluarte took over as president but has faced calls to resign by protesters also demanding fresh elections.

The prosecutors' announcement comes shortly before congress, controlled by the right but now an ally of Boluarte, will debate on Thursday the admission of a motion to remove the president.—AFP

At least 38 migrants dead in Mexico detention centre fire

A fire believed to have been started by migrants protesting against their deportation killed at least 38 people at a Mexican immigration detention centre near the US border, authorities said Tuesday, prompting demands for justice.

The blaze broke out late Monday at the National Migration Institute (INM) facility in Ciudad Juarez, prompting the mobilization of firefighters and dozens of ambulances.

The migrants were believed to have lit the fire as a demonstration because they feared they would be deported, President Andres Manuel Lopez Obrador said.

"They put mats at the door of the shelter and set them on fire as a protest, and did not imagine that it would cause this terrible tragedy," he told reporters.

United Nations High Commissioner for Refugees Filippo Grandi expressed solidarity with relatives of the victims and appealed to countries in the region "to deal in a humane, just, effective manner with growing population flows through the Americas."—AFP

Germany prepares pomp for Charles III's first foreign trip

BRITAIN'S Charles III will arrive in Germany on Wednesday for his first state visit as king, after a planned trip to France was postponed in the face of political protests.

British Union Jack flags have been raised along Berlin's central Unter den Linden avenue, which leads to the Brandenburg Gate, in anticipation of the monarch's arrival.

German President Frank-Walter Steinmeier and German first lady Elke Buedenbender will welcome Charles and Queen Consort Camilla with military honours at the famous landmark, the first time it has provided a backdrop for receiving a state guest.— AFP

Pence ordered to testify against Trump in insurrection probe

A US judge has ordered former vice-president Mike Pence to testify about his conversations with Donald Trump leading up to the 2021 assault on the Capitol, multiple media outlets reported on Tuesday.

Washington's Chief Judge James Boasberg reportedly ruled that Pence should have to provide answers to a federal grand jury on any questions probing potential criminality by the then-president.

But Pence can decline to discuss his actions on the day of the insurrection itself, when he was serving as president of the Senate for the certification of the election, the reports said.—AFP

Early Spain setback for coach De la Fuente 'no accident'

suffered an early setback in a chastening defeat by Scotland in Glasgow on Tuesday in Euro 2024 qualifying.

After a solid win over a Norway side without in-form striker Erling Haaland on Saturday in their first qualifier, Scott McTominay's brace secured a shock 2-0 home win over La Roja at Hampden Park. De la Fuente - a relative unknown who has never managed in La Liga — was promoted to the job after Luis Enrique departed in December following Spain's disappointing 2022 World Cup campaign. Spain put in a disjointed, wayward performance after falling behind early on, suffering their first defeat against

NEW Spain coach Luis de la Fuente's project Scotland since 1984 and first loss in a Euro qualifier since 2014. De la Fuente made eight changes from the side which beat Norway, retaining only goalkeeper Kepa Arrizabalaga and midfield pivots Rodri and Mikel Merino. The coach wanted to explore his options in only his second match in charge but tinkered too much. Spain's five substitutions didn't help improve the performance, which worsened as the night went on, with the side lacking leadership. One of De la Fuente's early decisions was not to rely on Paris Saint-Germain defender Sergio Ramos, 36, who retired from international duty after the coach phoned him to explain the situation. - AFP
